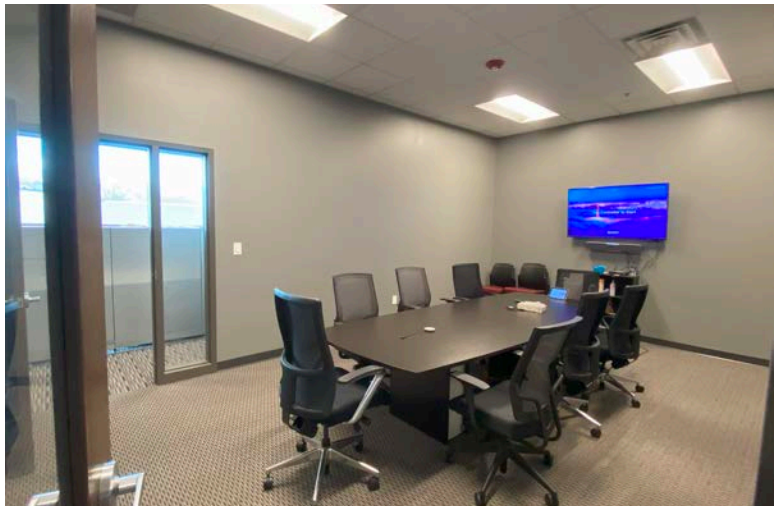

Floor Plan



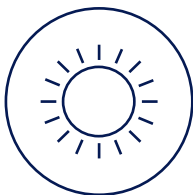

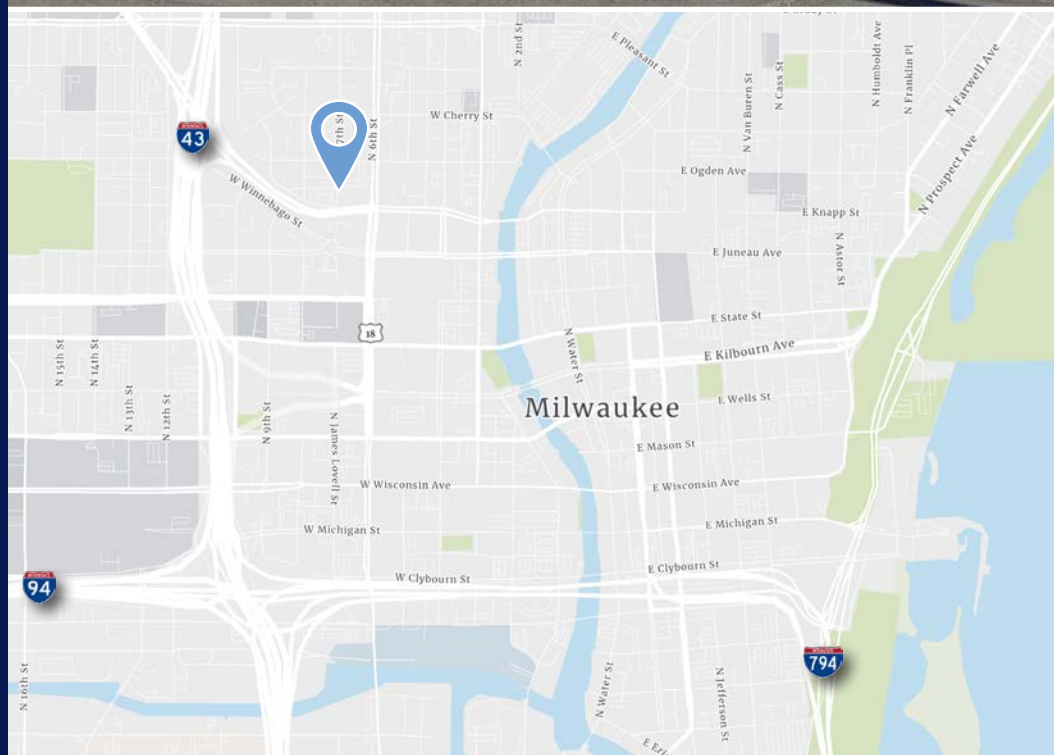
