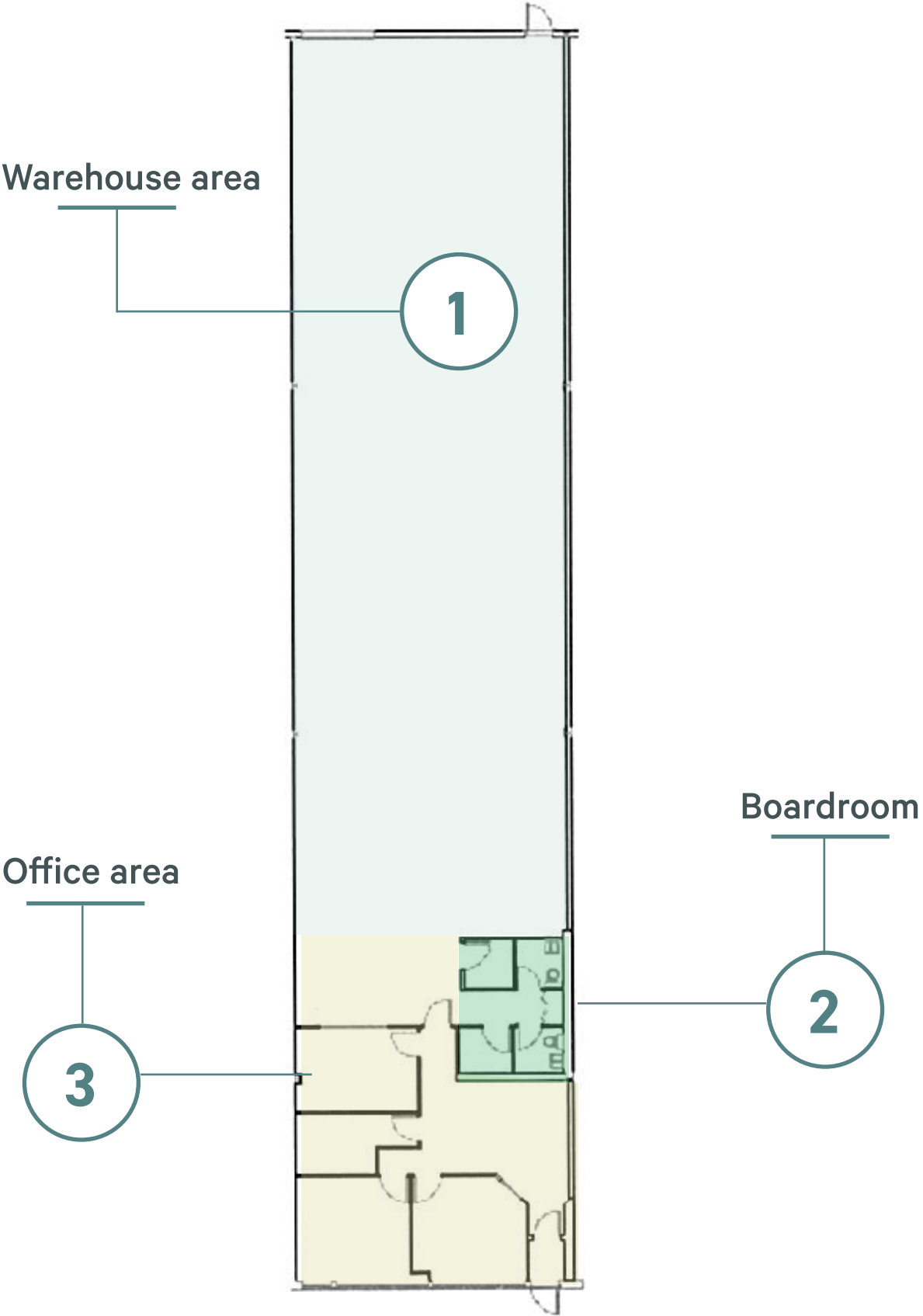
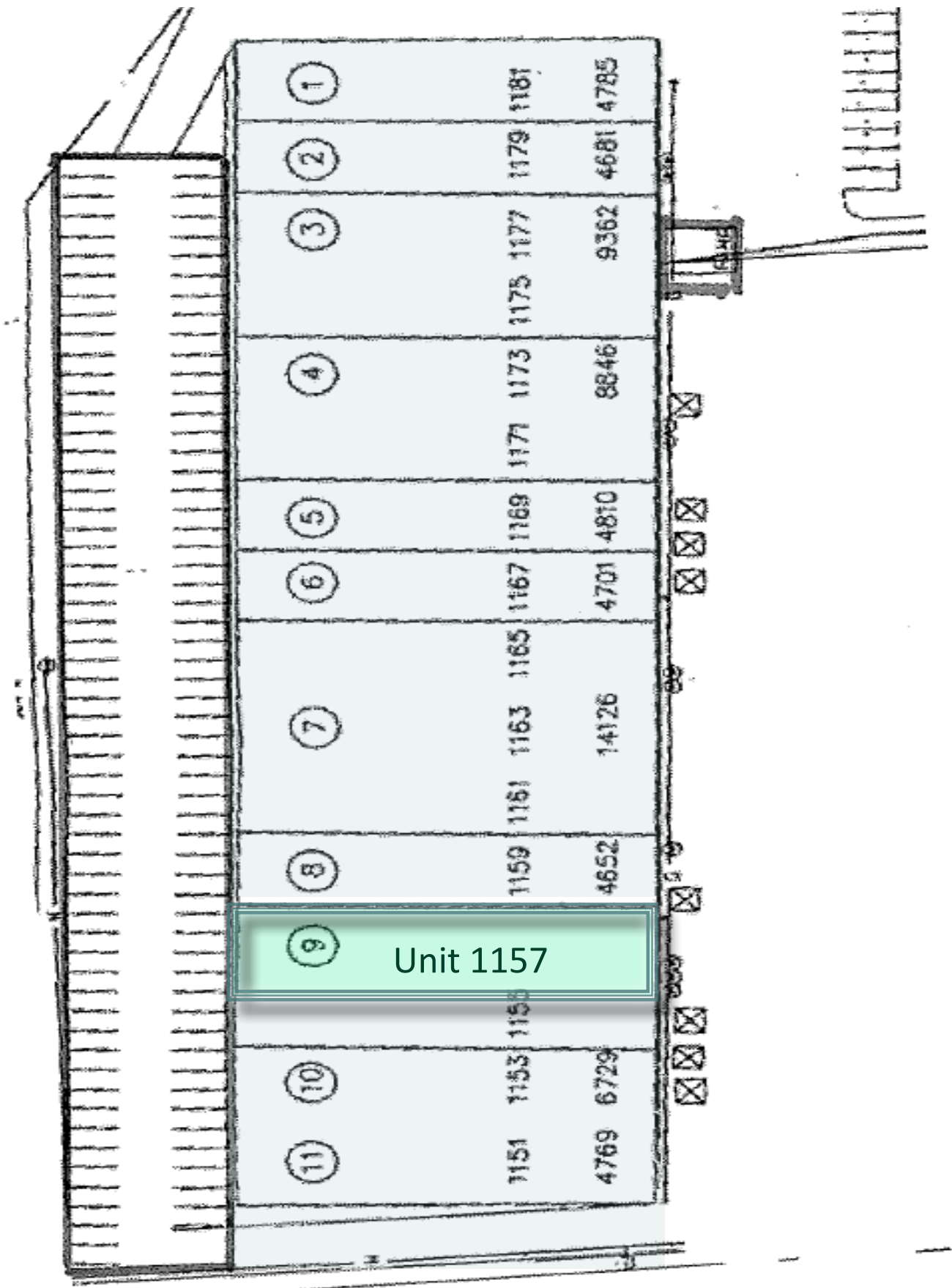

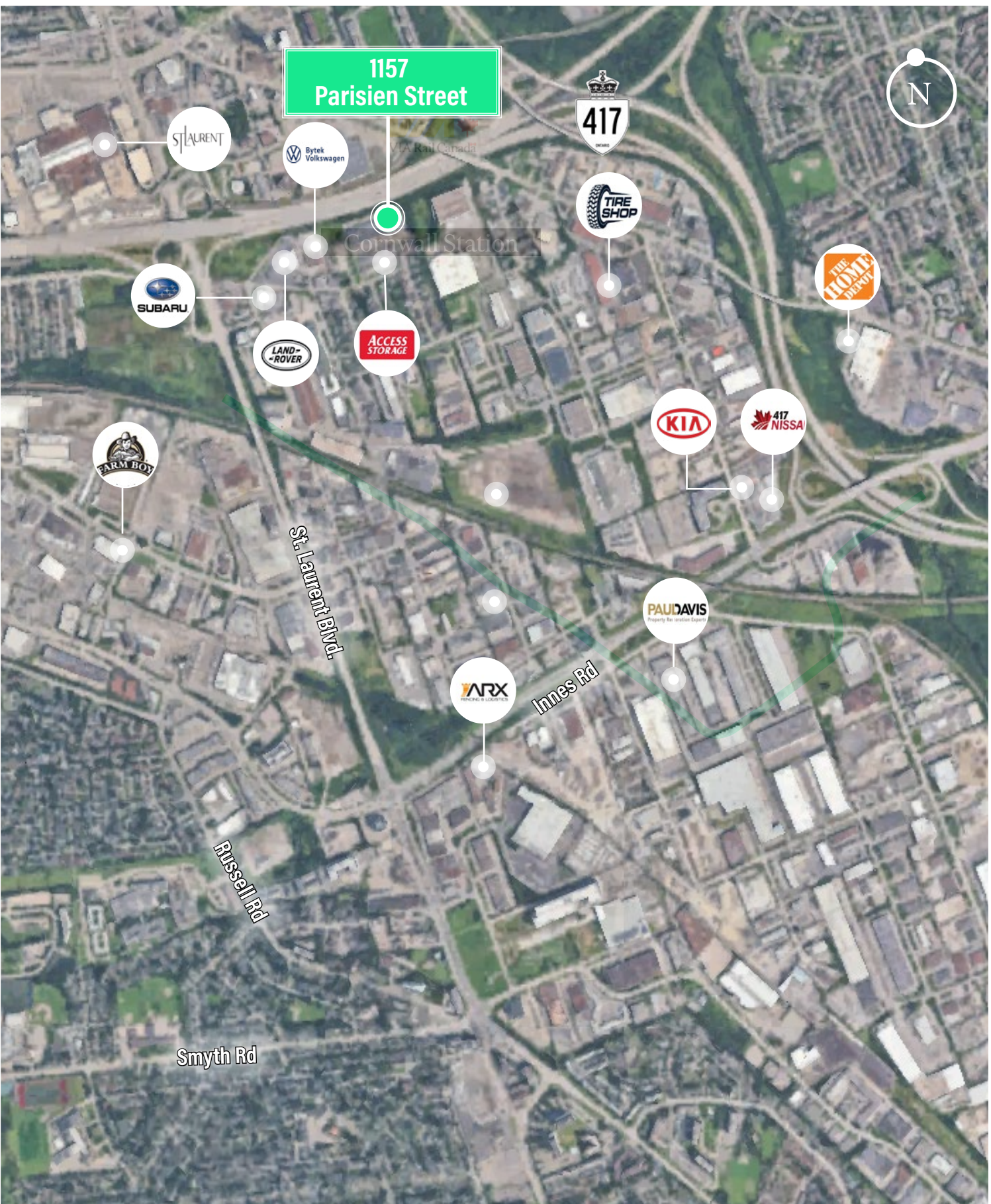
Existing Floor Plan Layout
