## MANCHESTER'S ICONIC BUSINESS ADDRESS

City Hall Plaza is a 219,700 SF, 19-story office tower located in the heart of Manchester's Central Business District. Designed by Lavallee Brensinger Architects and completed in 1992, it remains the tallest office tower in Manchester, the state of New Hampshire, and all of northern New England. The building features an elegant granite and wood-clad lobby, eight high-speed elevators, structured parking, and a full suite of on-site services. Floorplates are efficiently designed and easily divisible, with expansive window lines offering natural light and panoramic views of the city and Merrimack River. City Hall Plaza is home to a prestigious tenant roster and surrounded by higher education institutions making it a central destination for businesses in Manchester.
