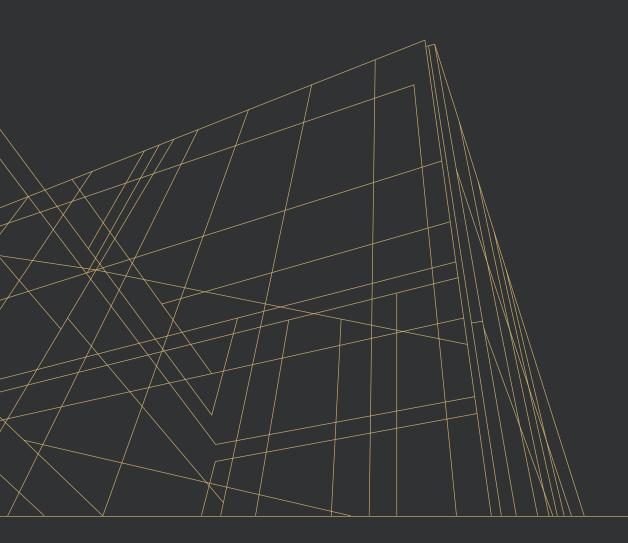
SUITE 8320

Suite 8320 is the eastern most suite. This suite has been remodeled and is also currently Month-to-Month, NNN.



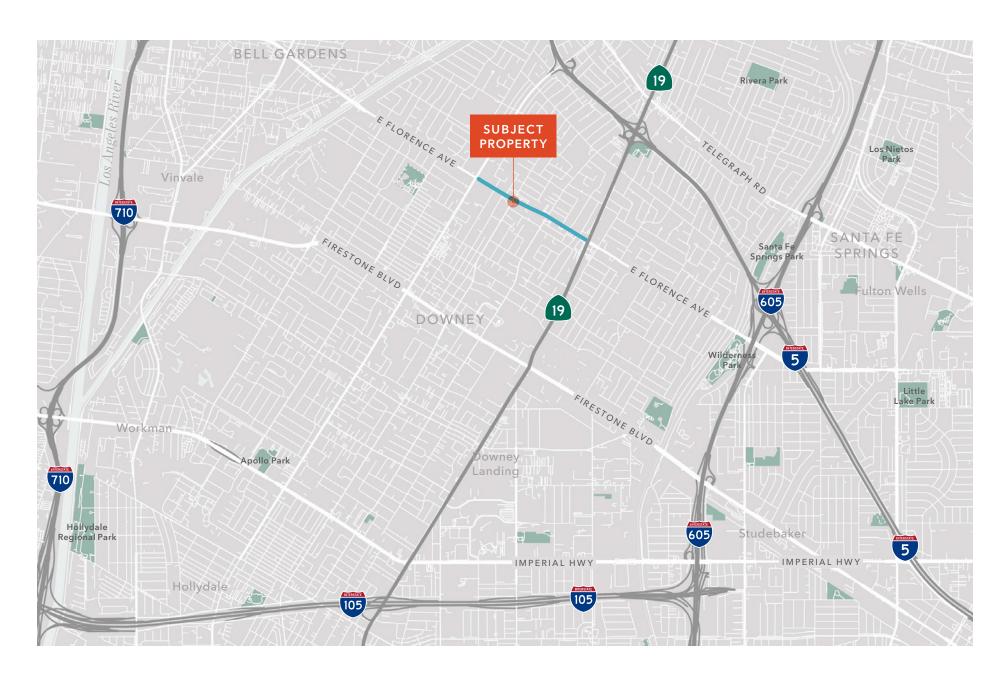

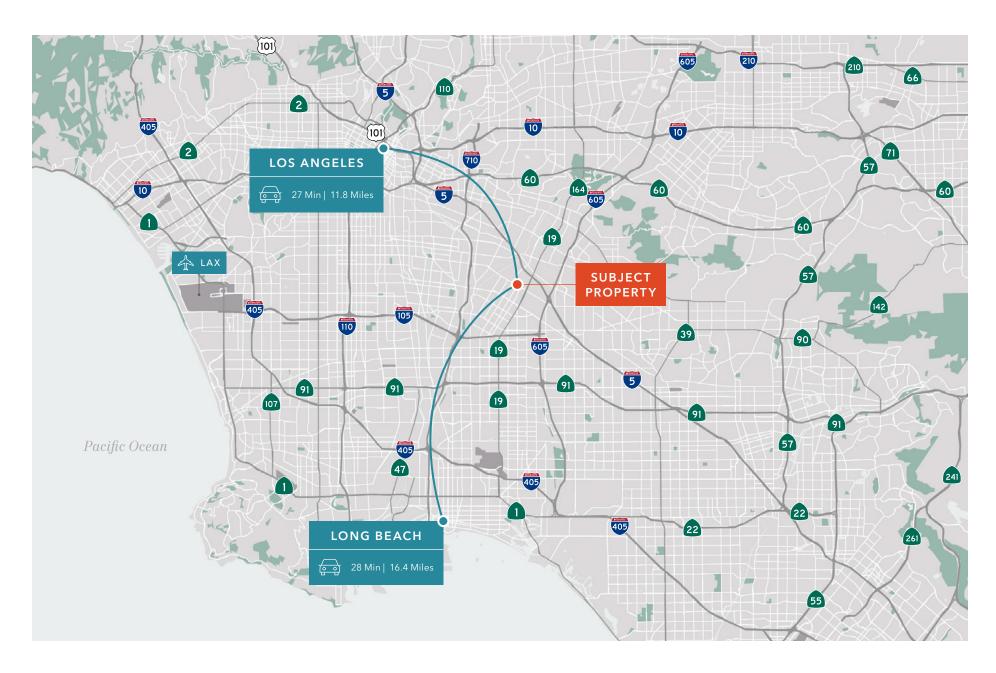


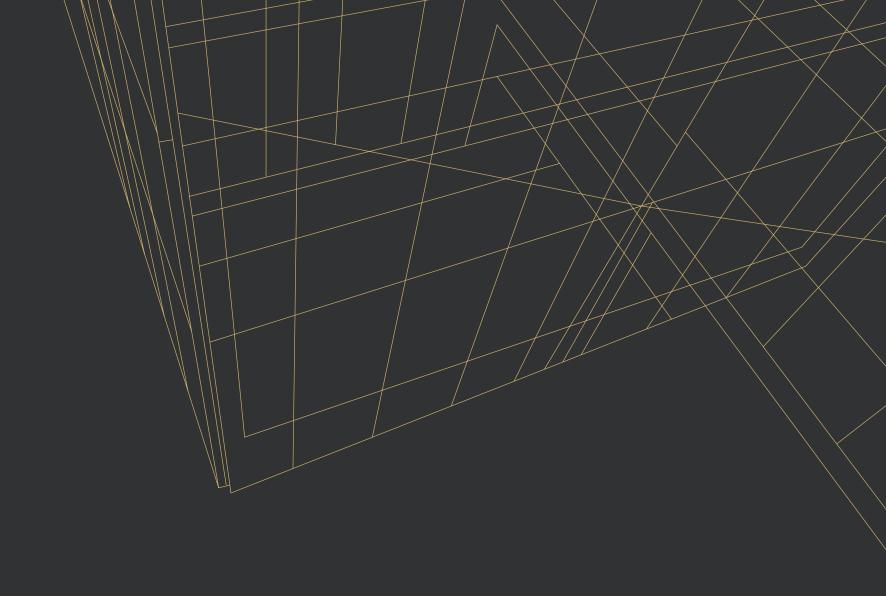
