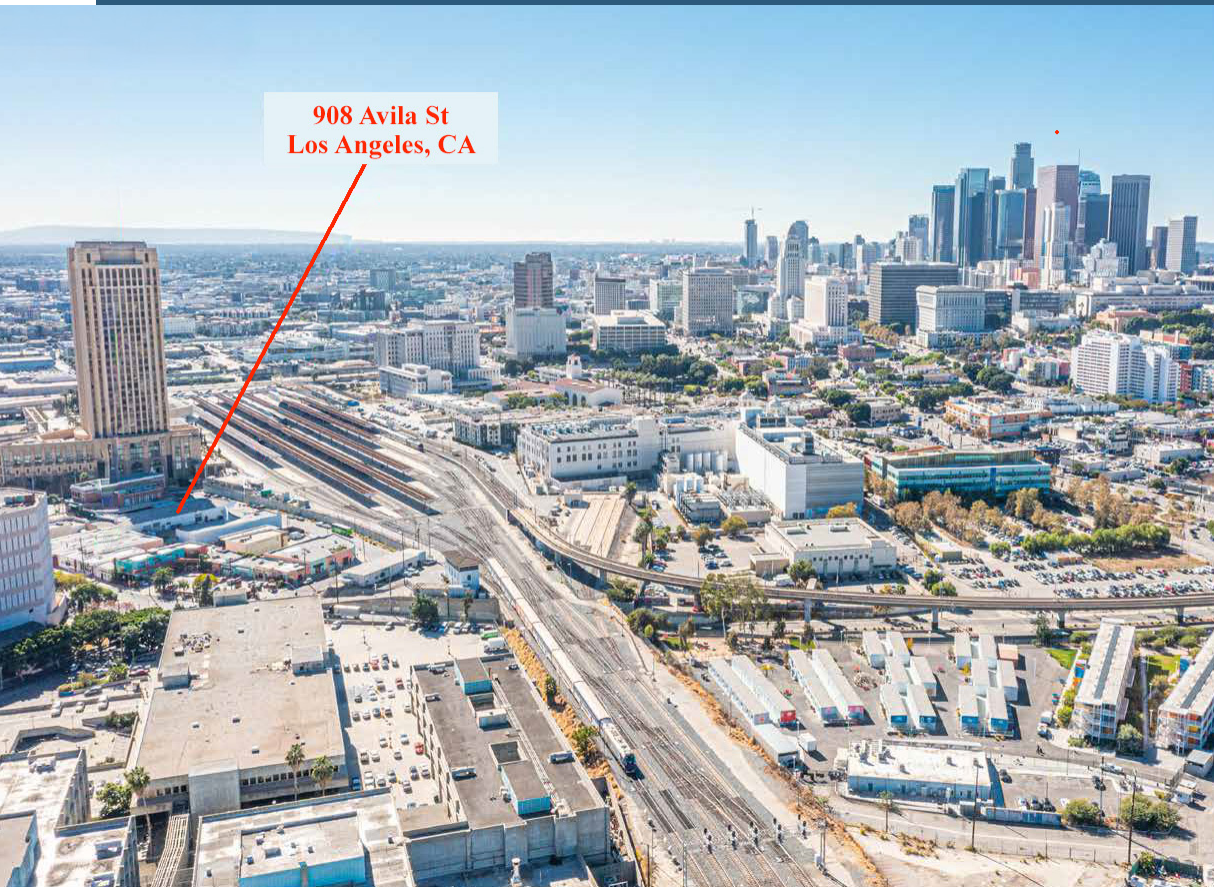

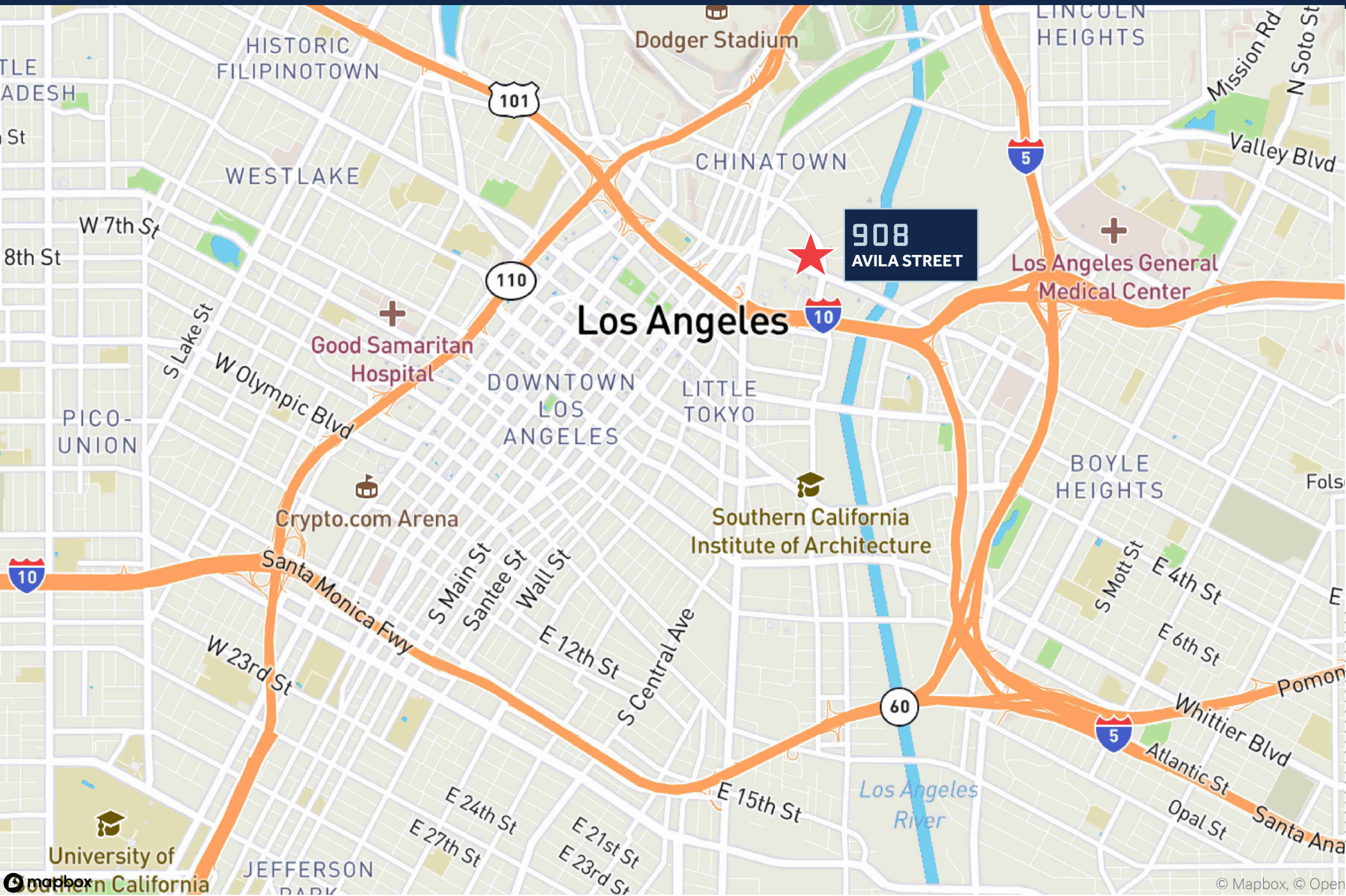

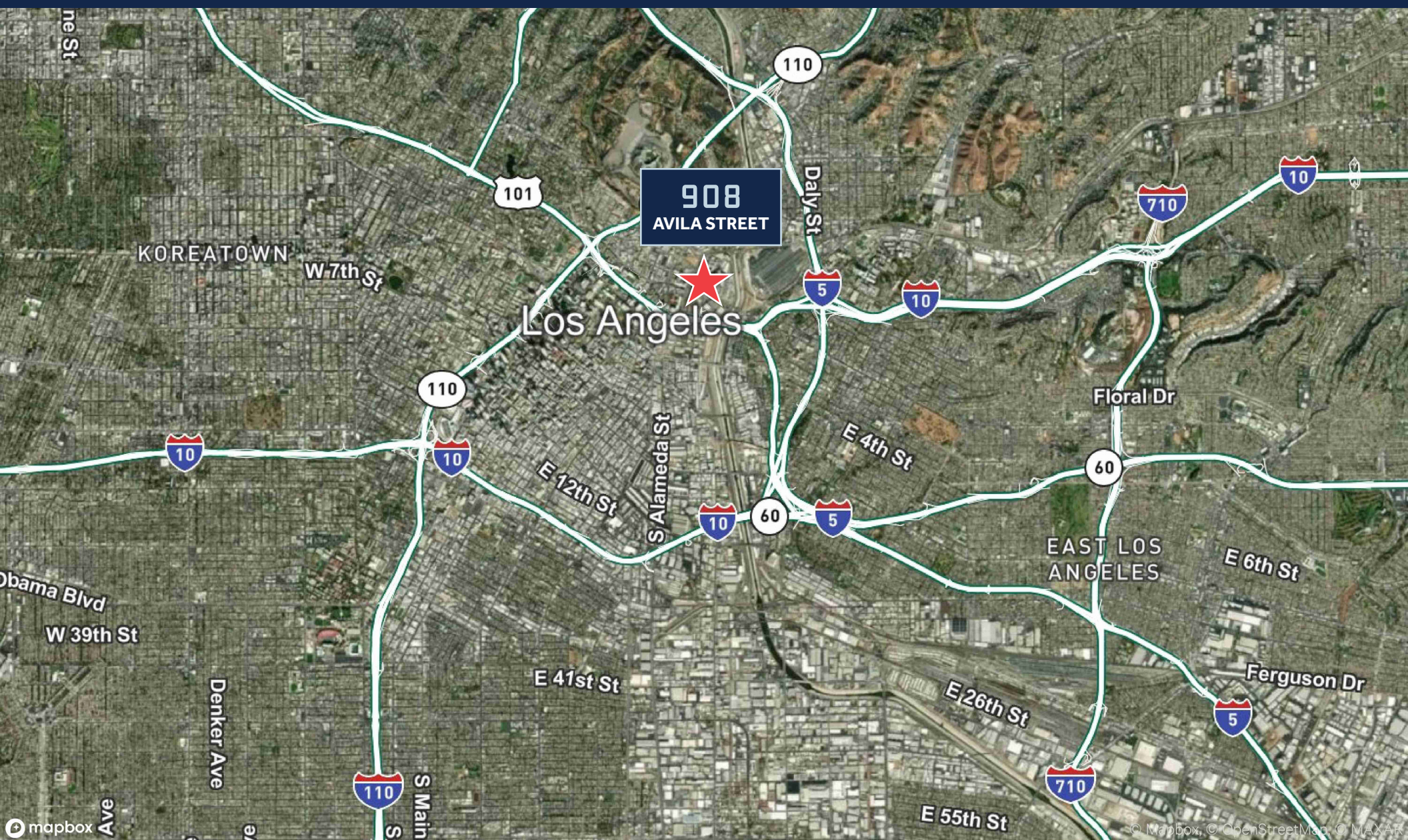
Location Map
