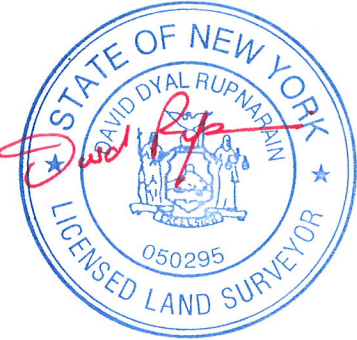

RUNNING THENCE EASTERLY ALONG THE NORTHERLY SIDE OF BURNSIDE AVENUE
142.00 FEET TO A POINT;
RUNNING THENCE ALONG A LINE FORMING AN INTERIOR ANGLE OF 146°18'36"
A DISTANCE OF 21.63' TO THE WESTERLY SIDE OF TAFT AVENUE;
THENCE ALONG A LINE FORMING AN INTERIOR ANGLE OF 123°41'24"
WITH THE LAST MENTIONED LINE 115.60 FEET TO A POINT;
THENCE ALONG A LINE FORMING AN INTERIOR ANGLE WITH THE WESTERLY
SIDE OF TAFT AVENUE 90°05'20" AND PART OF A DISTANCE THROUGH A
PARTY WALL 200.00' TO THE EASTERLY SIDE OF WHEELOCK AVENUE;
THENCE ALONG THE EASTERLY SIDE OF WHEELOCK AVENUE 40.00' TO A POINT;
