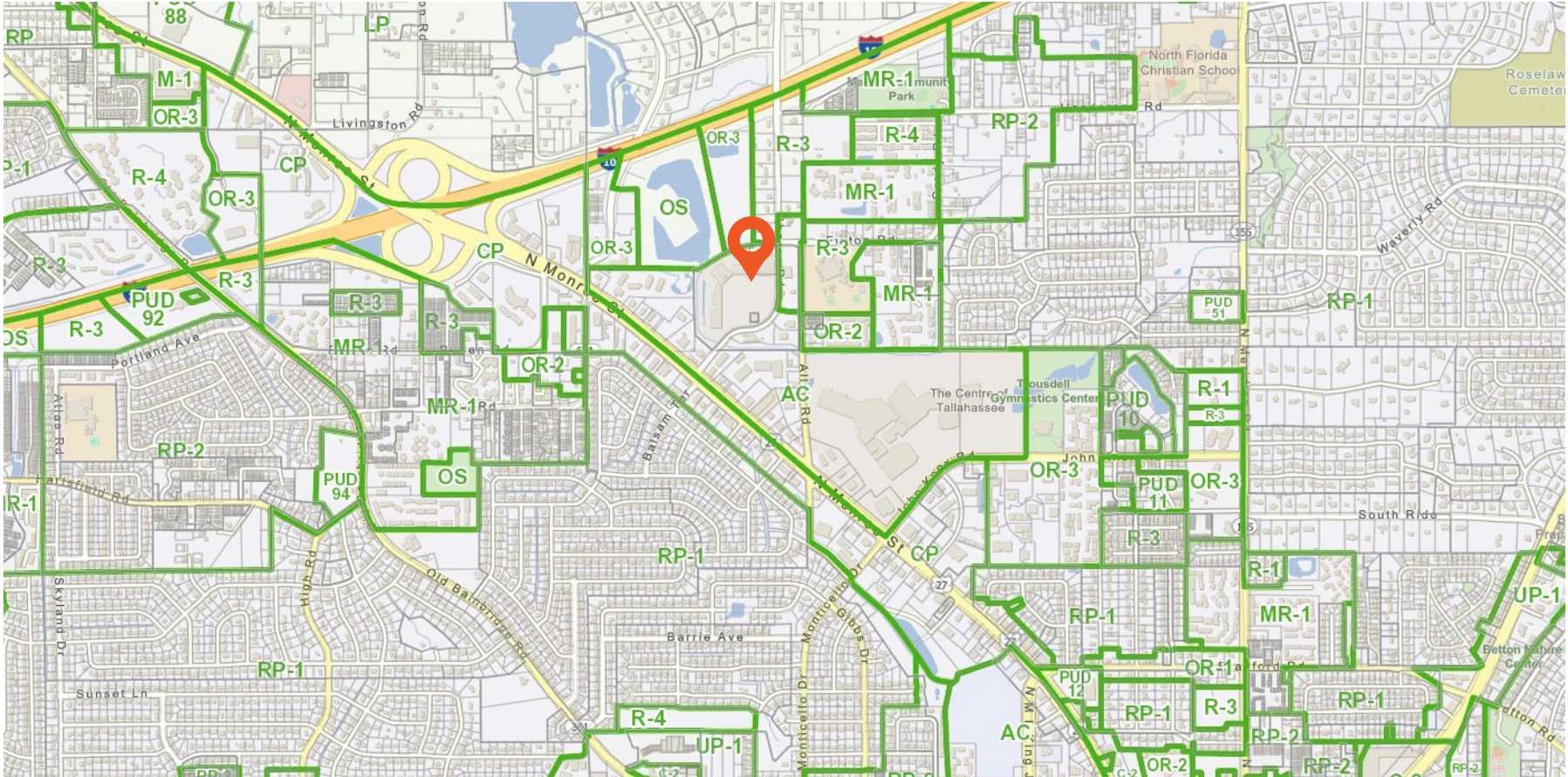

The subject property consists of a former retail big-box pad site converted for church use. Originally built in 1988, the space was converted for church use in 2005. The building is 75,107± square feet and sits on 1.72± acres.

The property includes a sanctuary that can seat 1,886± people, a large fellowship hall, a commercial grade kitchen, and multiple classrooms and offices. Parking appears to be adequate through a shared reciprocal agreement with the surrounding retail center and its 980 ± parking spaces.

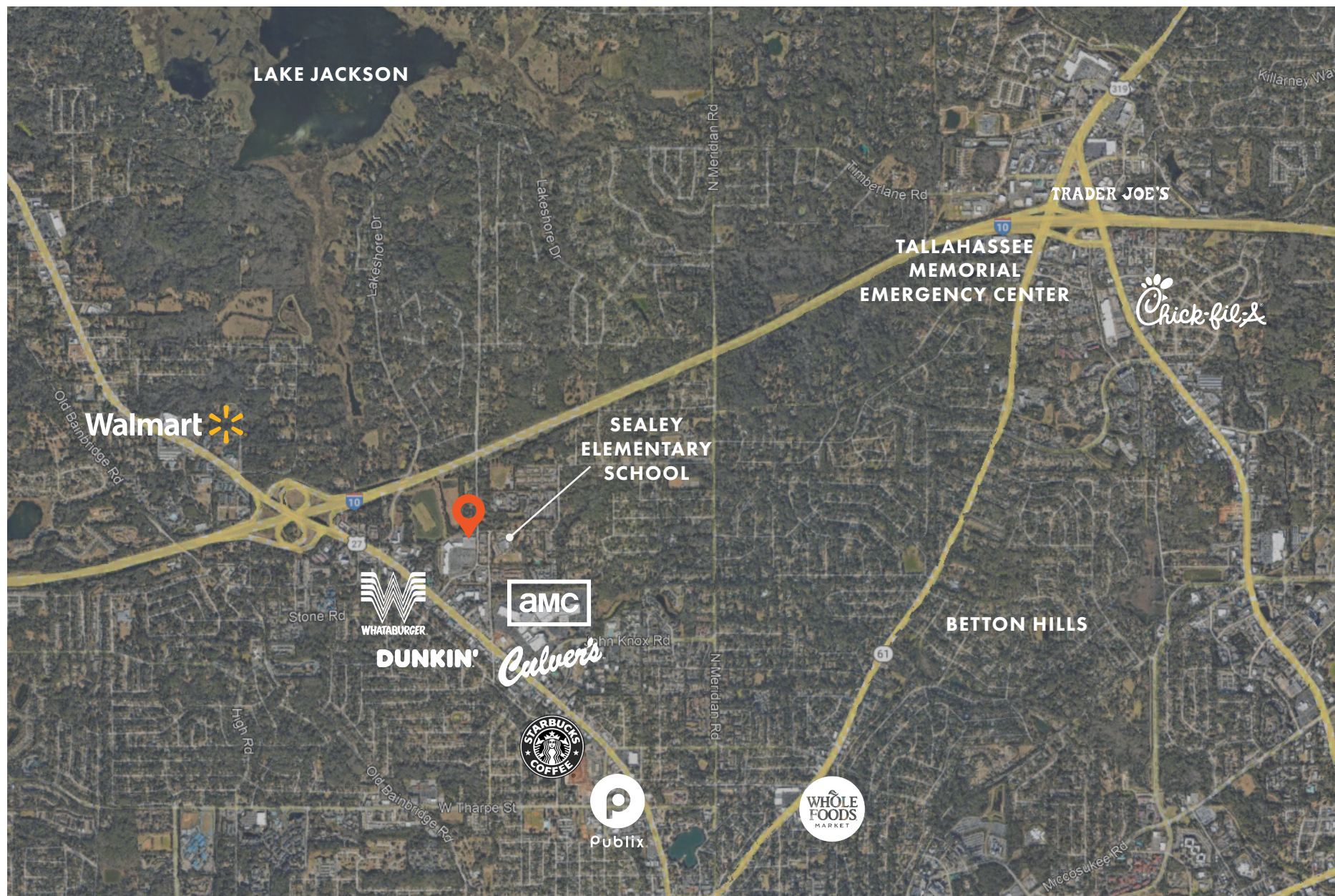

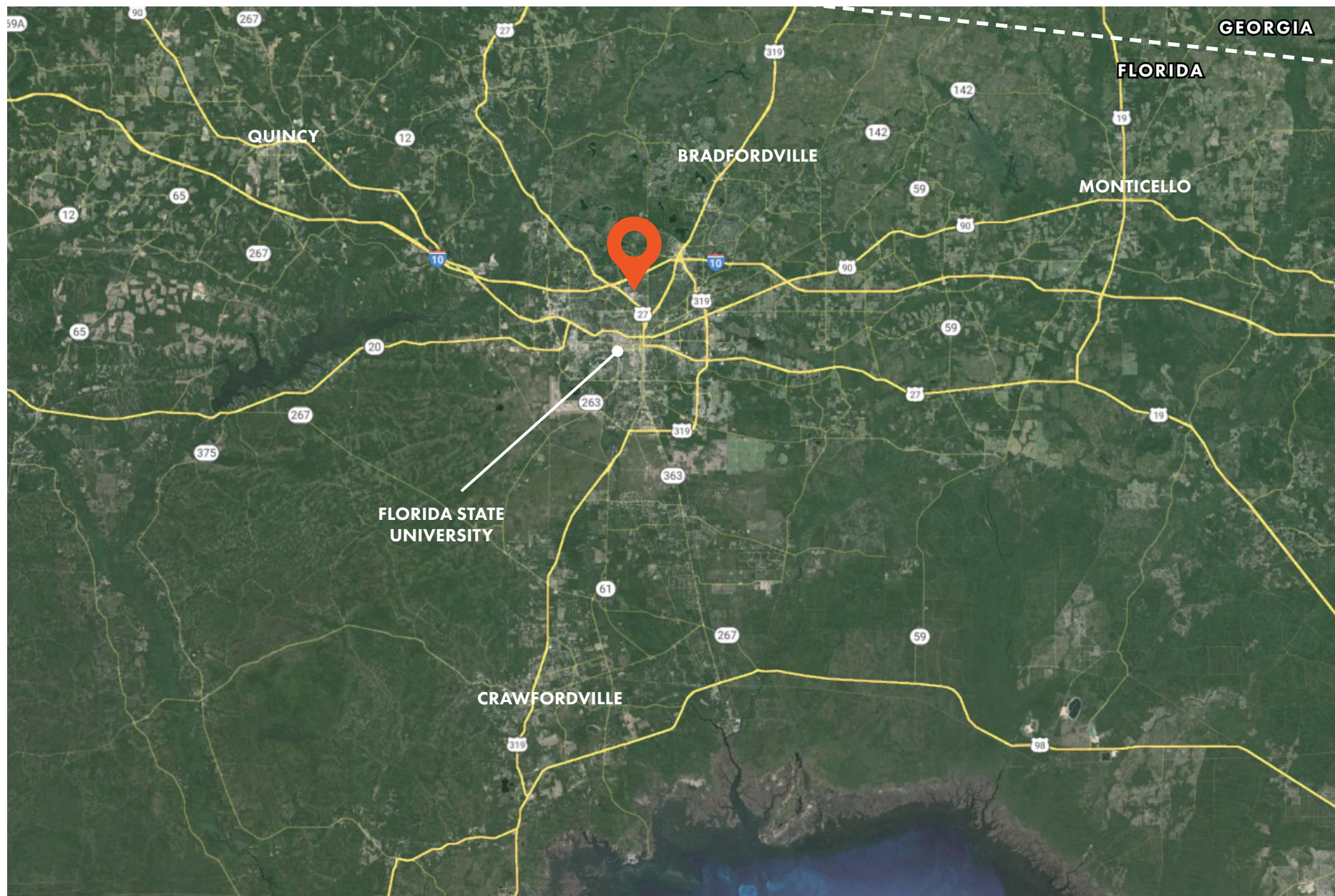

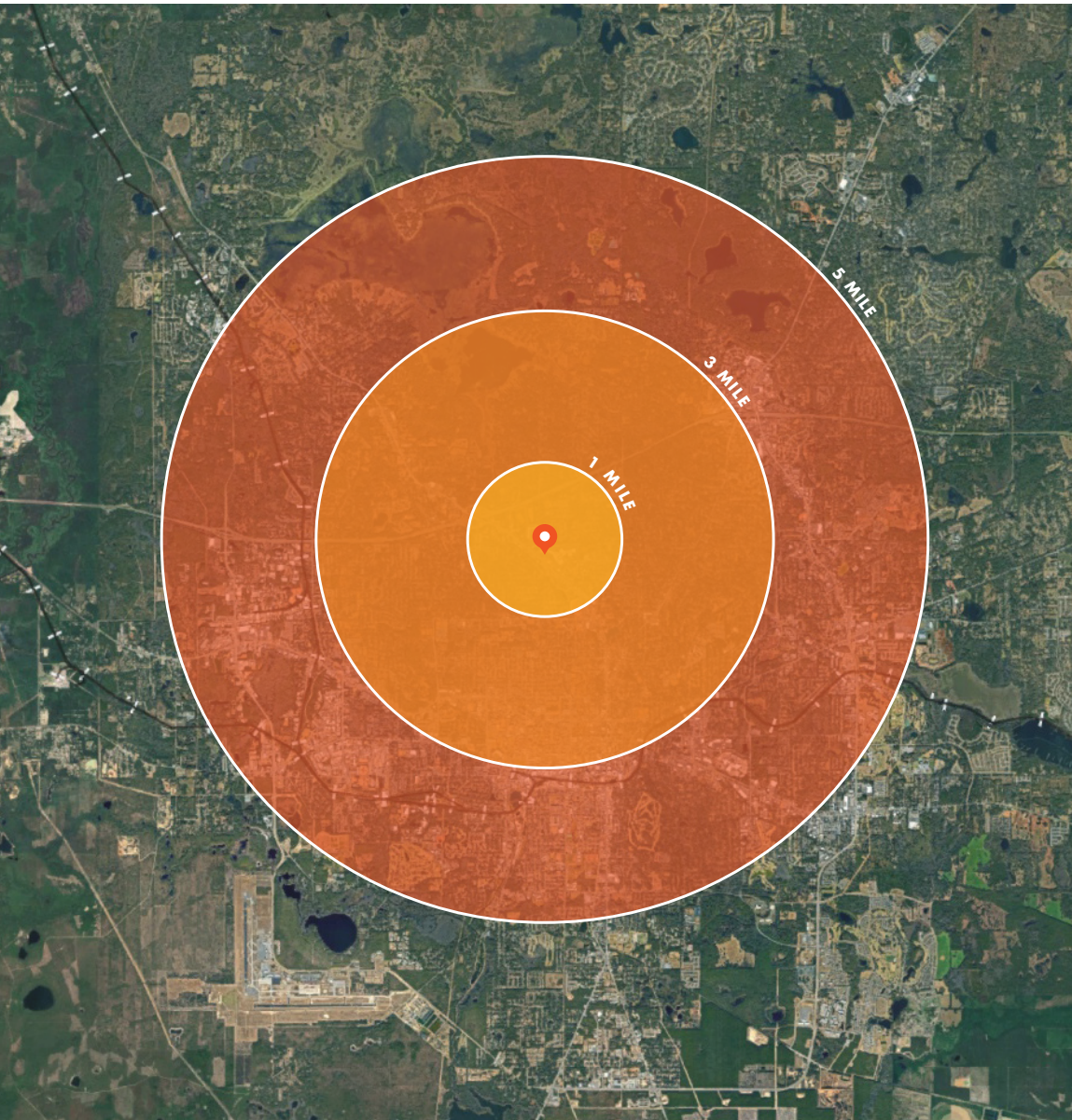
