# **Executive Summary**

The Boulder Group is pleased to exclusively market for sale a single tenant net leased Walgreens property located in Charleston, Illinois. Walgreens has successfully operated at this location since 2007 demonstrating commitment. The lease is absolute triple net featuring no landlord responsibilities. The lease runs through November 2032 leaving over 7 years of term remaining. Additionally, there are ten 5-year renewal options. Walgreens is the second largest pharmacy store chain in the United States with a Fortune 500 ranking of 27 for total revenue

The 14,550-square-foot building is strategically located along West Lincoln Avenue, also known as IL-16, which is a major thoroughfare for the area that experiences over 24,600 vehicles per day. IL-16 also connects the property to Eastern Illinois University. The university is found less than one mile east of the subject and enrolls over 9,000 students every year. Neighboring retailers found nearby include Starbucks, Ace Hardware, McDonald's, Chevrolet, Buick, GMC, Ruler Foods, and several others. There are over 19,000 people living within a five-mile radius. Those of which earn an average household income of \$76,187.













#### **CHARLESTON, ILLINOIS**

Charleston, Illinois is a charming city located in Coles County in the east-central region of the state. Founded in 1831, it serves as the county seat and is perhaps best known as the home of Eastern Illinois University. According to the 2020 U.S. Census, Charleston's population is approximately 17,286, though the city also sees a sizable student presence when classes are in session. The area benefits from a balance of small-town comforts and the cultural and educational influence of the university. Charleston's history includes notable sites tied to Abraham Lincoln's legal and political career, and the city is part of the Charleston–Mattoon Micropolitan Statistical Area, highlighting its close economic and social connections to nearby Mattoon.

In addition to its collegiate atmosphere, Charleston boasts numerous recreational opportunities. Lake Charleston, on the city's southeast side, provides scenic walking and biking trails, fishing spots, and picnic areas. Cultural activities include local museums such as the Lincoln Douglas Debate Museum in neighboring Coles County, reflecting the area's storied past. 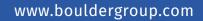
