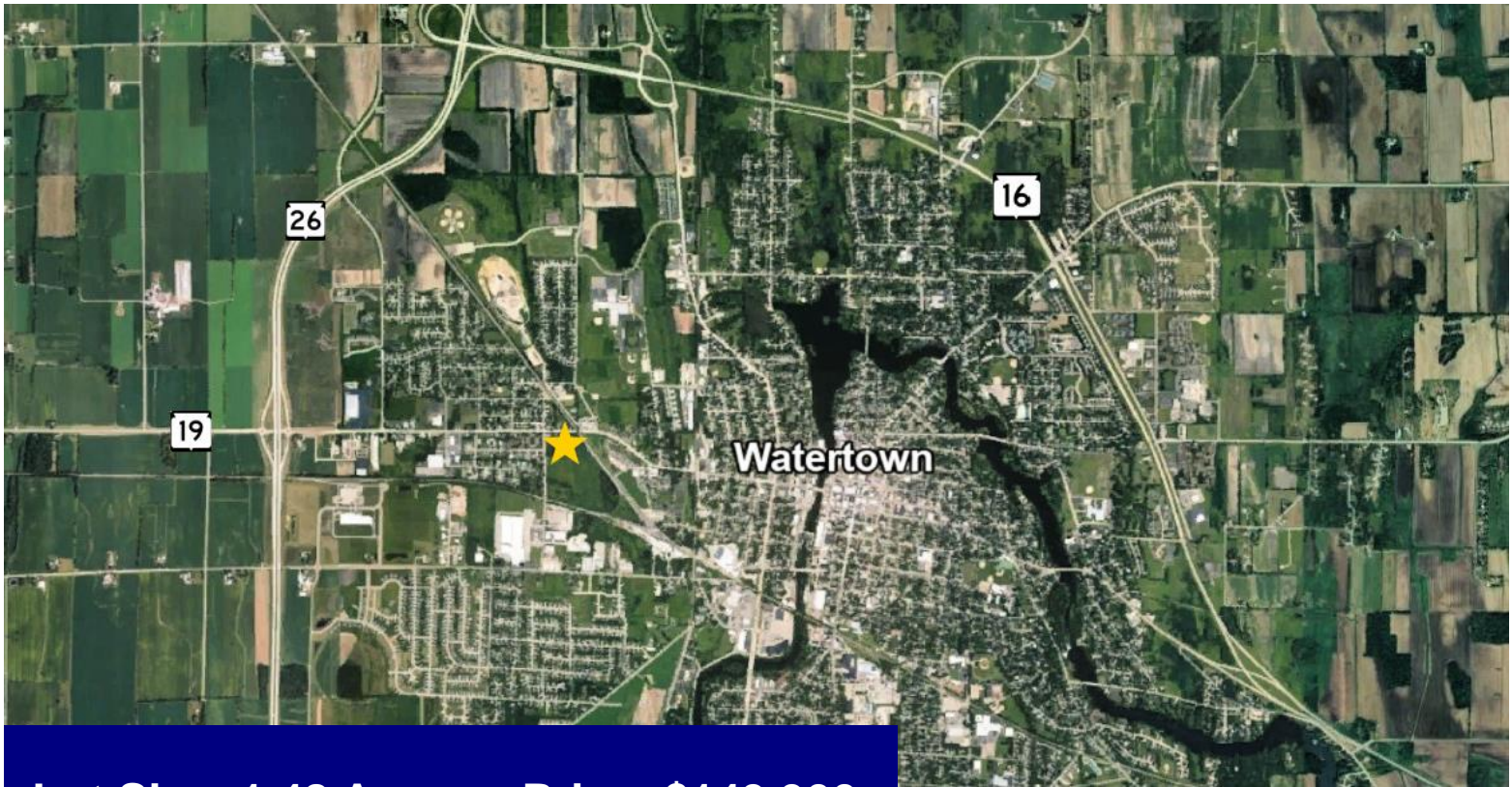

- 17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the
