If the Texas Legislature had not enacted property tax relief legislation during the 2023 legislative session, your tax bill would have been \$23,337.55. Because of action by the Texas Legislature, your tax bill has been lowered by \$2,101.77, resulting in a lower tax bill of \$21,235.78, contingent on the approval by the voters at an election to be held November 7, 2023, of the constitutional amendment proposed by H.J.R. 2, 88th Legislature, 2nd Called Session, 2023.
