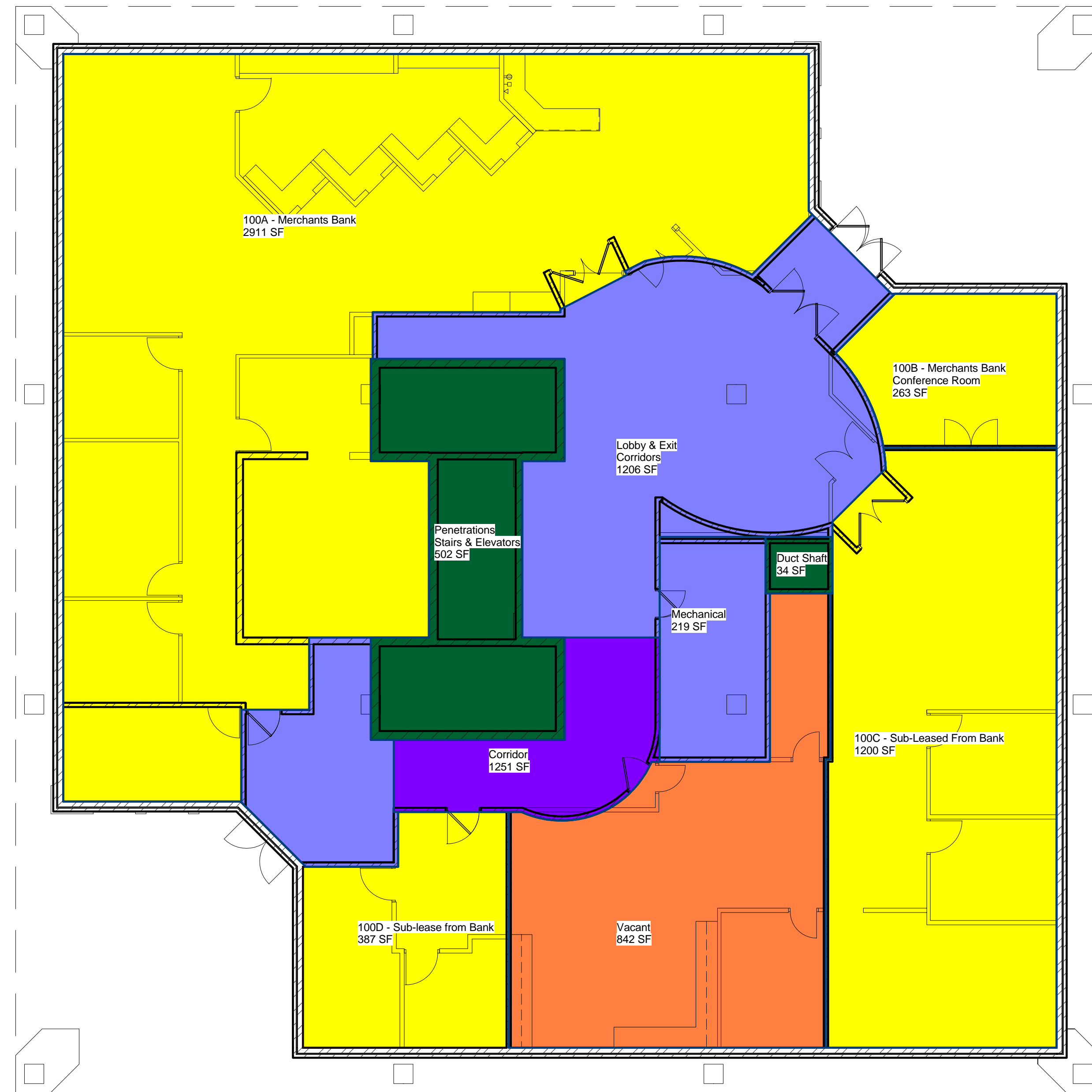


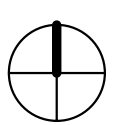

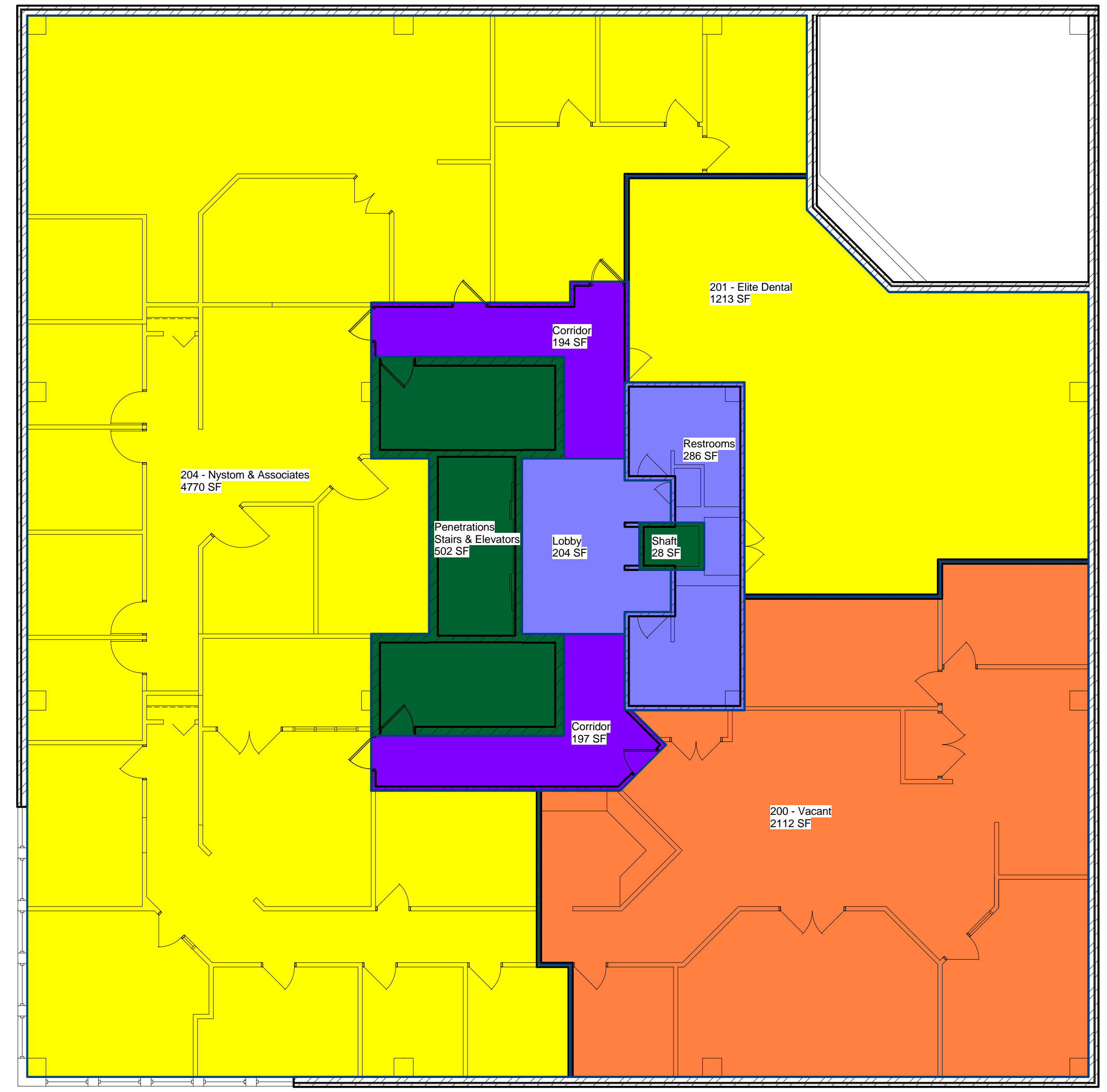

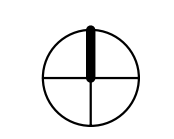

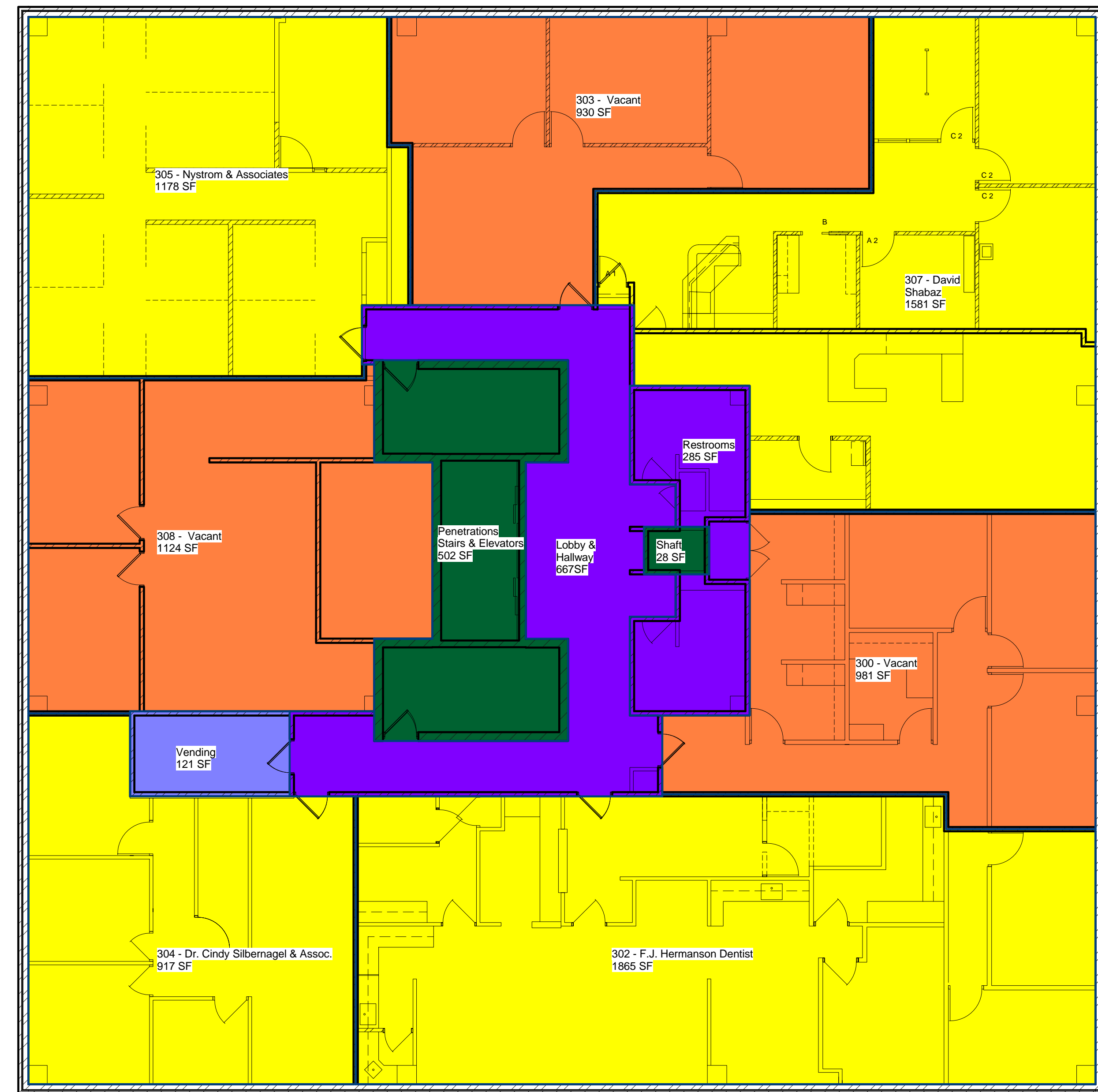
A1 SC02 Second Floor Plan (Area)

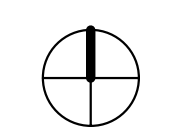

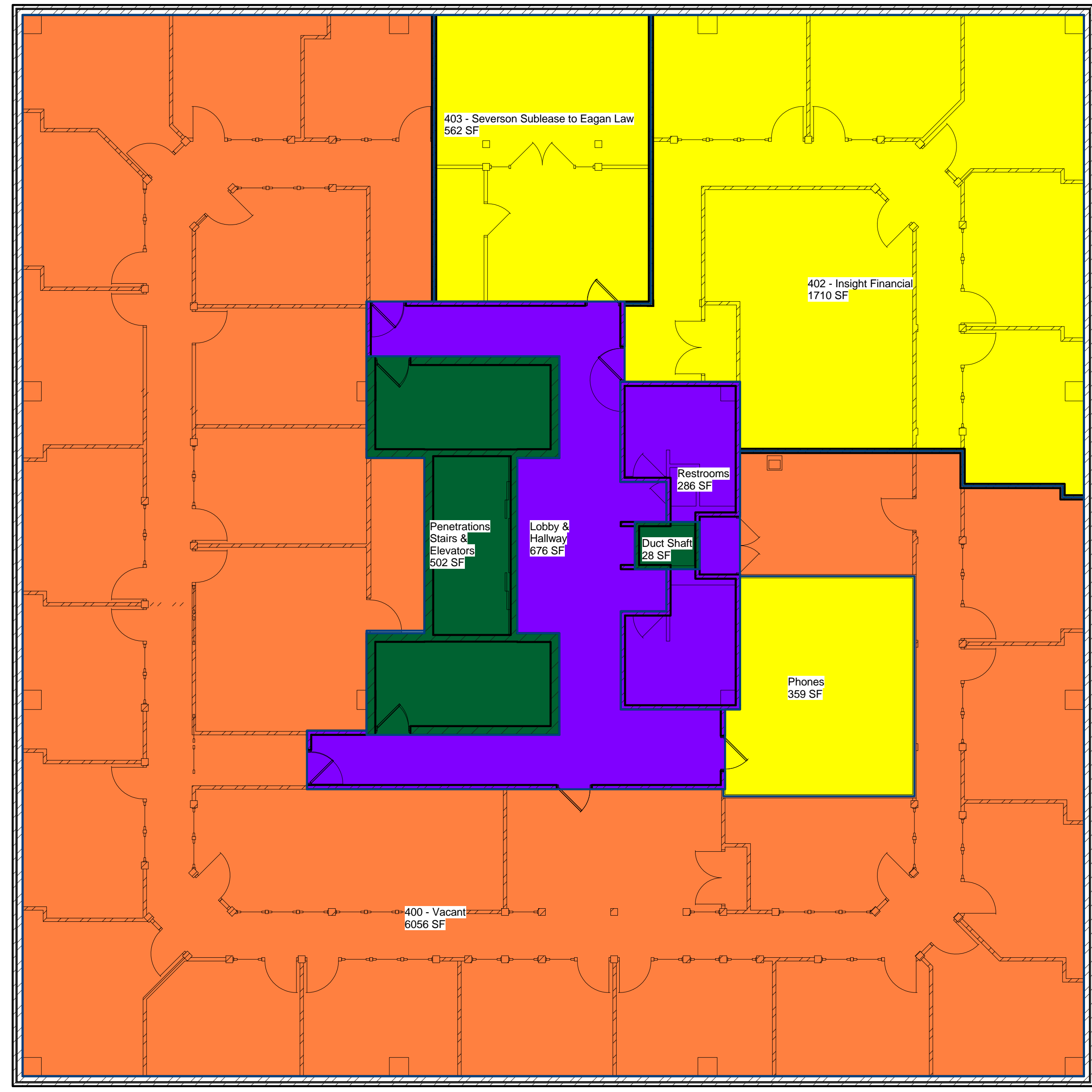

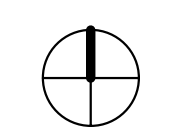

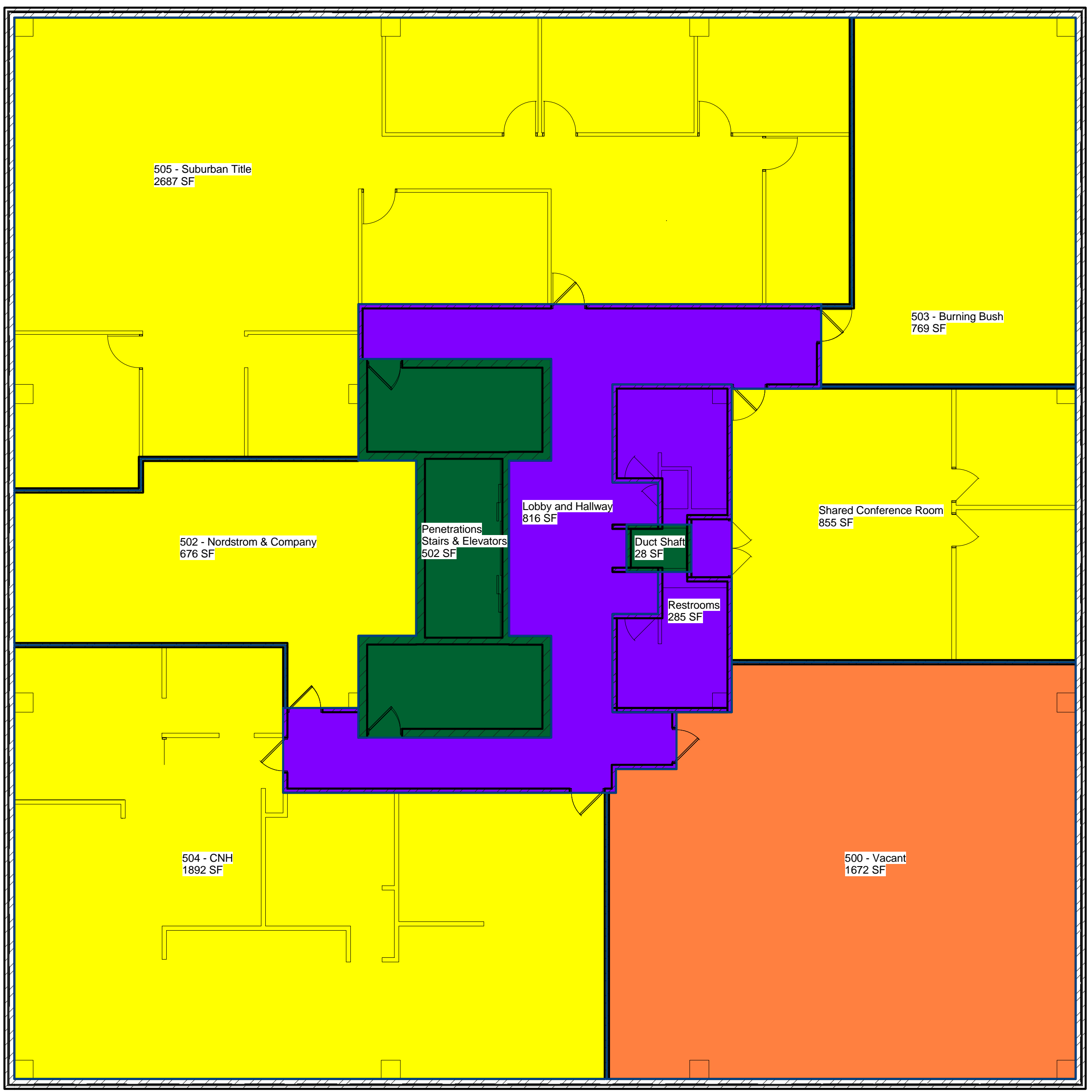

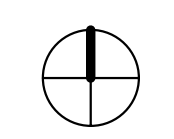

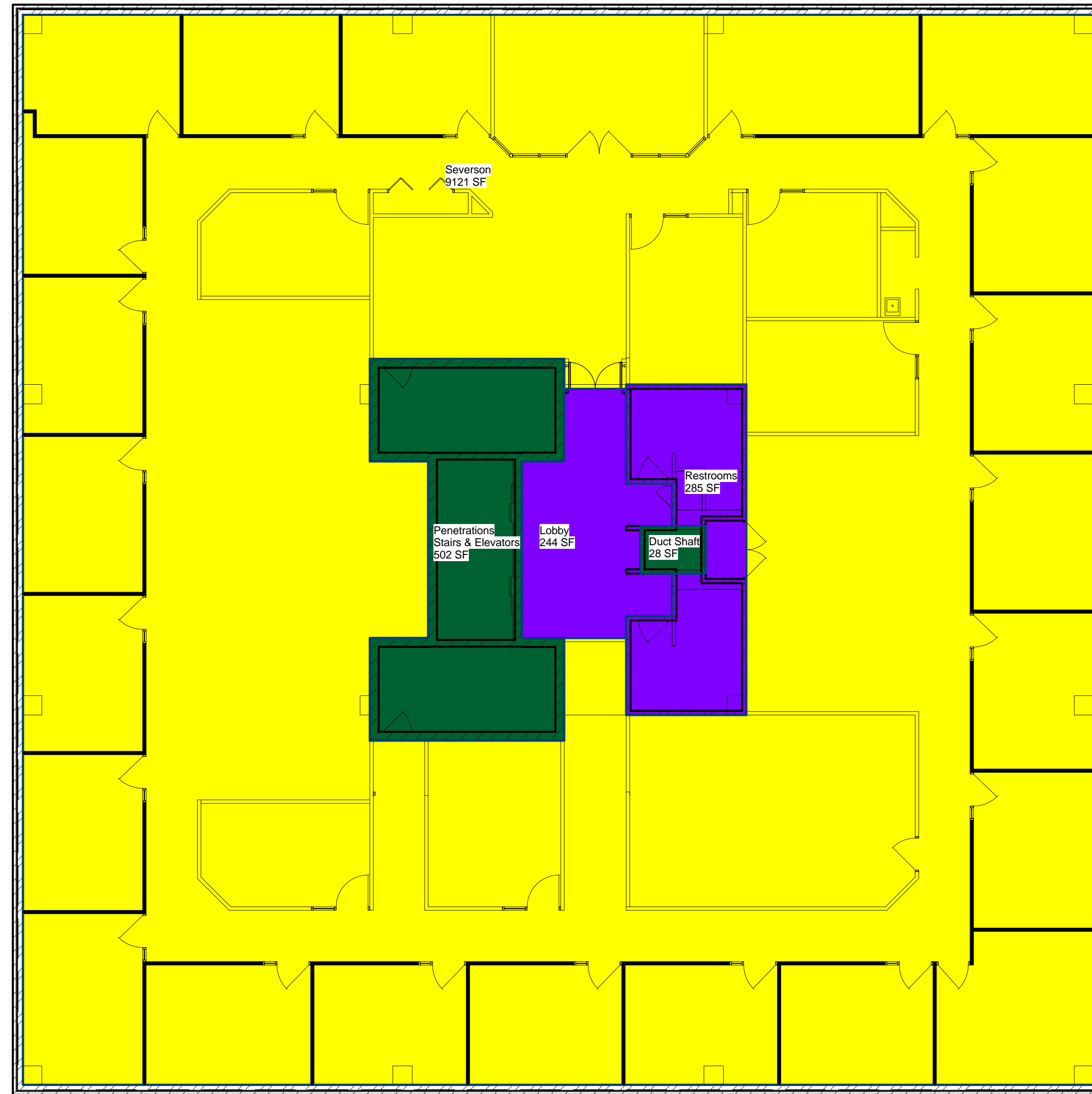

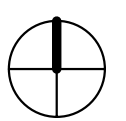
