Skyline Chili is strategically located at 2216 Lantern Ridge Drive within Richmond Centre in Richmond, Kentucky, a prominent lifestyle center in Madison County. Situated along I-75, approximately 21 miles south of Lexington, Richmond Centre serves as south-central Kentucky's premier destination for shopping, dining, and entertainment. This 685,000 square foot center is the dominant retail development in the market and the largest on I-75 between Lexington, Kentucky and Knoxville, Tennessee.

Richmond Centre is anchored by major retailers and entertainment venues including Meijer, Cinemark, JCPenney, Belk, and Dick's Sporting Goods, alongside other well-known brands such as T.J. Maxx, HomeGoods, and Ulta. The center had over 75 million visitors in the past year, drawing shoppers and diners from over 12 counties across central Kentucky and is recognized as the number one lifestyle center in the state, according to Placer.ai.

Skyline Chili is a chain famous for its unique Cincinnati-style chili. Other restaurants in the center include Olive Garden, Logan's Roadhouse, Skyline Chili, Panera Bread, Raising Cane's, Chick-Fil-A, Starbucks Coffee, Culver's, and Buffalo Wild Wings.

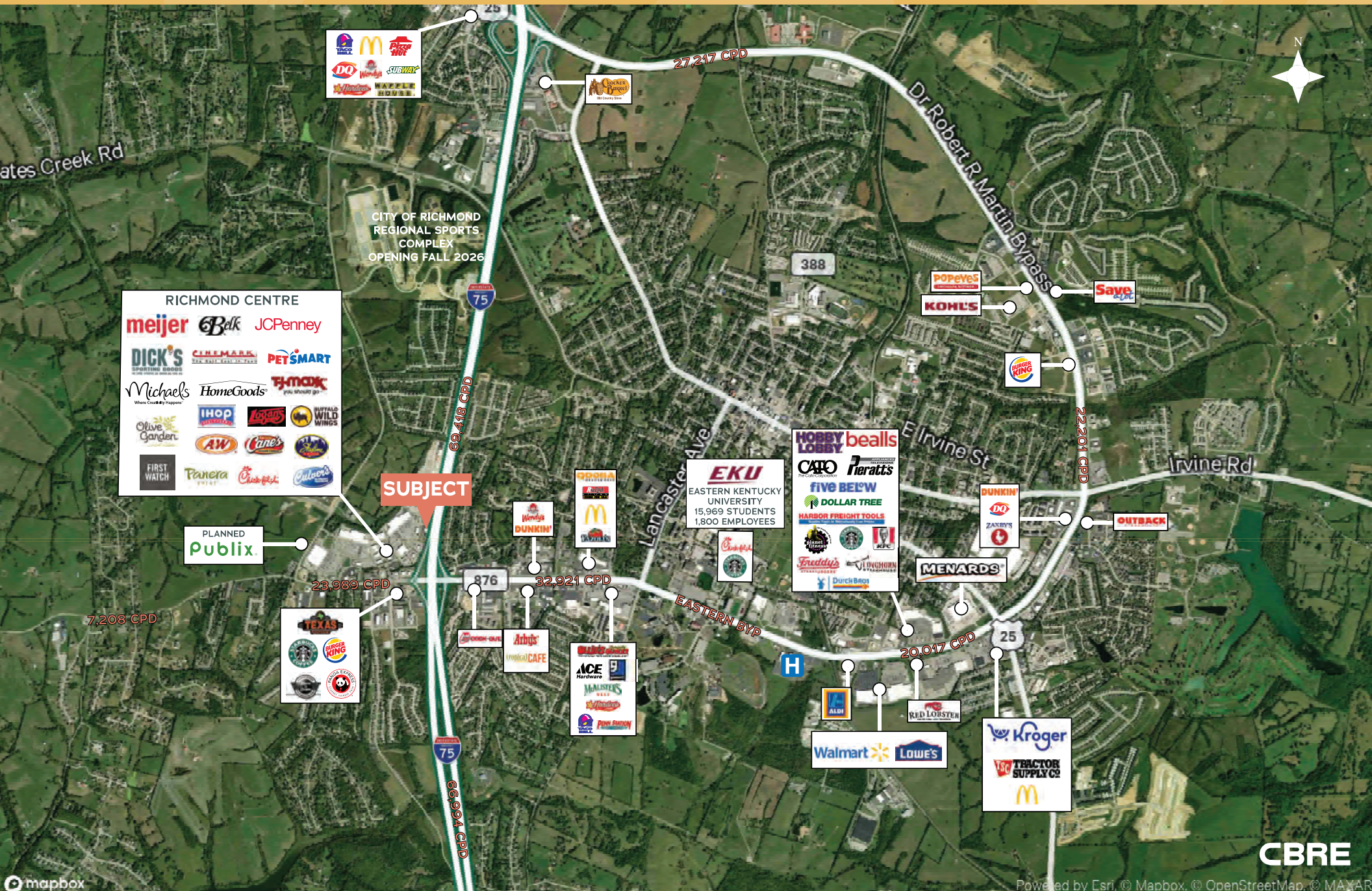

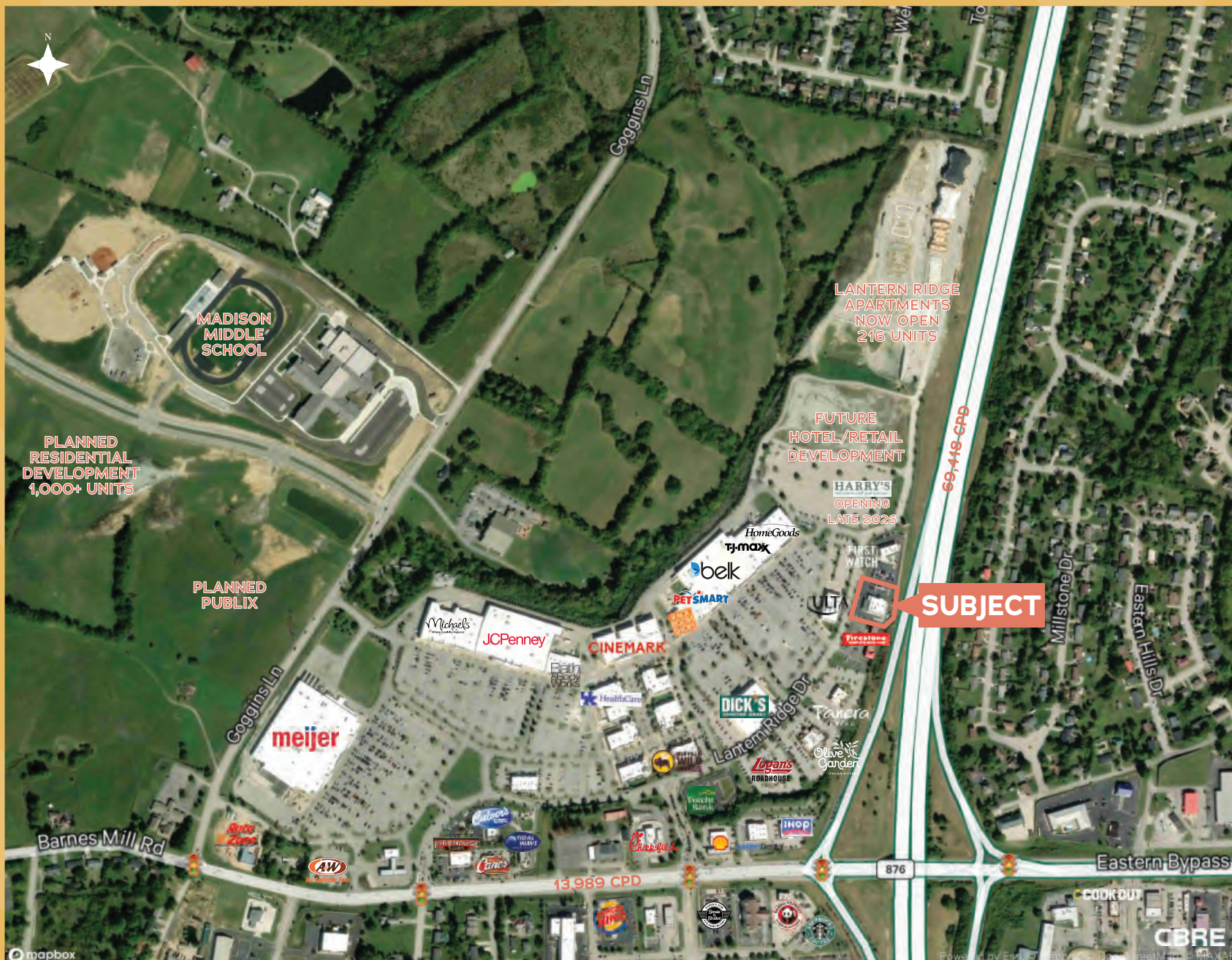
