DESCRIPTION

Elder House comprises three floors of office accommodation located above a number of retail units and restaurants. It is clad with a double glazed curtain walling system and there is allocated car parking to the rear.

Immediately adjacent to Elder House, Milton Keynes central train station offers regular and frequent trains to London Euston, with a fast journey time of approximately 33 minutes.




