3 **Villages of Rosewick Annexation Plan**

5 **FOR** the purpose of approving an Annexation Plan for the annexation of 20.7256 acres, more  
6 or less, of land into the corporate limits of the Town of La Plata; and all matters relating  
7 to a plan for annexation of such 20.7256 acres of land, more or less, into the Town of La  
8 Plata.

10 **WHEREAS**, the Town of La Plata has received a written Petition for Annexation,  
11 C&K Properties of Maryland, LLC, to extend the boundaries of the Town by annexing 20.7256  
12 acres of land, more or less, as described in the Petition for Annexation and attached to Resolution  
13 22-05; and

15 **WHEREAS**, Local Government Article, Section 4-415, of the *Annotated Code of*  
16 *Maryland* requires that municipalities adopt annexation plans for areas proposed to be annexed  
17 into their corporate limits; and

19 **WHEREAS**, the Council of the Town of La Plata desires to adopt an Annotated Plan for  
20 the 20.7256 acres of land, more or less, to be annexed into the corporate limits of the Town of La  
21 Plata and subject to development.




