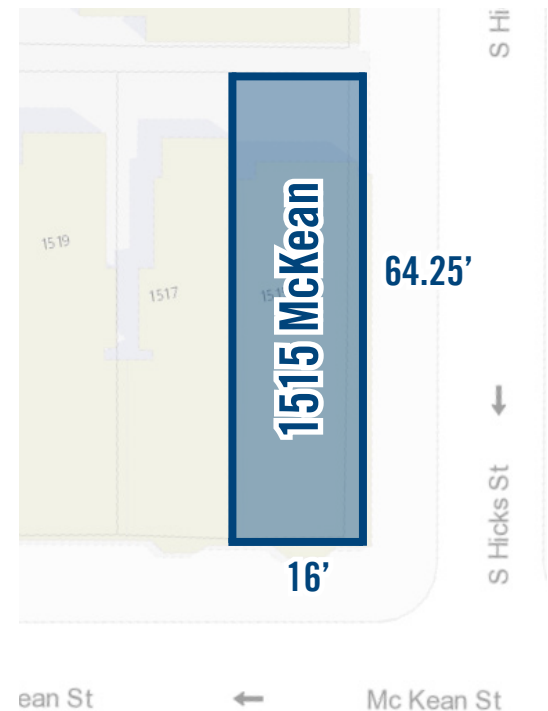

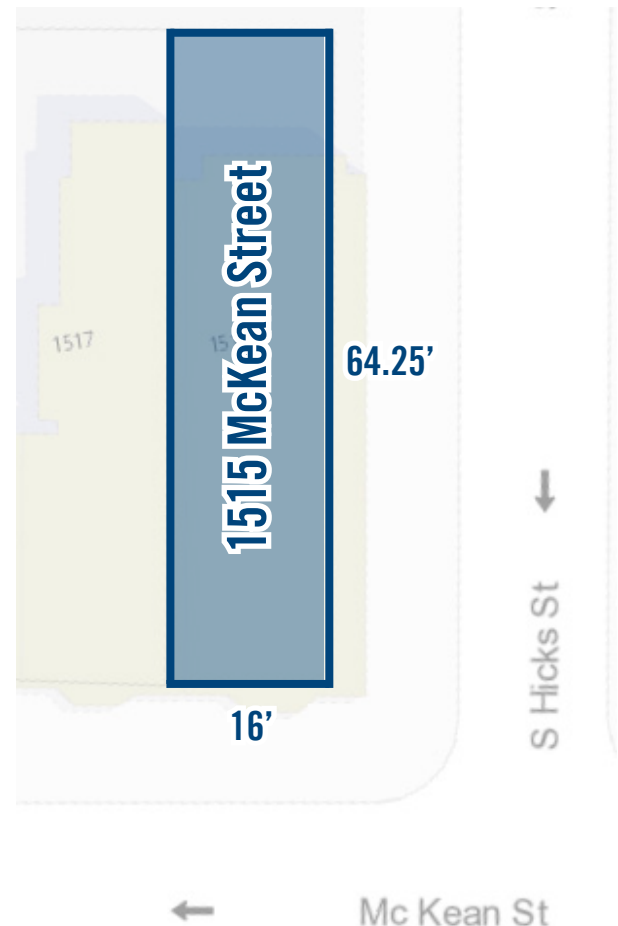

RETAIL MAP

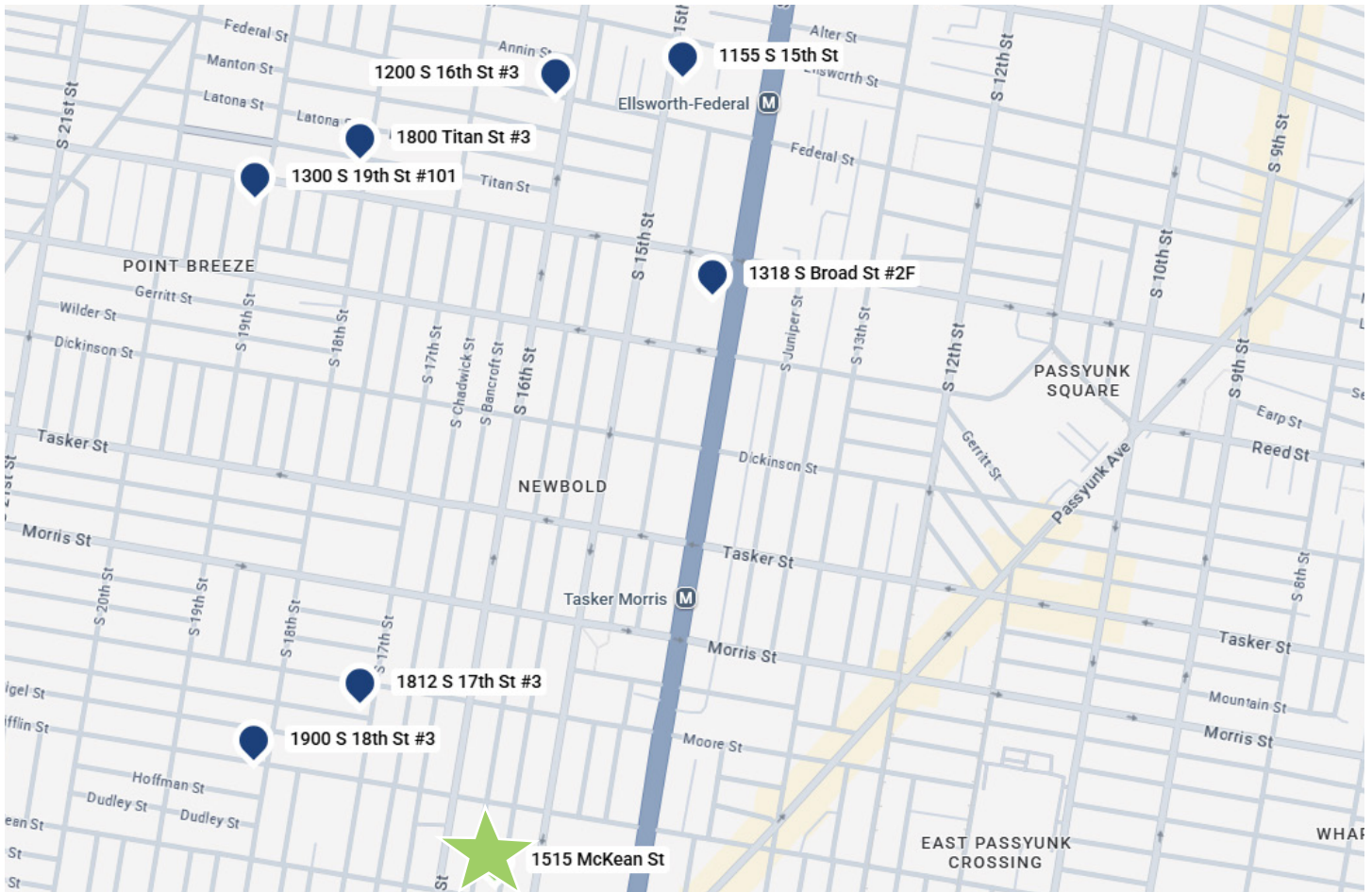

Newbold is a popular residential neighborhood in South Philadelphia, generally located between Broad Street and 18th Street, and between Washington Avenue and Passyunk Avenue. While some locals consider it part of the larger Point Breeze area, Newbold has developed its own identity over the past two decades and is known for its classic Philadelphia rowhomes, walkability, and growing restaurant scene.

The neighborhood has become especially attractive to young professionals and first-time homebuyers because it offers relatively affordable housing compared to Center City while maintaining easy access to downtown. Residents enjoy a dense urban environment with numerous restaurants, coffee shops, bars, and neighborhood businesses within walking distance. Newbold scores highly for walkability, biking, and public transportation access thanks to nearby SEPTA Broad Street Line stations.

One of Newbold's biggest advantages is its location. It's just south of Center City and adjacent to popular neighborhoods such as East Passyunk, Passyunk Square, and Point Breeze.
