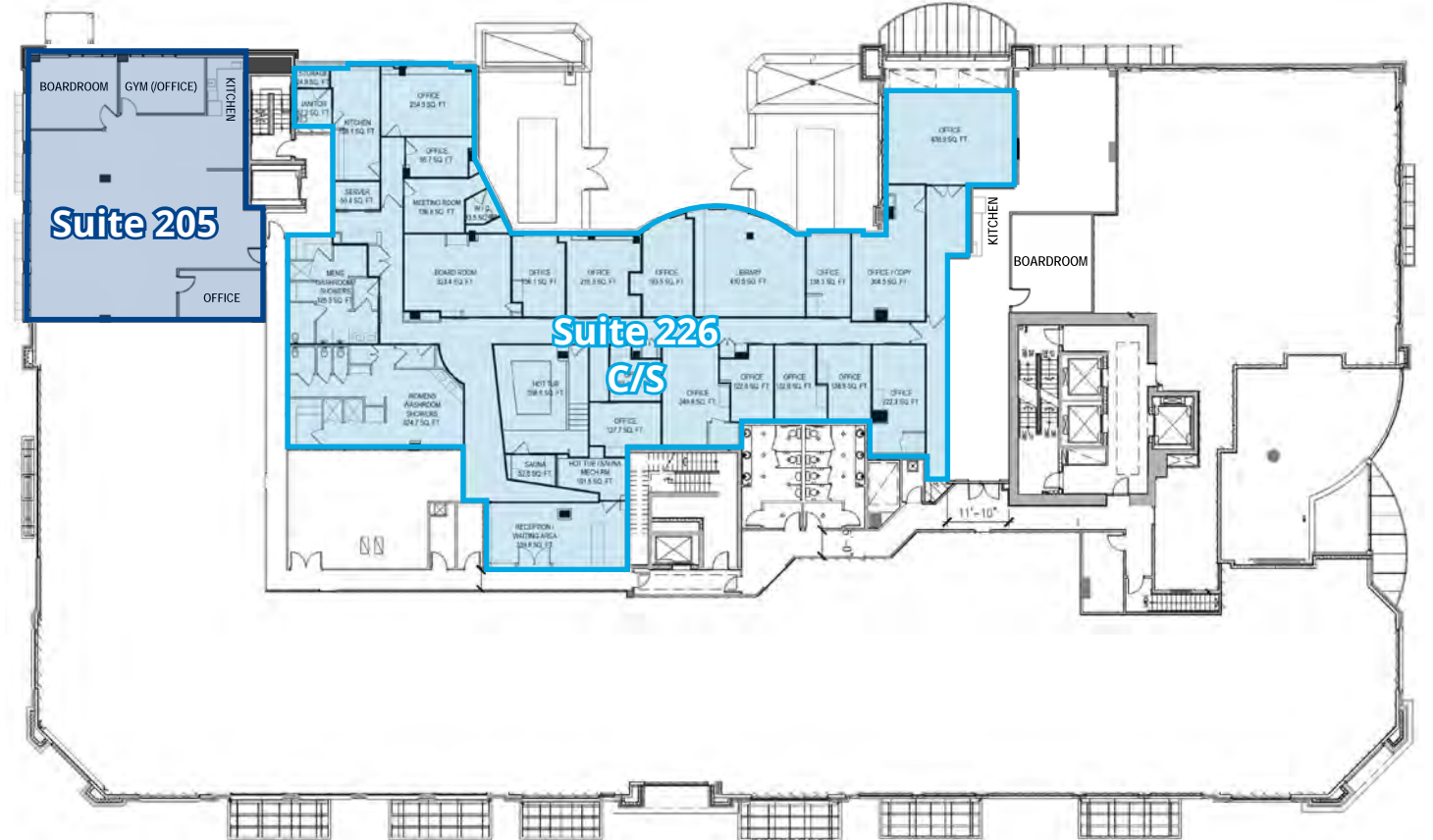

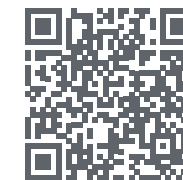


Floor Plan
