



Lyon county, located southwest of the Reno/Sparks region, is home to ± 51,579 residents and has grown over 49% in the past two decades. With limited development opportunities remaining in Washoe, Carson City, and Douglas counties, Lyon county has been a target for home builders to provide housing to residents relocating to northern Nevada.

Dayton sits at the western border of Lyon County along Hwy. 50 between Carson City and Stagecoach. The area provides easy access to the Tahoe Reno Industrial Center (TRIC) via USA Pkwy. The Carson River runs throughout Dayton from Carson City to Lake Lahontan in Silver Springs

Visiting Dayton

The Dayton Valley is home to a multitude of recreational and historic destinations. The area features Dayton Valley Golf Club designed by Arnold Palmer and is the home to the longest running PGA Tour Qualifier. Lake Lahontan is a summer destination for water sports and fishing throughout the year. The Sutro Tunnel is a historic mining tunnel completed in 1878 continually preserved by The Friends of Sutro Tunnel society and available for guided and private tours.
