The 28,088 SF freestanding building features a balanced mix of anchor and complementary retail users with independent utilities and efficient operating structure, minimizing landlord responsibilities.

Strategically positioned in a high-visibility commercial corridor between New York City and Boston, and within close proximity to Yale University and Yale New Haven Hospital, the property benefits from sustained regional demand drivers and strong market fundamentals. This offering represents an opportunity to acquire a turn-key asset with secure income, long-term lease stability, and favorable market positioning.

LOCATION DESCRIPTION

469 East Main Street is strategically located in Branford, Connecticut along the highly visible Route 1 corridor with immediate access to two Interstate 95 interchanges, providing direct connectivity to New Haven, the Connecticut shoreline, and the greater New York and Boston metropolitan markets. The property sits within New Haven County, one of the region's strongest economic hubs, and benefits from close proximity to Yale University and Yale New Haven Hospital, both major employment and traffic generators. Positioned adjacent to the fully developed Branford Business Park, the site is surrounded by established commercial users and light industrial operations, creating consistent daily traffic and strong area synergy. The location offers excellent regional accessibility while maintaining convenient access to the shoreline demographic and surrounding professional communities.


