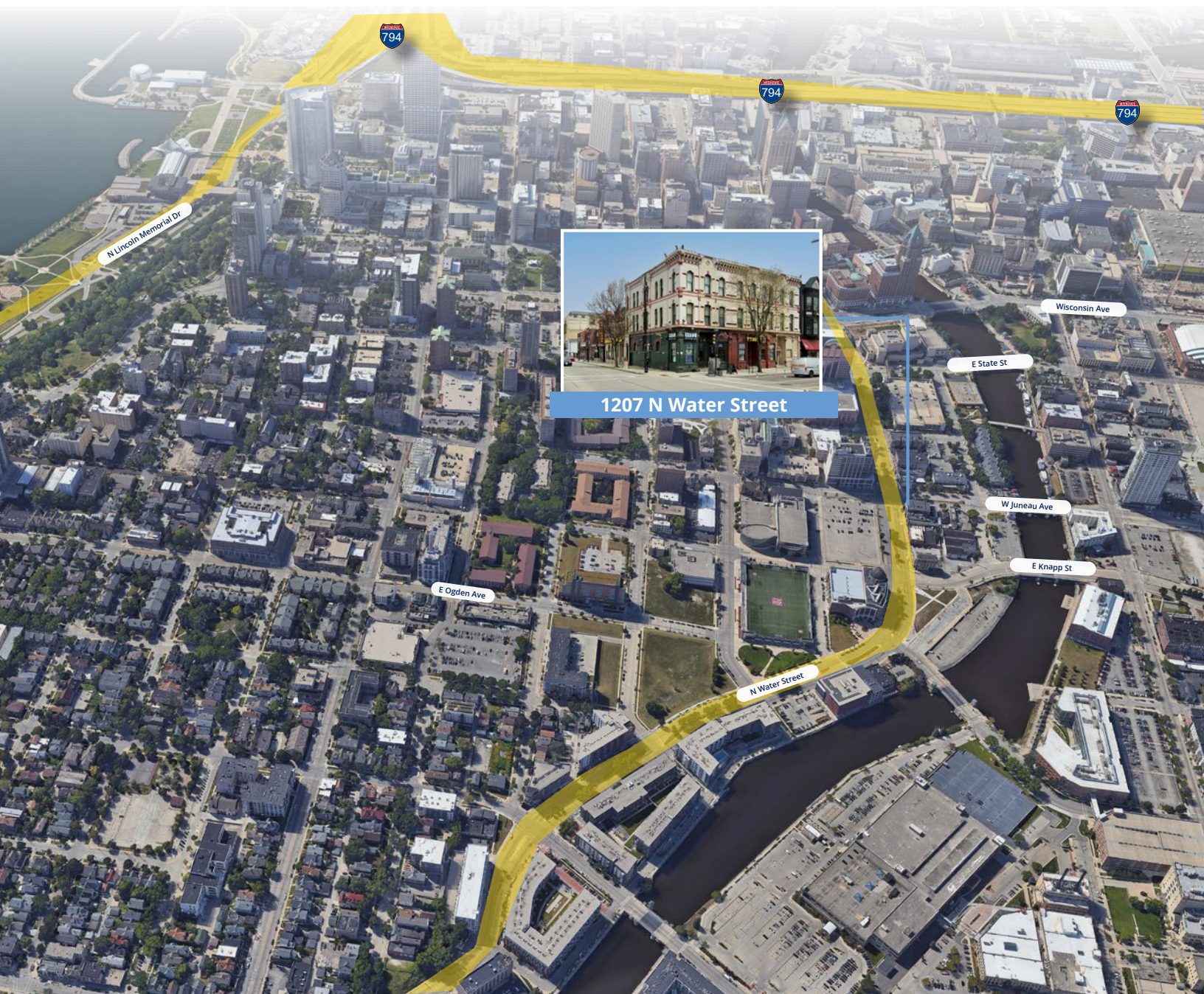

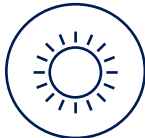


2023 Demographics - 1, 2, 3 Mile Radius

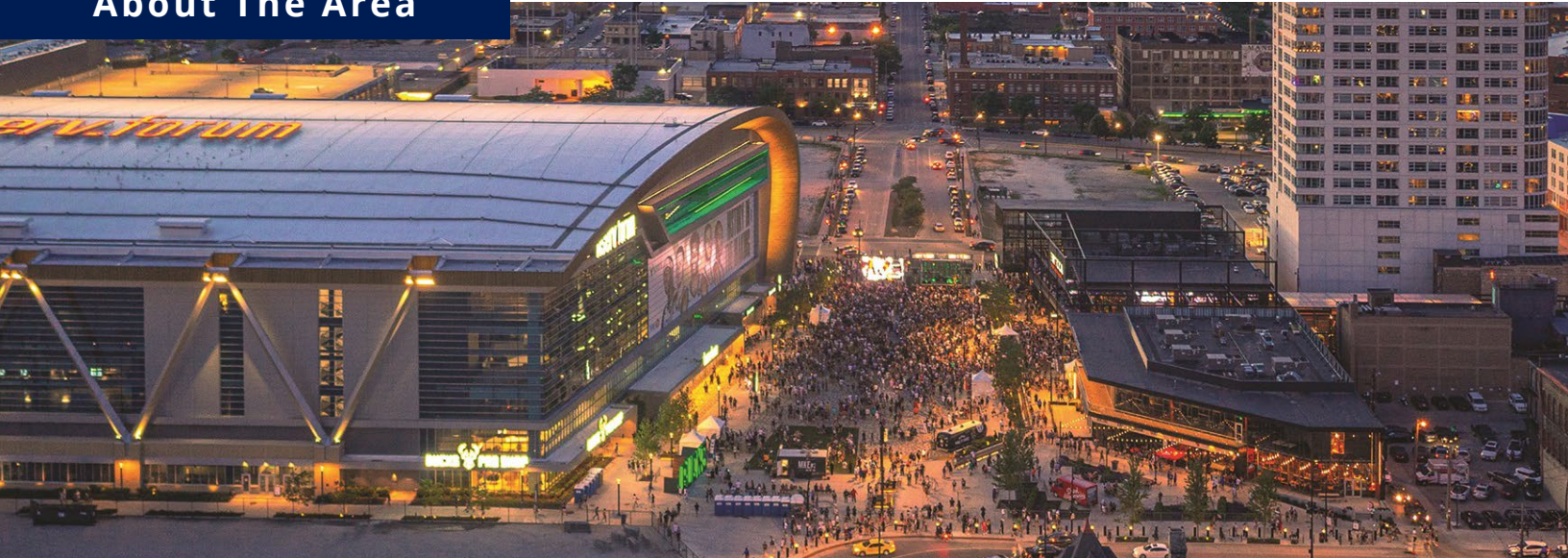

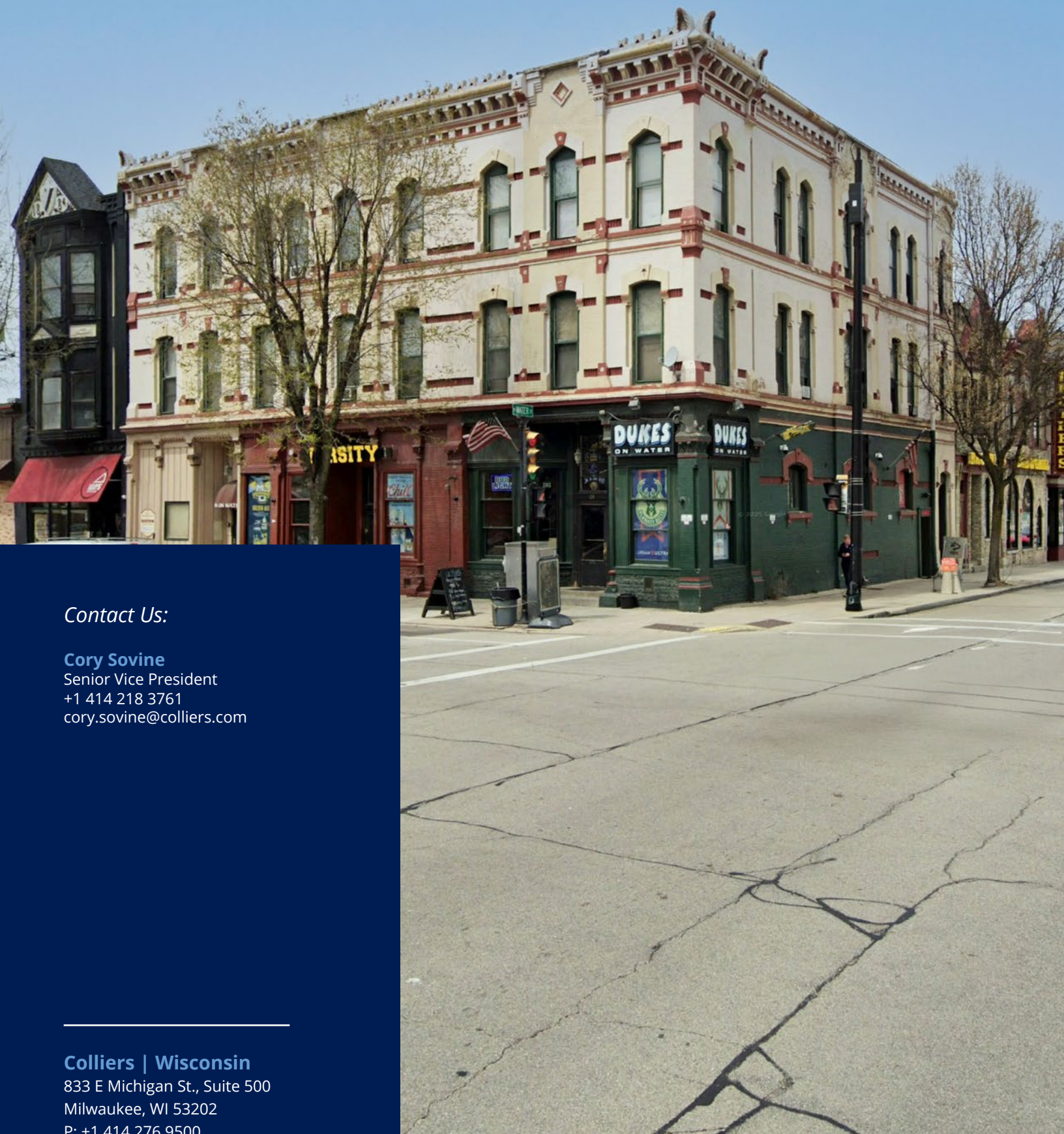


Downtown Milwaukee

Downtown Milwaukee has quickly become a hotspot for sports and entertainment alike. This is thanks to such ventures as the revitalization of Grand Avenue Mall, now The Avenue MKE, which utilizes the upscale food hall concept, Modern office suites and high end residential units. The 2021 NBA Championship team the Milwaukee Bucks recently completed construction on the key component of a transformational entertainment hub in downtown Milwaukee. The \$1 billion development package, named Deer District, includes a \$524 million arena and an additional \$500 million in mixed-use development. The 700,000 SF arena, Fiserv Forum, seats 17,000 with an adjacent 60,000 SF public plaza utilized as a live entertainment space with a beer garden and restaurants including Punch Bowl Social, Good City Brewing and Mecca Sports Bar. In recent news, a local developer has announced plans for an 11-acre development know as "The Iron District" on the South end of downtown near the Menomonee Valley just to the west of I-43. This new entertainment complex will include a professional outdoor soccer stadium, a concert venue, an upscale hotel and new restaurants – all of which will further bolster the already booming downtown area while solidifying Milwaukee as a hub for sports and entertainment.
