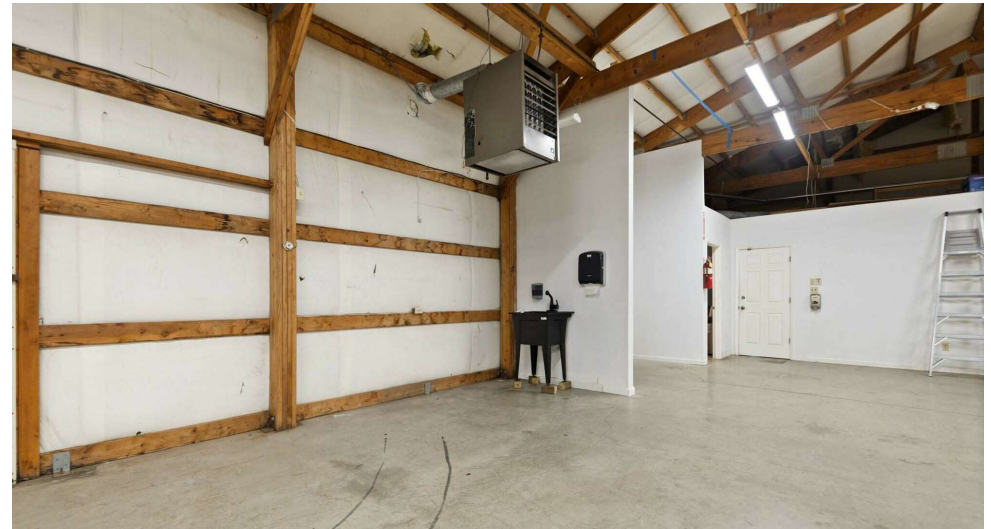
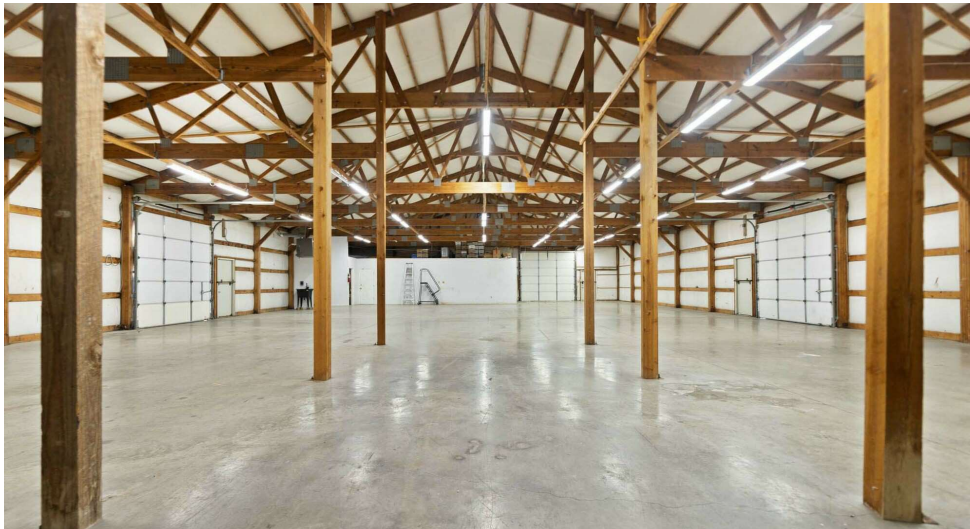

PROPERTY AERIAL

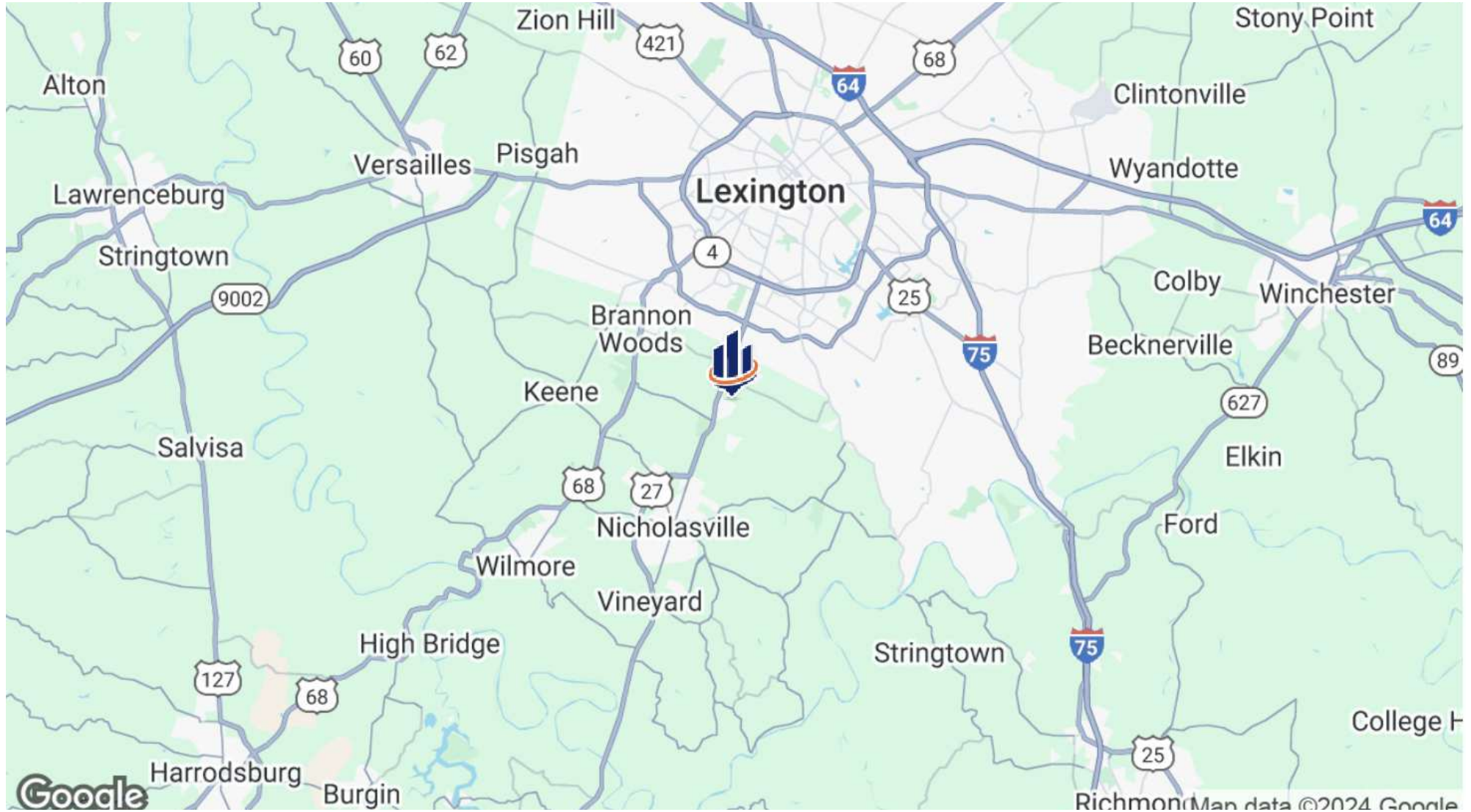
