Old City Height Districts - 3

The Old City Height District (is comprised of several height district classifications and includes all of peninsular Charleston lying south of Mt. Pleasant St and the extension thereof across the entire peninsula, the Magnolia redevelopment area (west of I-26, South of Hagood Rd and about 400' north of Mechanic St), and portions of West Ashley Albemarle area (generally within the area bound by Hwy 17, Ashley Point Drive/SC 30 ramp and Albemarle Rd). Certain height districts in the Old City Height District have minimum and maximum height requirements and some have additional building setback requirements.

The AR Overlay Zone applies to all areas of peninsula section of the city as bounded by the Ashley River, the Cooper River and Charleston Harbor

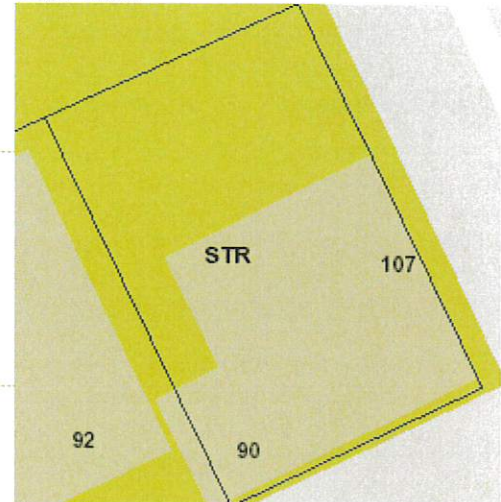

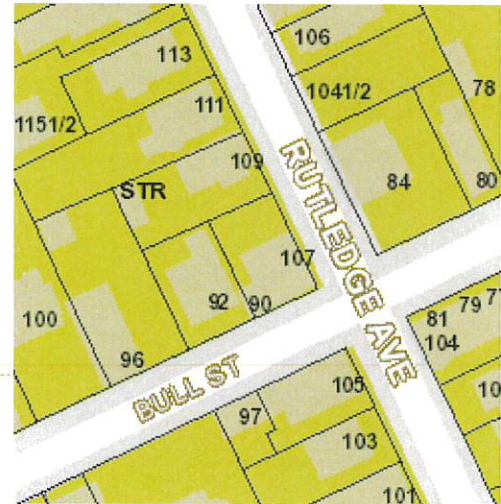

Area Overview:



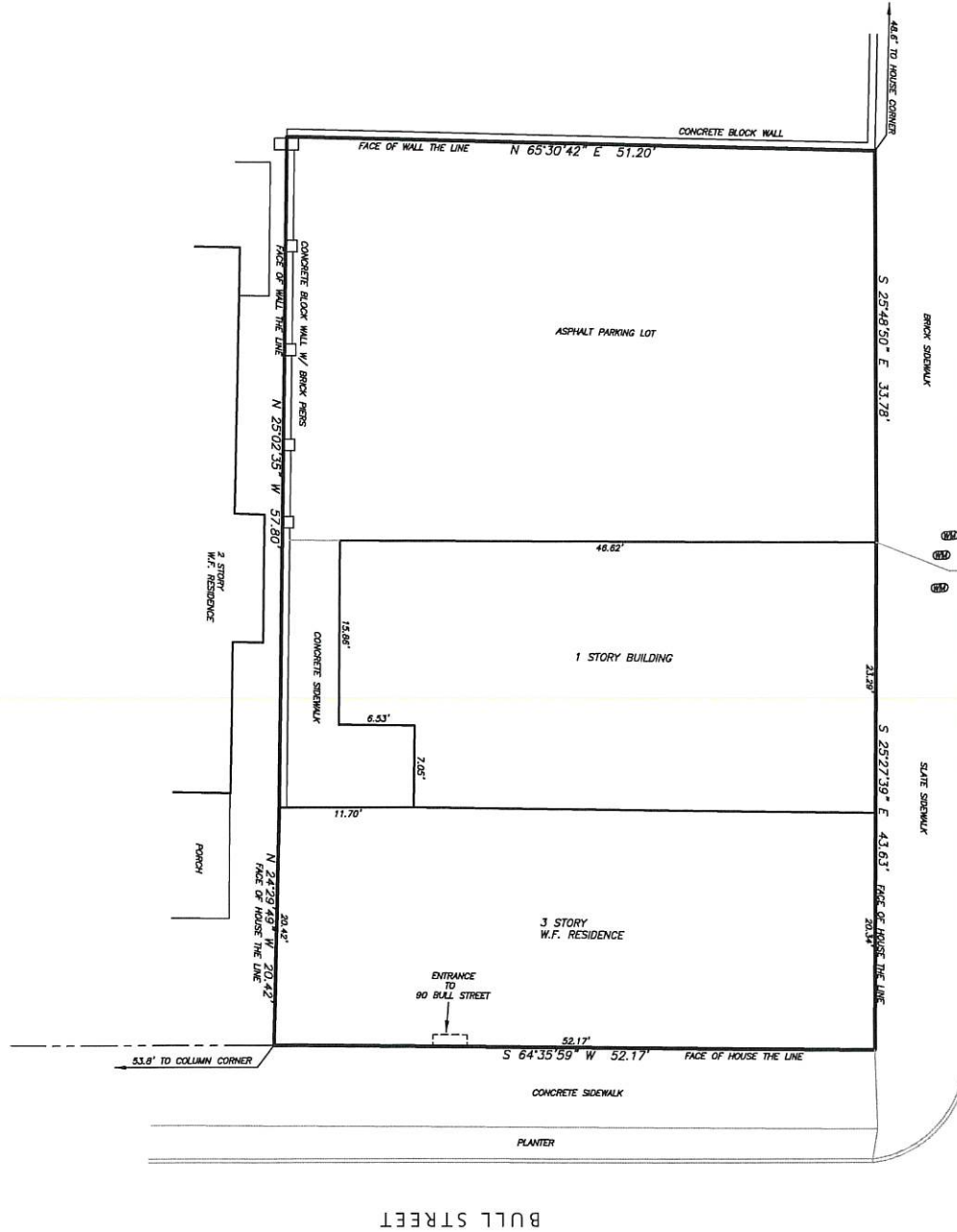
