The subject building formerly housed an ambulatory surgery center that was constructed in 2005. The building features a state-of-the-art architectural design including three fully functioning medical/dental operatories, pre-op and post-op facilities, reception, waiting and records management offices, administrative offices, multiple restrooms and an employee lounge. The entire facility is fully self-contained with electrical, data and telecommunications functions on-site. Ample parking is provided at over 5.2± spaces per 1,000± SF.

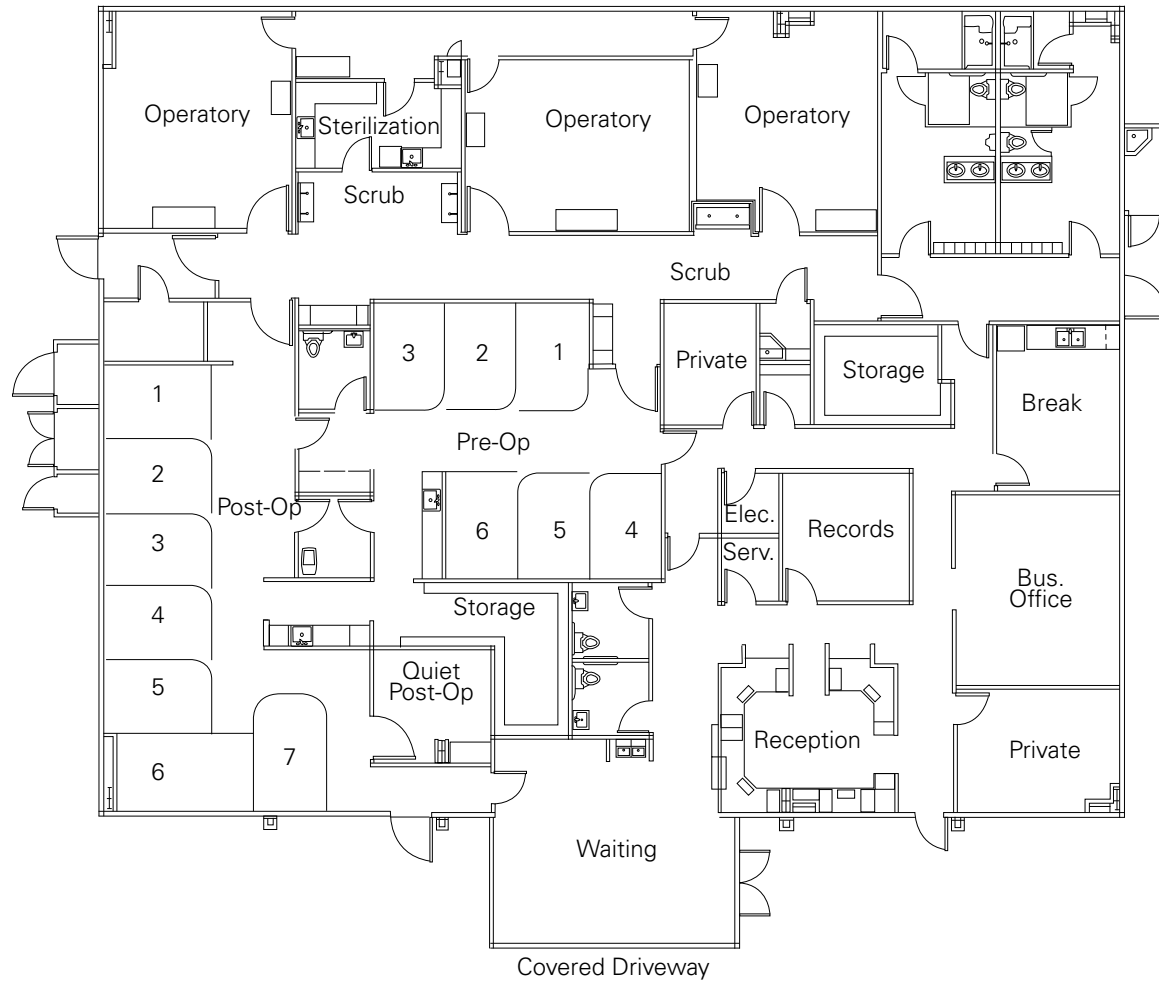
