BEGINNING at a 1 inch iron pipe found at the Northeast corner of said Tract II same being the Southeast corner of a tract of land described in deed to Tommy L. Caruthers, Sr. and Patricia Ann Caruthers, recorded in Instrument Number 2017-4934, Real Property Records, Denton County, Texas:
