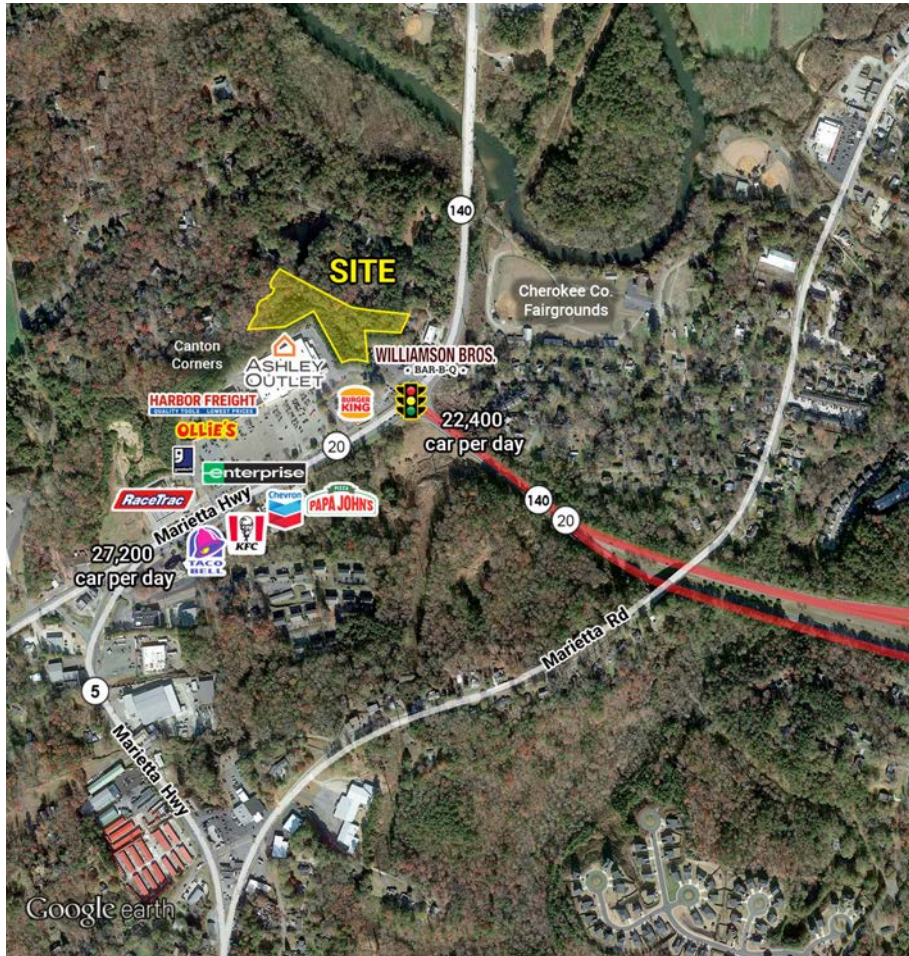

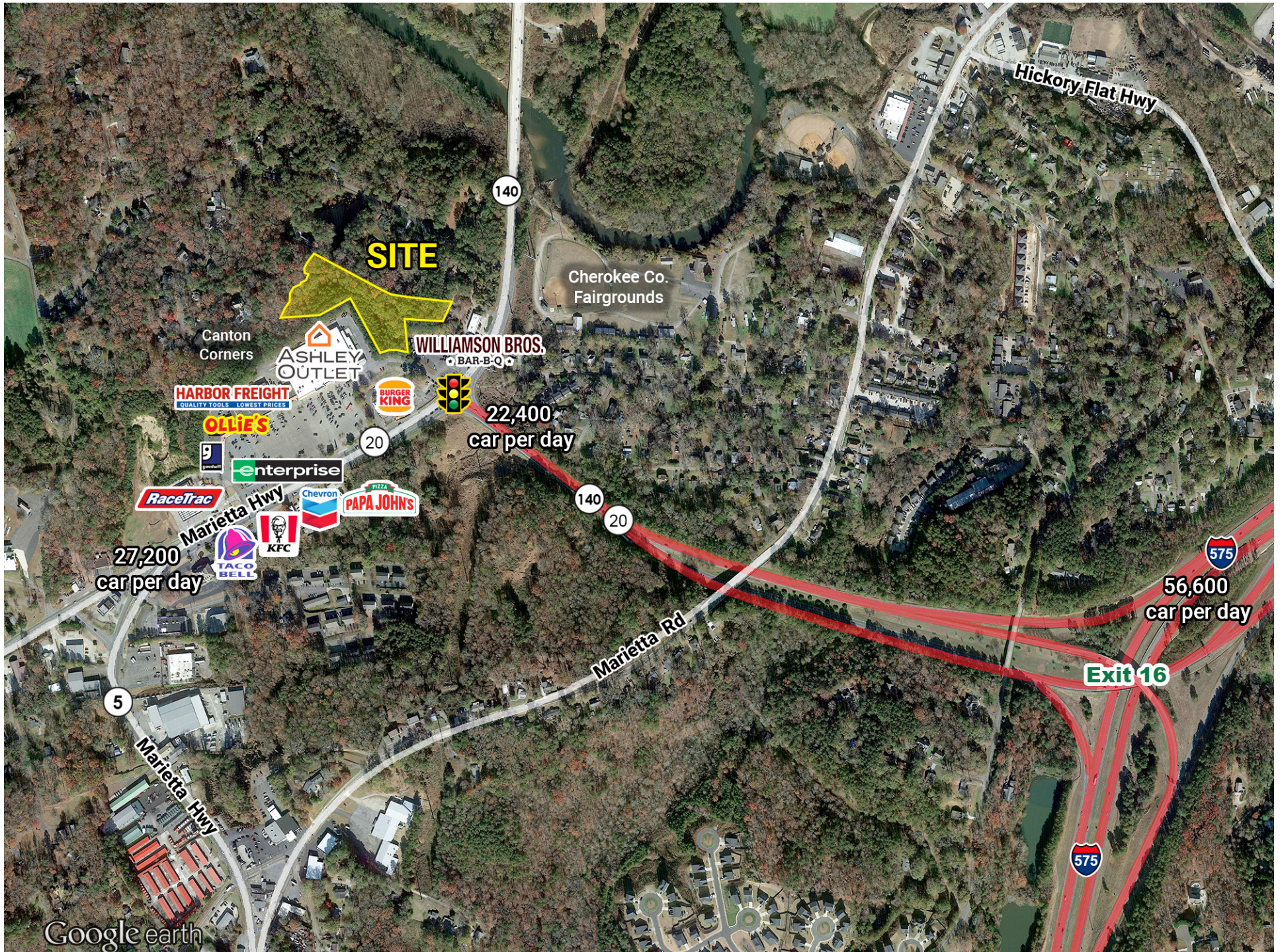

The Property is being offered at \$1,300,000 (\$396,341±/ac).

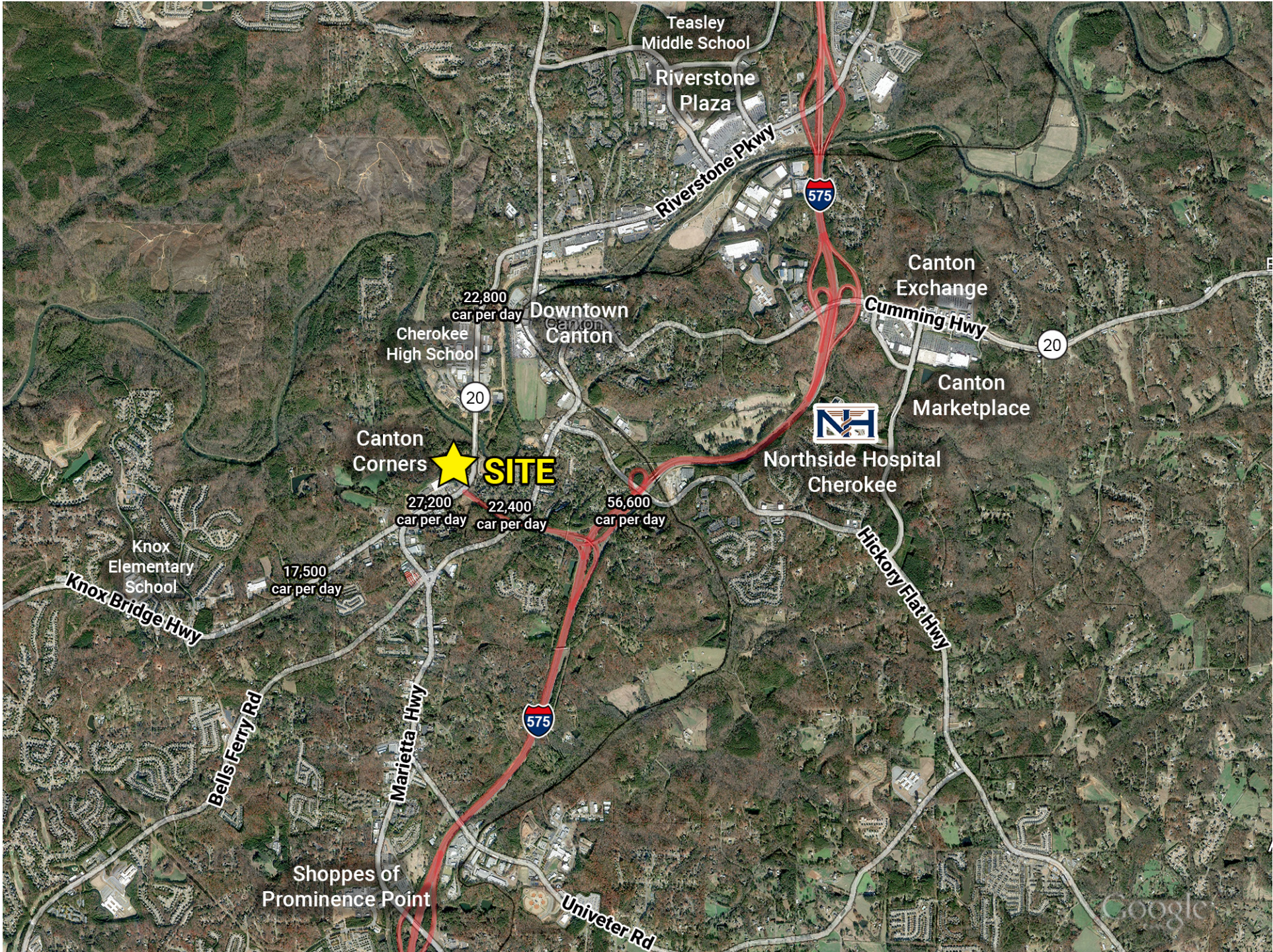

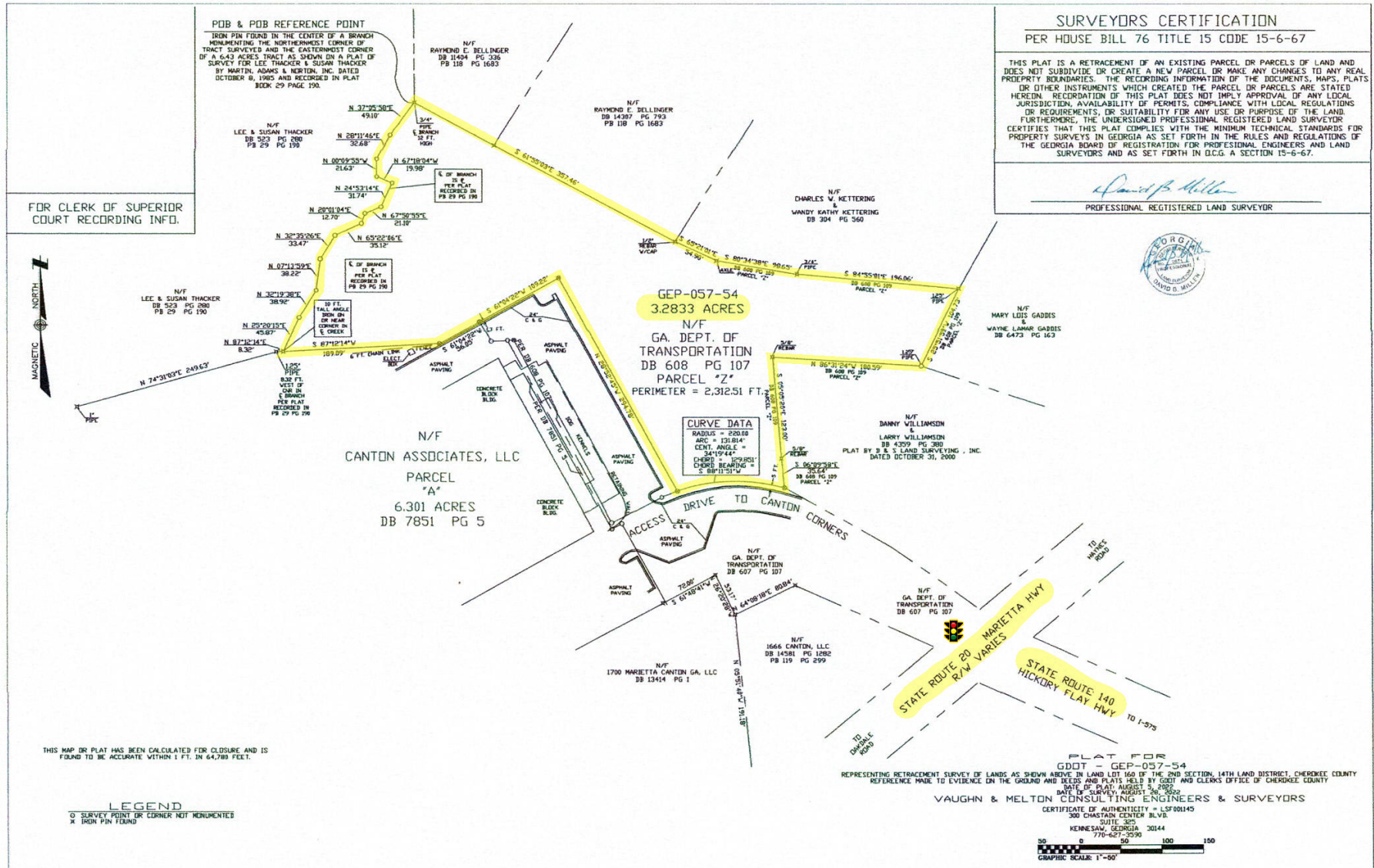

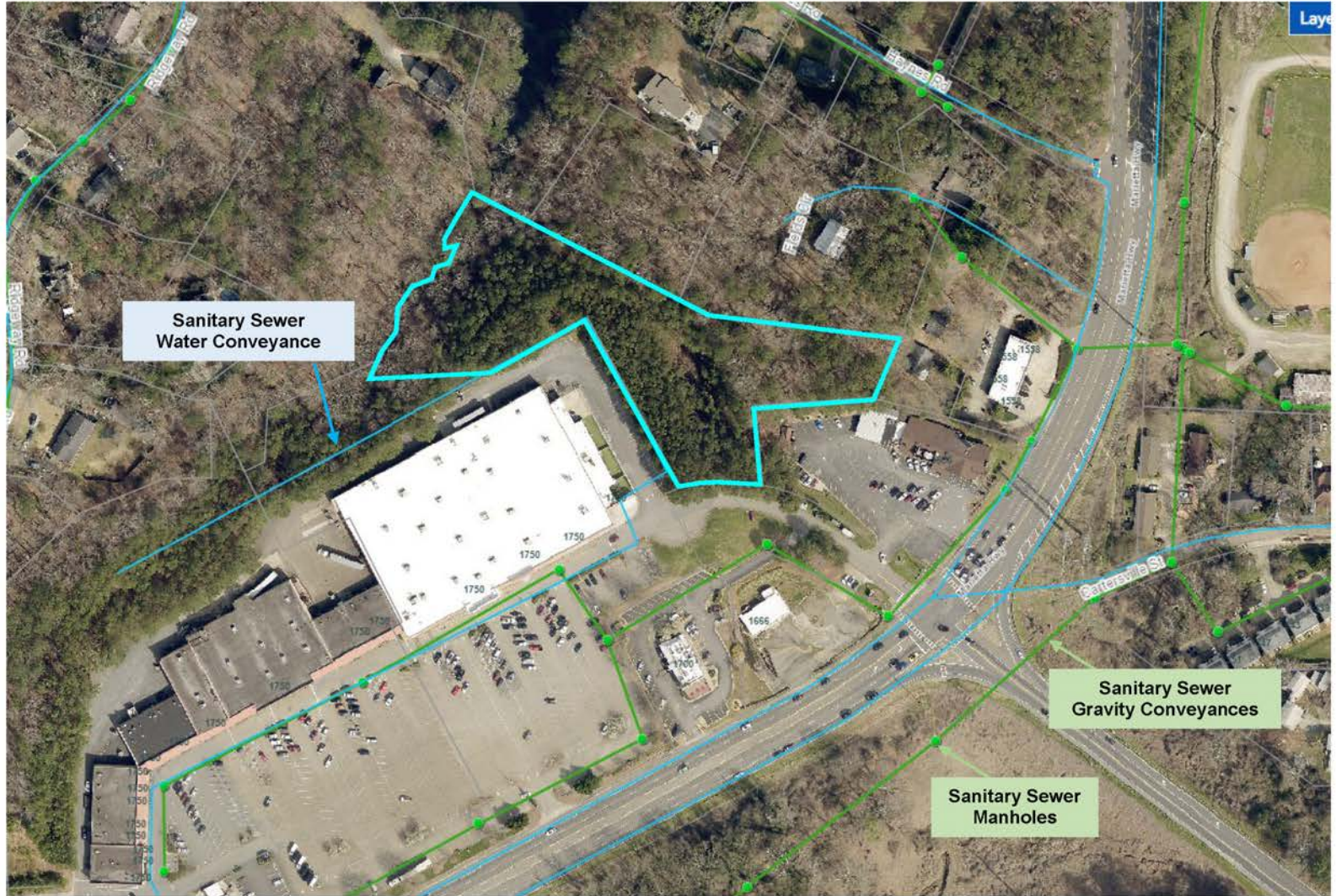




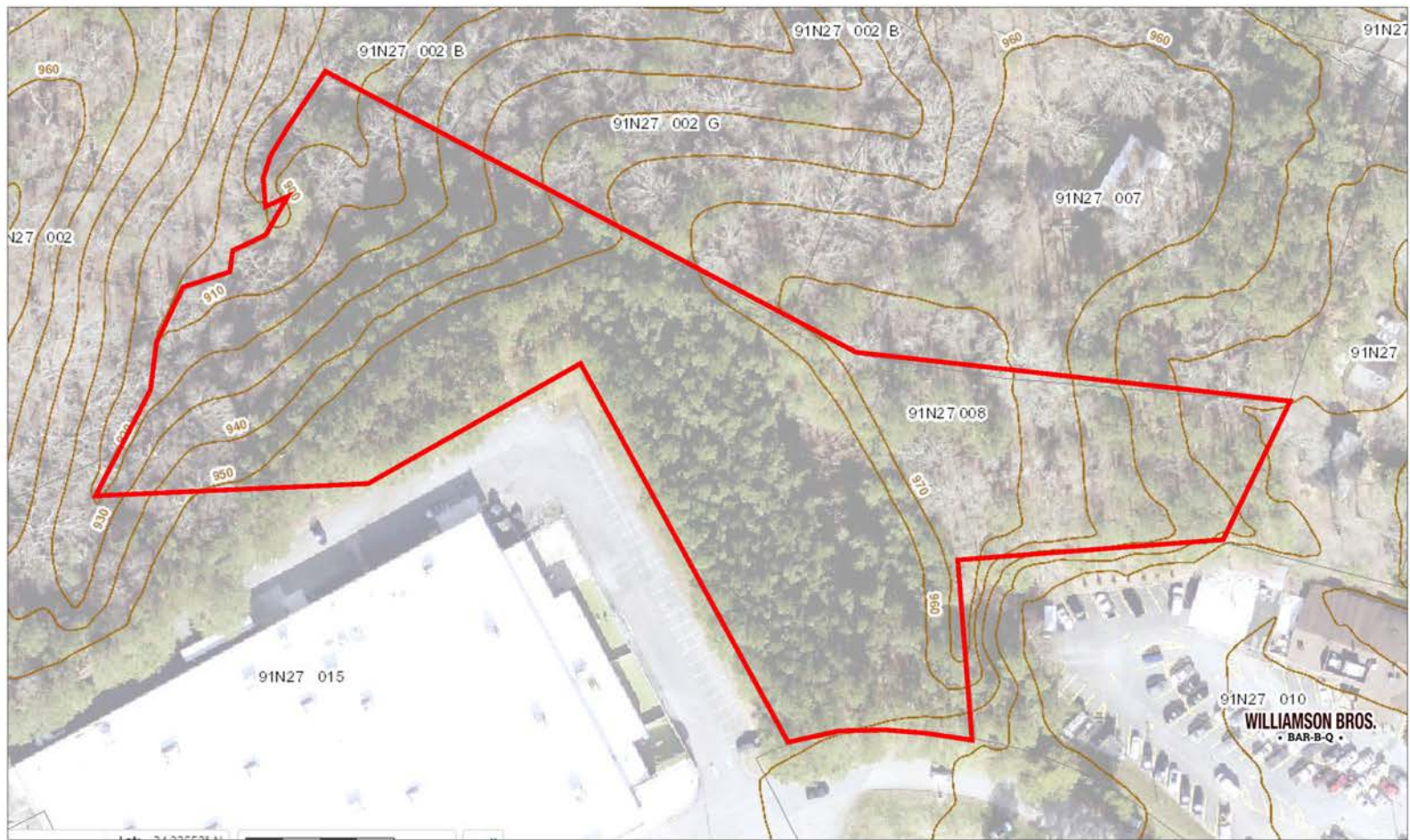
0 Marietta Highway – Future Land Use
