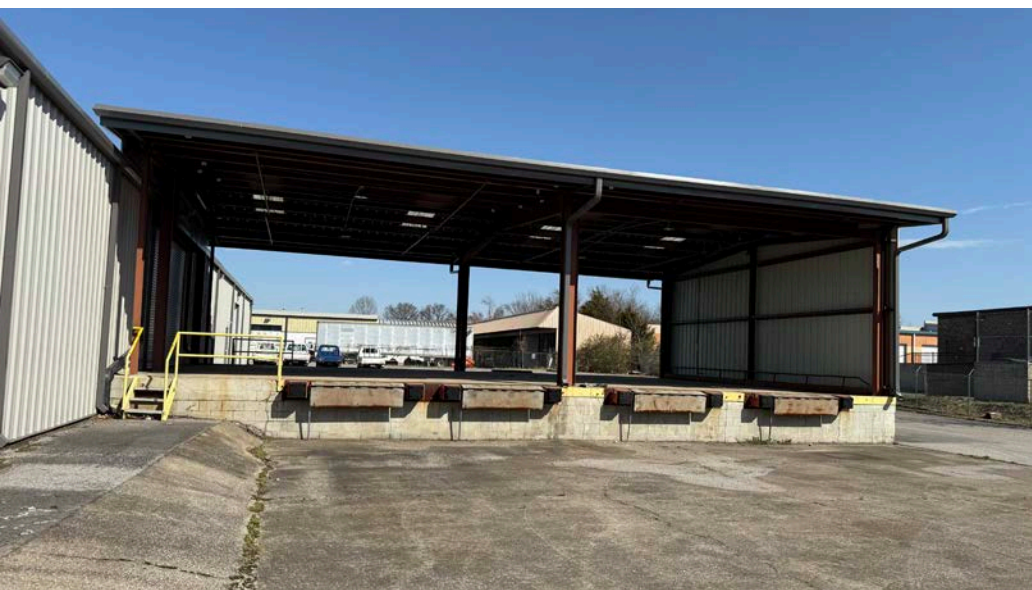

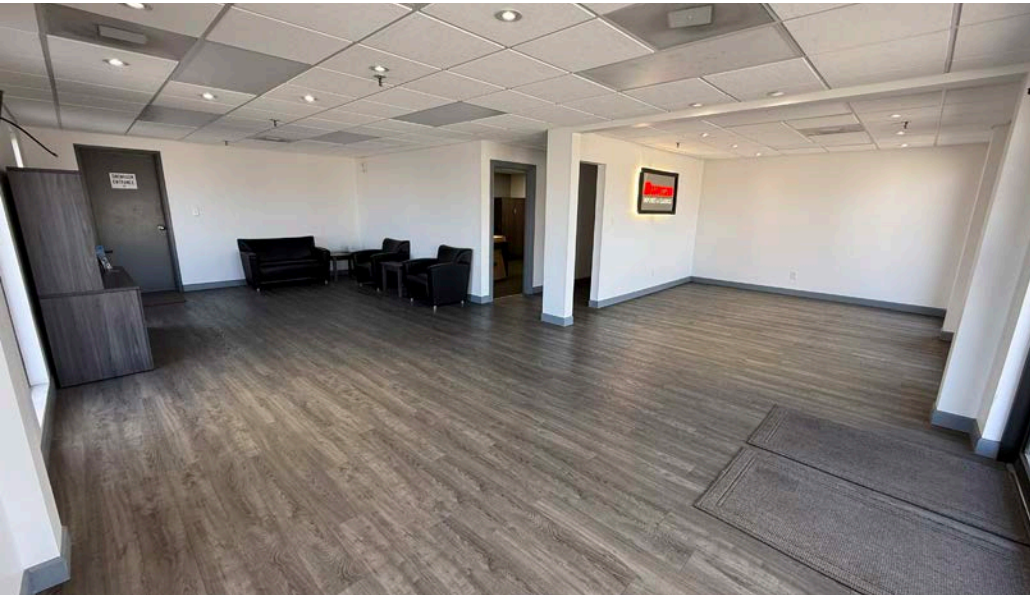

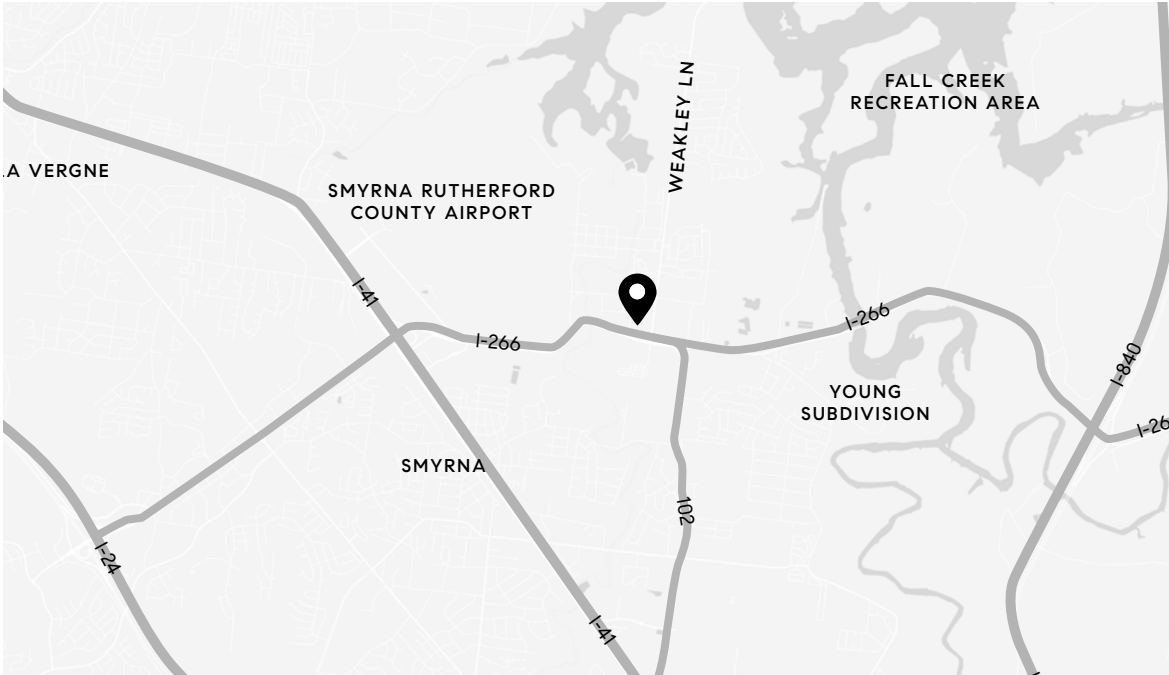
## 100 G STREET, SMYRNA, TENNESSEE

100 G St is a 40,500 SF industrial warehouse with 3,000 SF of office space, located in a heavily industrial area between I-24 and I-840. The 4.11-acre site features a rear-load configuration, clear-span layout, and full sprinkler coverage, along with 1.5 acres of fenced outdoor storage. The facility includes 9 drive-in doors, 1 oversized drive-in door, and an 8-dock pavilion with EOD levelers, providing flexible loading options.
