

executive summary

A fully restored 1898 Victorian Mansion on the National Historic Registry. Located in the Five Points Historic District, near the University of Alabama at Birmingham and 5 Hospitals, Five points is home to \pm 41 restaurants and evening entertainment venues.

- This 12,000 square foot Mansion has 4 stories (3 stories Bed & Breakfast, 1 story Art Studio).
- A total 10 Guest Rooms (4 suites (each sleeps 3-4) & 6 bedrooms (each sleeps 2)), 14 Bathrooms, and Owner's Quarters
- Its steep complex roof is adorned with numerous gables and decorative finales
- Wraparound veranda porch constructed of limestone with scalloped limestone porch enclosure
- All window lintels and sills are limestone, and it has a well-appointed brick exterior with joisted masonry interior
- The athenaeum in the pediment over the front door entry has elaborate scroll-work unique to the mansions of this neighborhood and time period
- The east side has a circular staircase between the 2nd and 3rd floors with the beautiful Victorian stained glass still intact with vivid gold, orange and blue colors, including a Heraldry theme in the central curved stained glass
- Eight (8) Victorian ornamental fireplaces and surrounds are present and 4 chimneys
- The building was restored in 2011 to 2013 under International Building Code standards with modern electrical, plumbing, and mechanical systems
- ±0.4 Miles from Highway 280
- ±1.3 Miles from I-65
- ±2.9 Miles from I-20
- ±7.5 Miles from the Birmingham Shuttlesworth International Airport

Birmingham is home to world-class medical research, a celebrated food and arts scene, and the Birmingham Civil Rights National Monument. 
Nestled at the foothills of the Appalachian Mountains, Birmingham boasts more green space per capita than any other city its size in the nation, with breathtaking locations from Ruffner Mountain to Railroad Park to the 2.2 mile Vulcan Trail at the foot of Vulcan Park and Museum. The city is home to Childrens of Alabama Indy Grand Prix in April, Birmingham Freedom Fest in the summer, great HBCU football in October featuring the Magic City Classic, and the Birmingham Bowl in December. The Mansion is 2 walkable blocks to the University of Alabama Birmingham, the State's largest employer with its 5 hospitals, 3 heliports, 4 million patient visits per year, a student body of 35,000 students, and rated in top 10 of National research institutions for Bio-Medical funding.

In June 2024, Birmingham will proudly host MLB at Rickwood Field: A Tribute to the Negro Leagues. The city-owned Rickwood Field is the oldest professional ballpark in the United States and former home of the Birmingham Black Barons of the Negro Leagues. The event will feature a special Regular Season game between the St. Louis Cardinals and San Francisco Giants!

Five interstates provide access to more than 80% of the U.S. population in a two-day drive. The Birmingham-Shuttlesworth International Airport offers 114 flights to 26 airports and 23 cities.







