Parcel Map



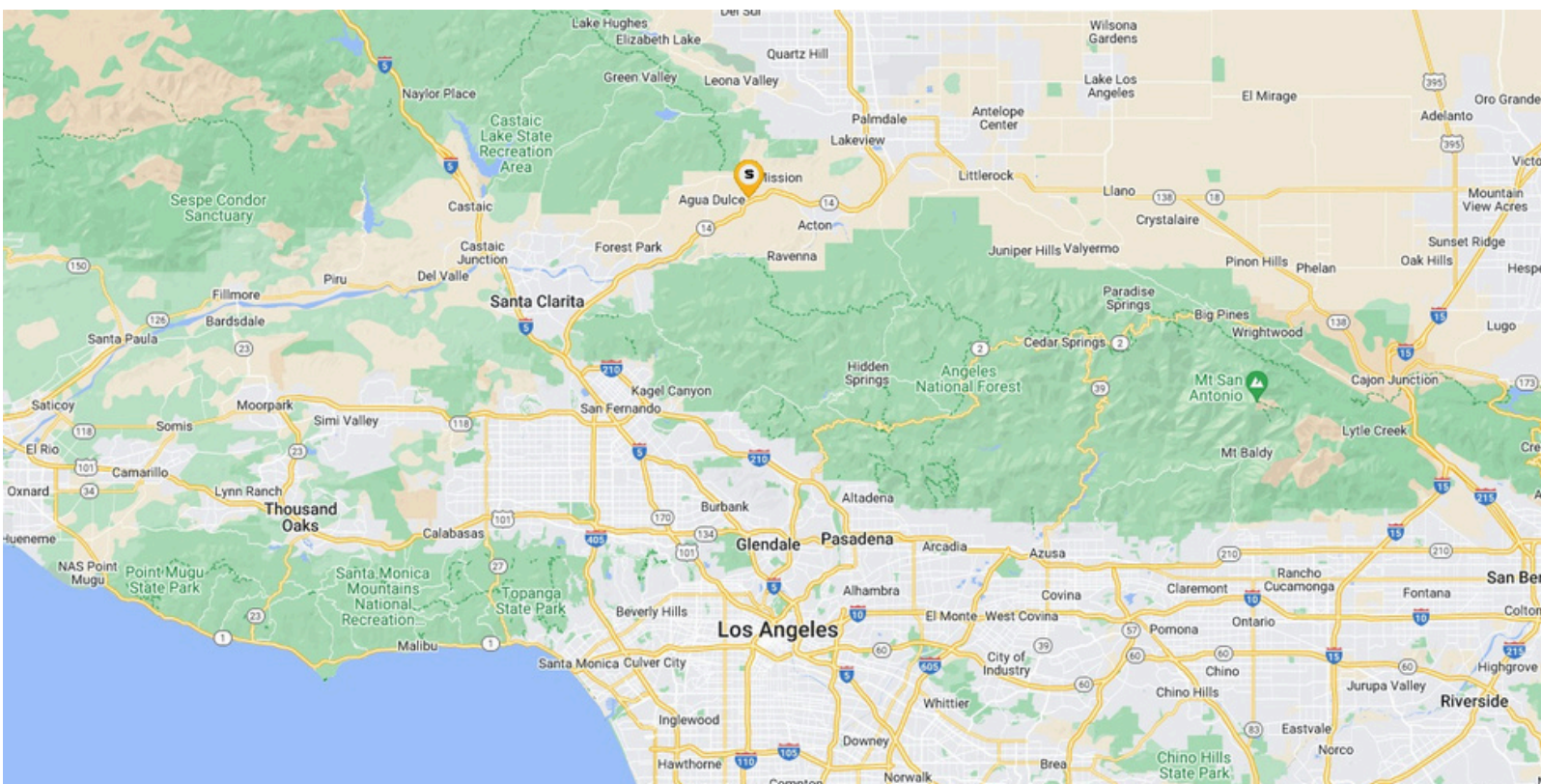
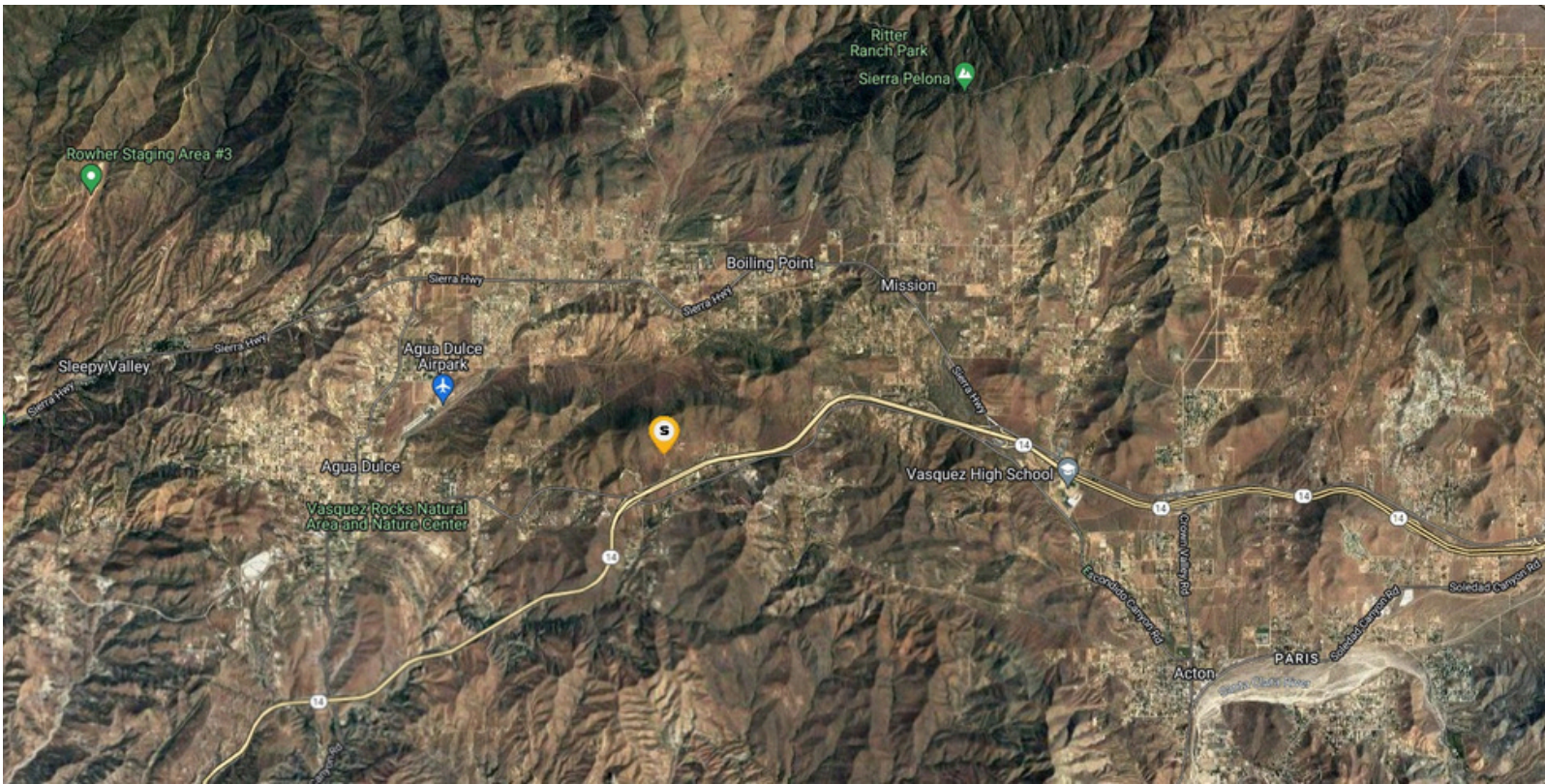
