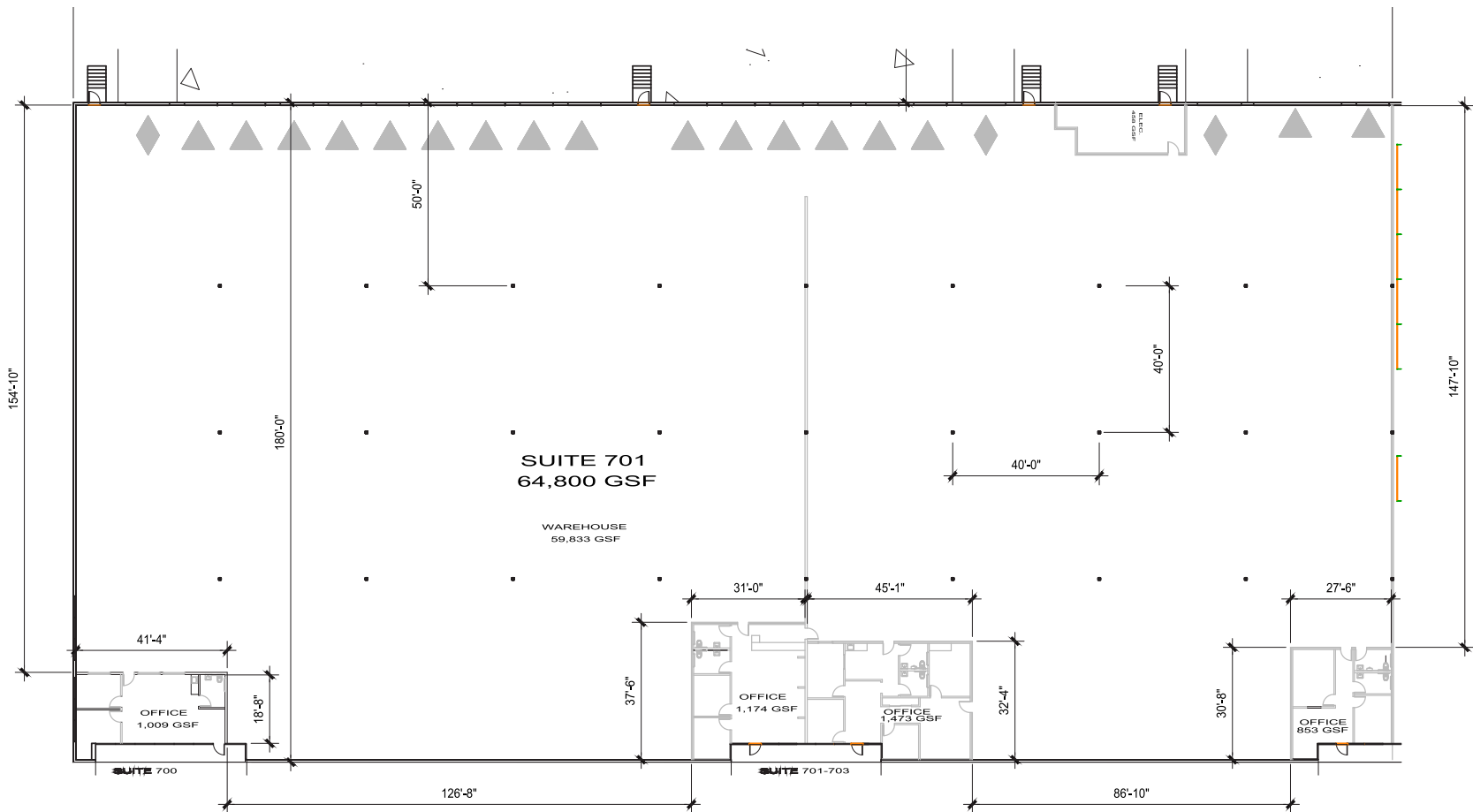
AREA DESCRIPTION
