The property is located at 809 Mitchell Street (Hwy 70) in Kinston, North Carolina off of West Vernon Avenue and Queens Street (Hwy 58).

Tenants in the immediate area include McDonalds, Dollar Tree, Auto Zone, Advance Auto, Bojangles, Piggly Wiggly, O'Reilly's, Little Caesars Pizza and First Citizen Bank. There are approximately 17,000 vehicles passing on Vernon Avenue daily.



## TENANT INFORMATION




On October 16, 2013 it was announced that Carquest would be acquired by Advance Auto Parts, Inc in an all-cash transaction estimated at approximately \$2 billion dollars. The deal was finalized on January 3, 2014. Carquest members now include Advance Auto Parts, Automotive Warehouse of Hawaii, CAP Warehouse of Nevada, and Muffler Warehouse of Idaho.

Advance Auto Parts, Inc. provides automotive replacement parts, accessories, batteries, and maintenance items for domestic and imported cars, vans, sport utility vehicles, and light and heavy duty trucks.

The company operates over 4,460 stores under the Advance Auto Parts and Carquest names, as well as branches under the Worldpac name. The company has stores in the United States, Puerto Rico, the U.S. Virgin Islands, and Canada; and independently owned Carquest branded stores in Mexico and various Caribbean Islands. Advance Auto Parts, Inc. was founded in 1929 and is based in Raleigh, North Carolina.
