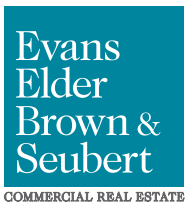
The lower level consists of kitchen area, fitness area with showers & bike storage space that can be shared with the existing tenant for an additional fee to be determined based on the amount of space shared.
