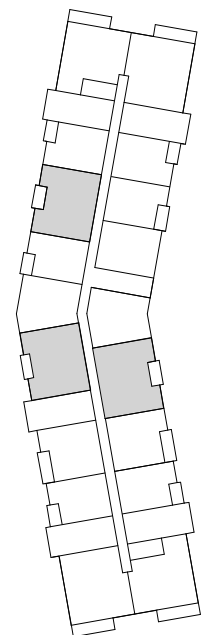
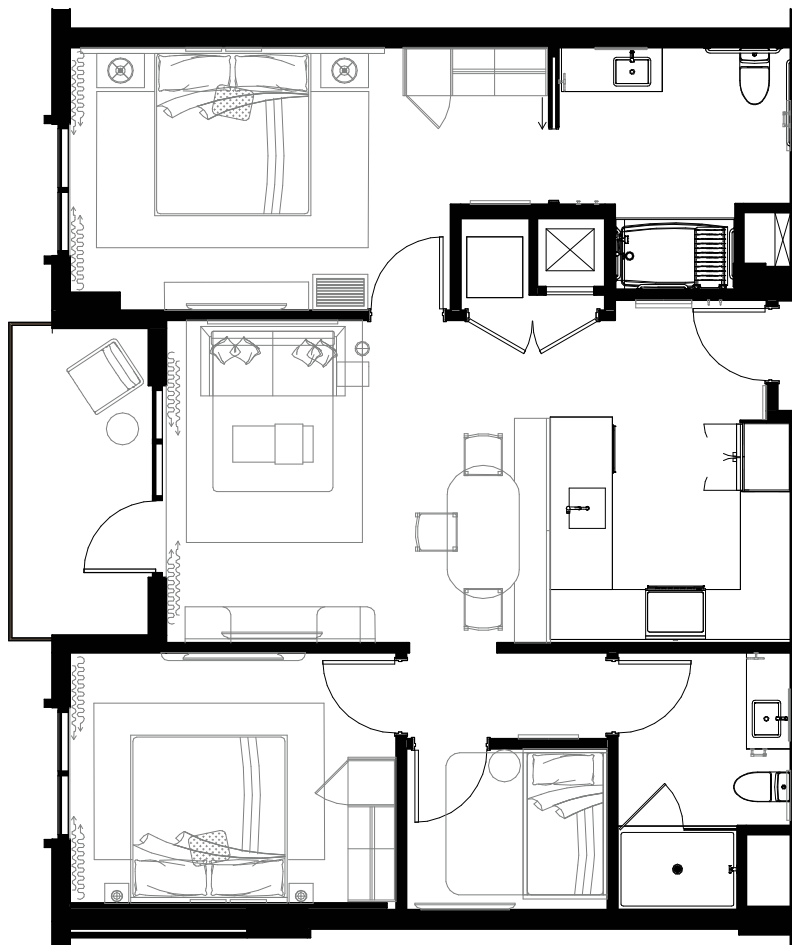
Residence B1 ADA - FLOOR PLAN
