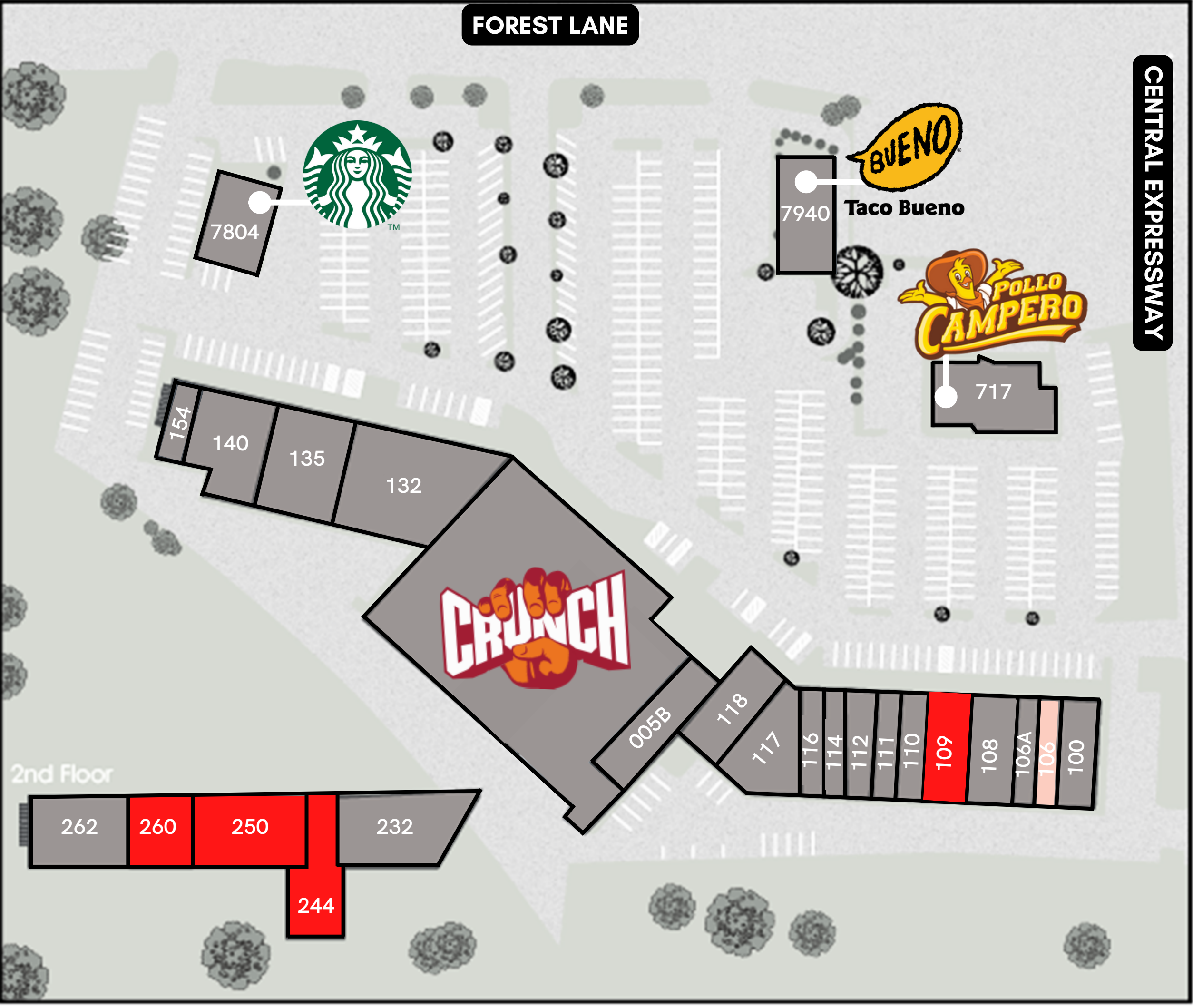

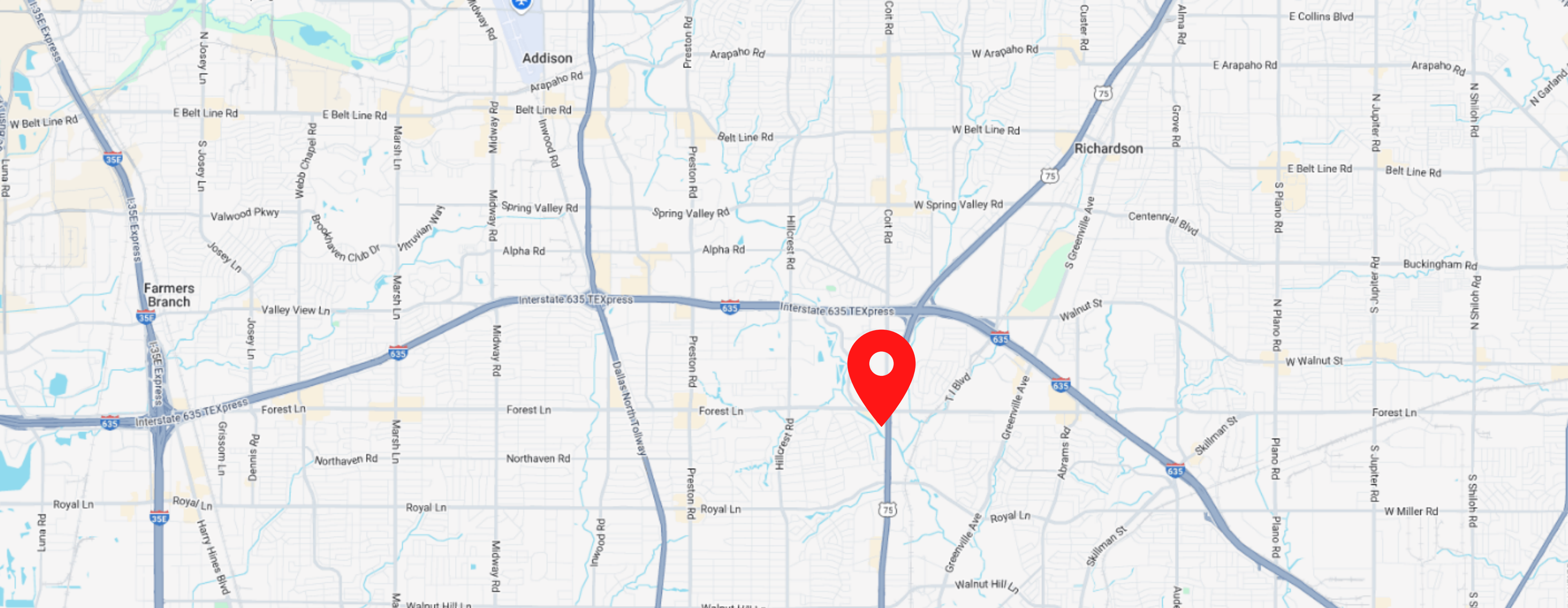


SITE PLAN
