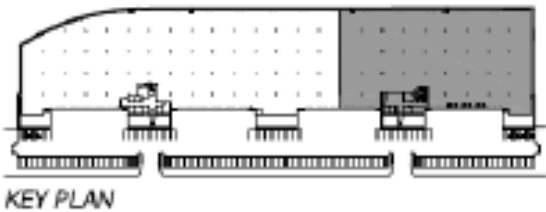

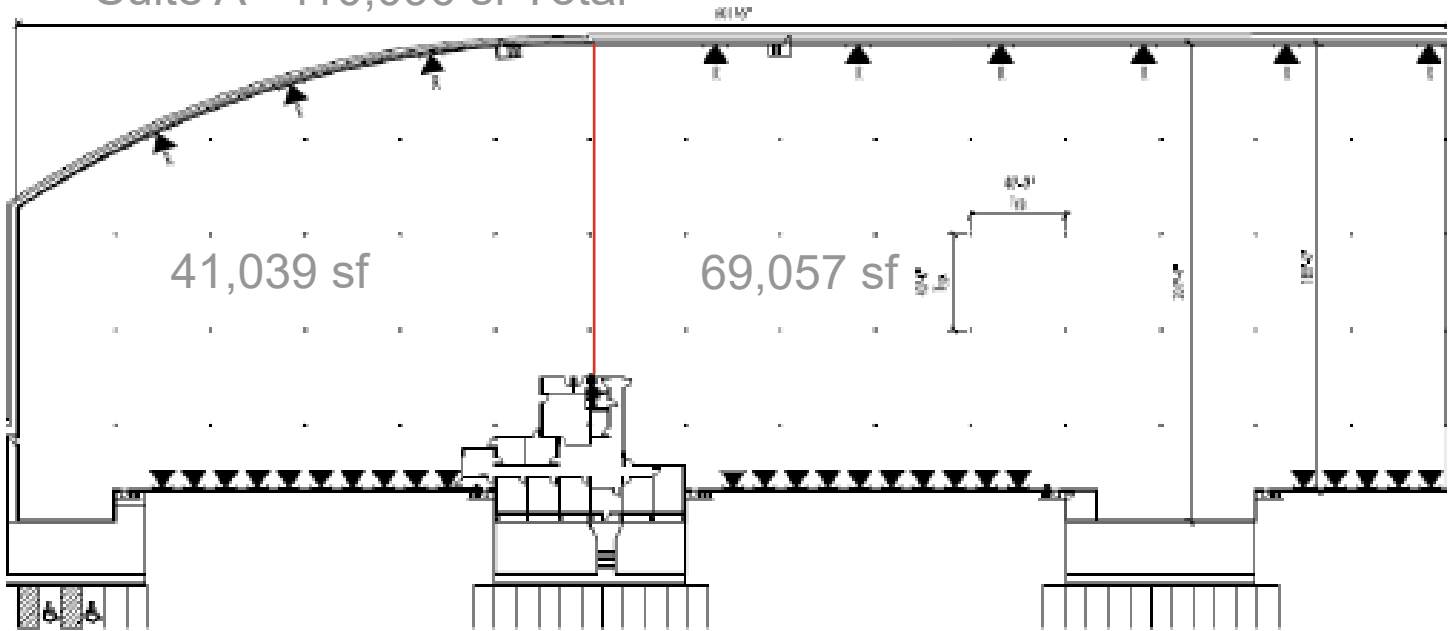

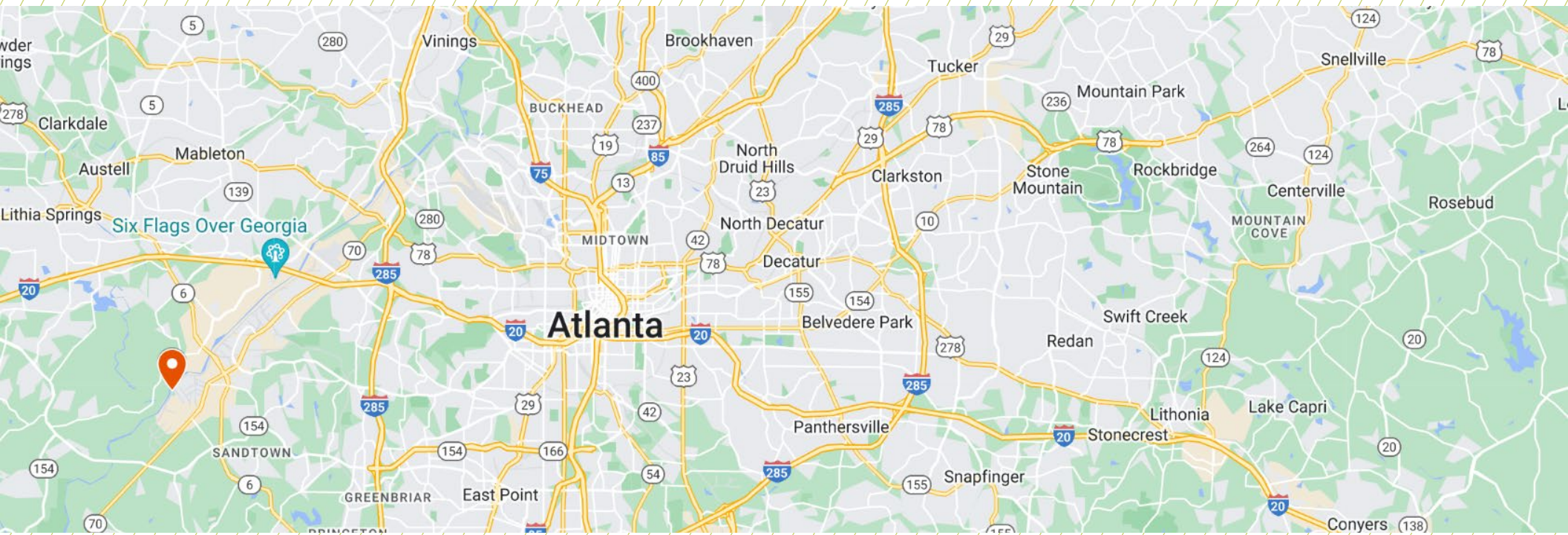




6255 BOAT ROCK BOULEVARD
