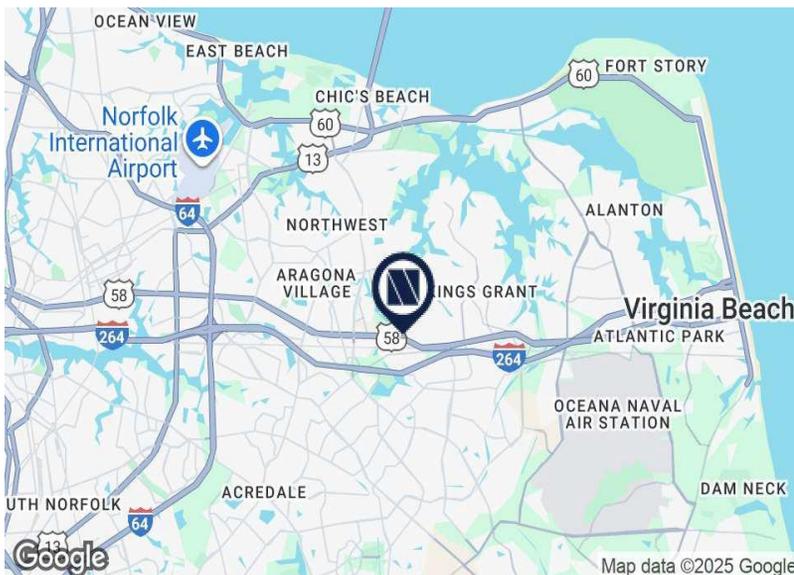

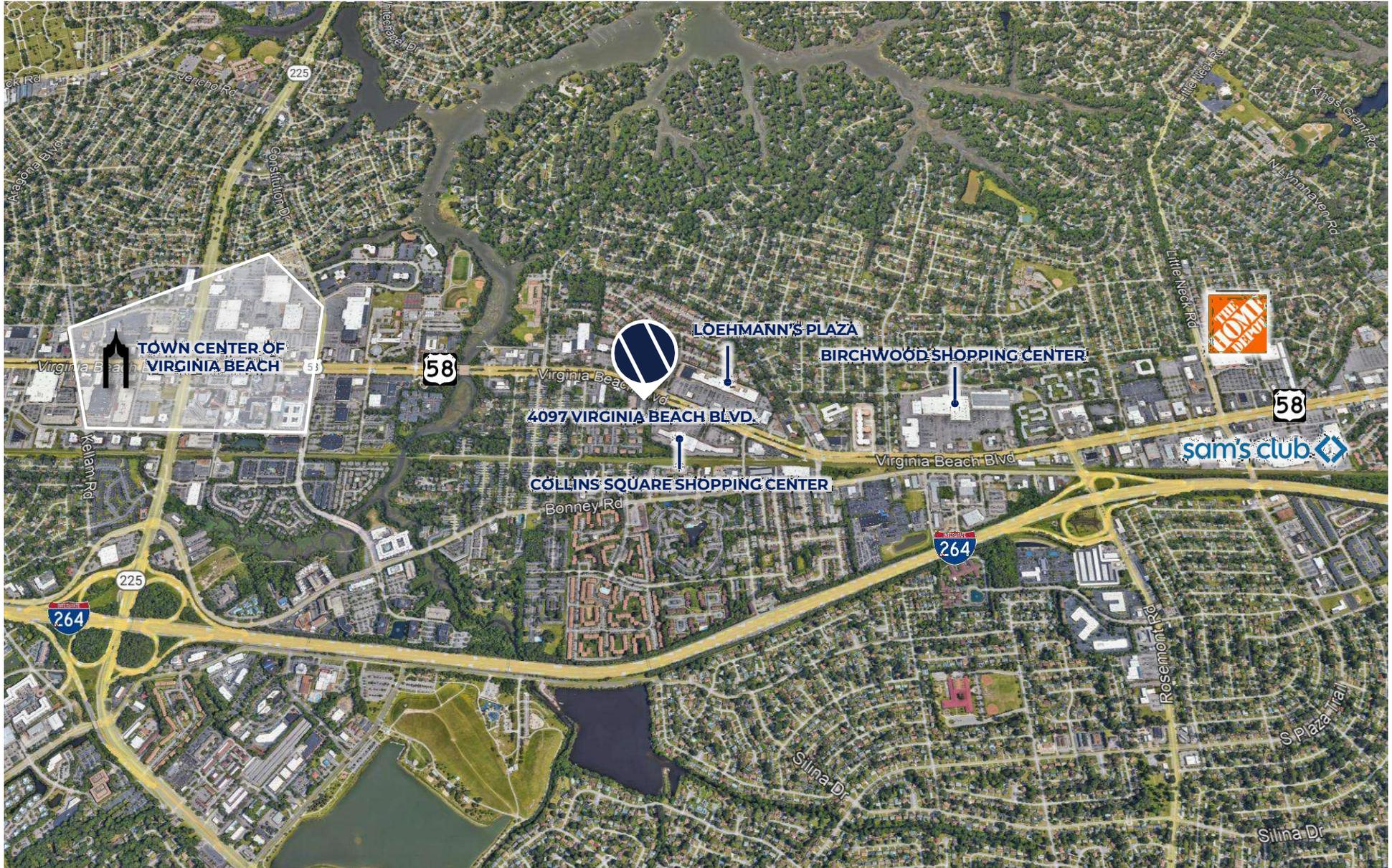


LOCATION MAP

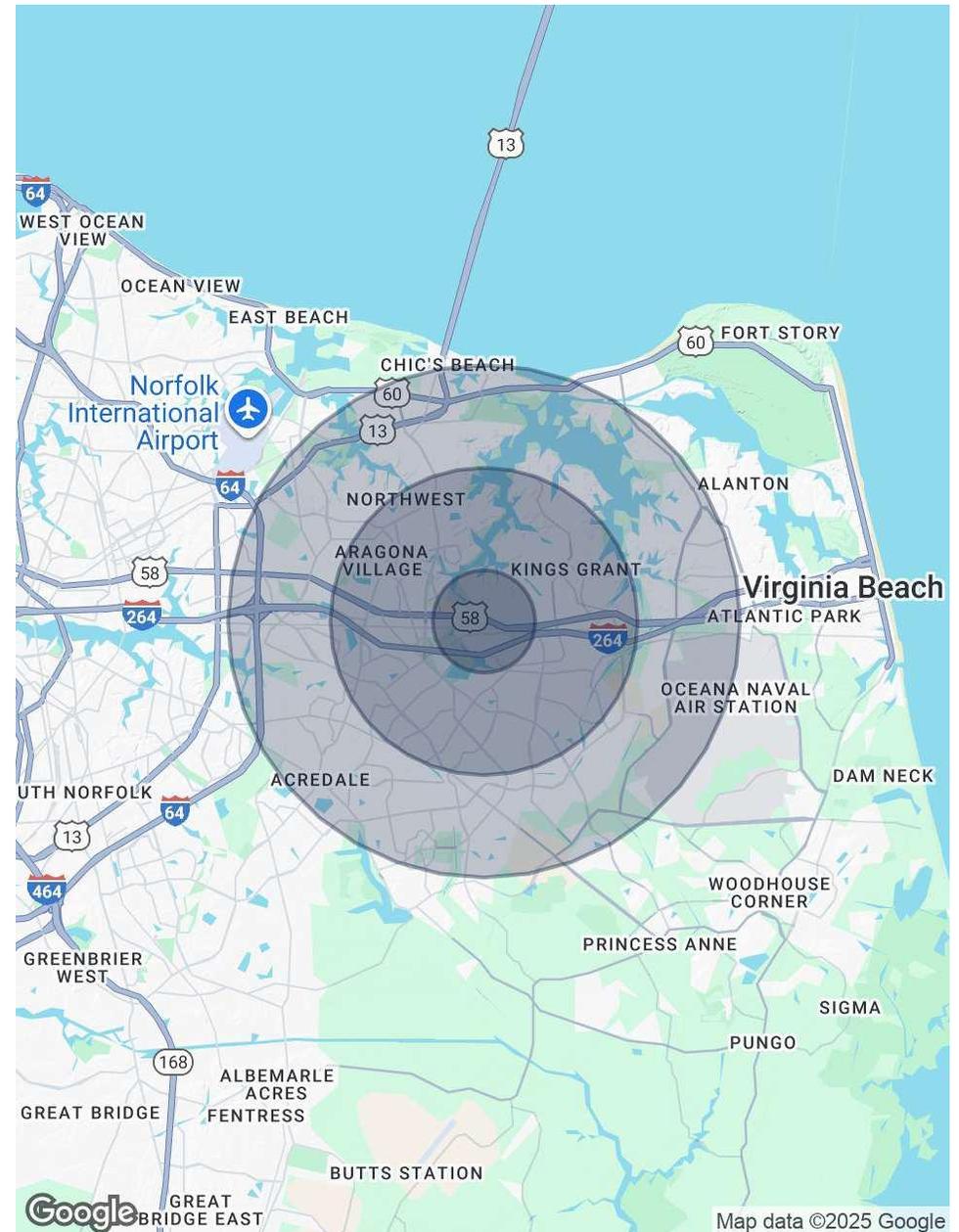
