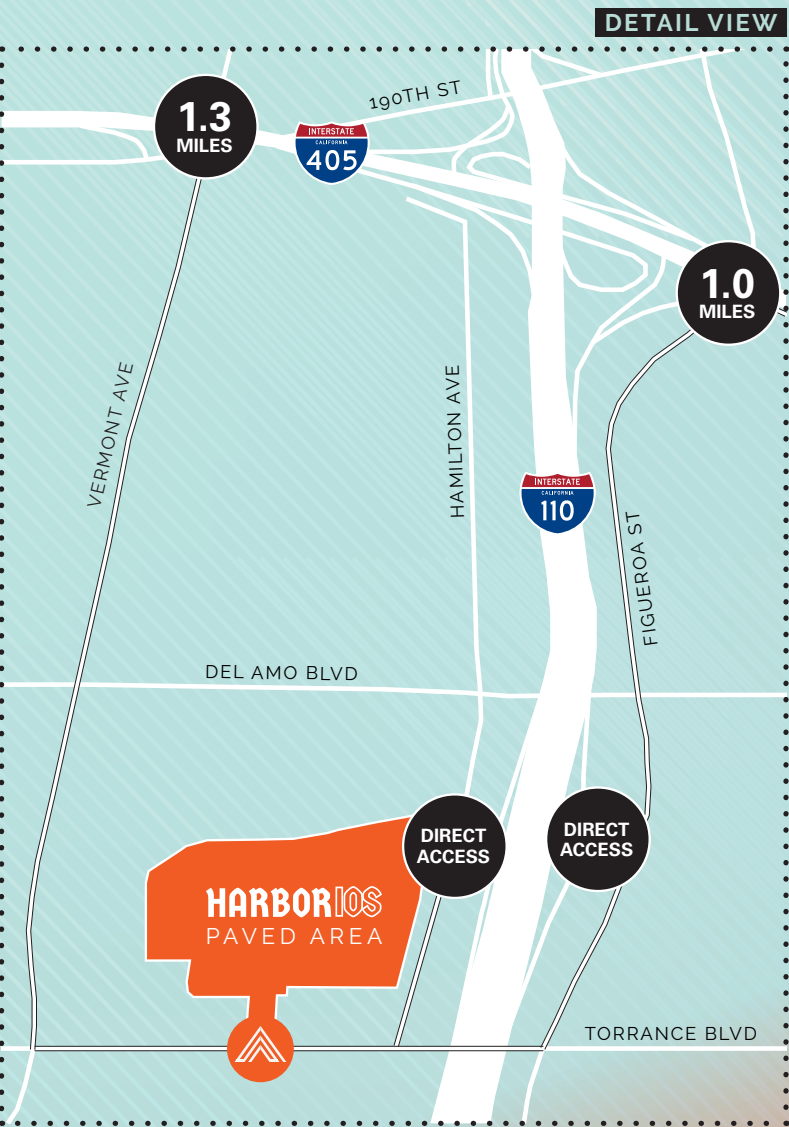
SITE PLAN

LOCATION MAP

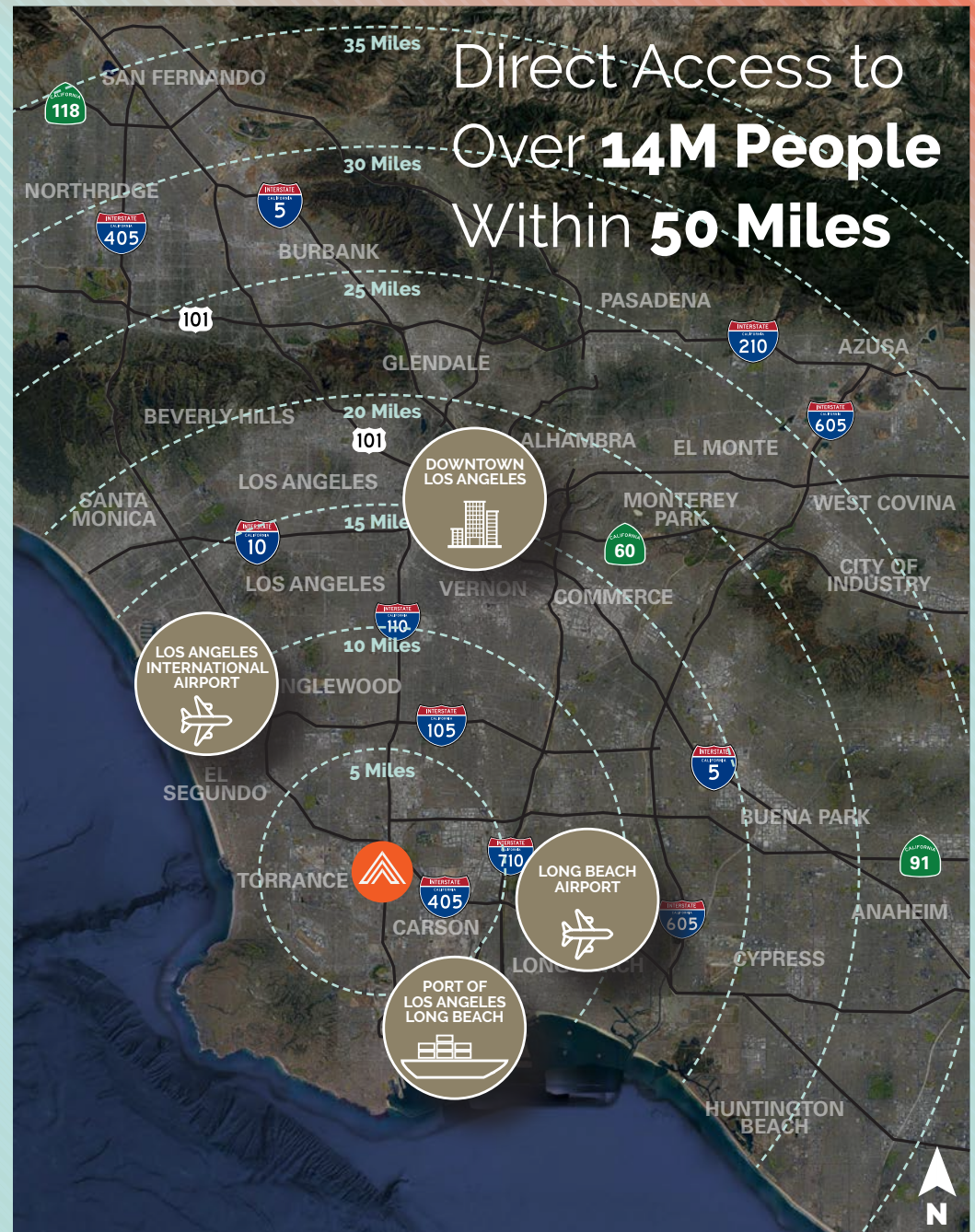
Local Access to Harbor IOS
