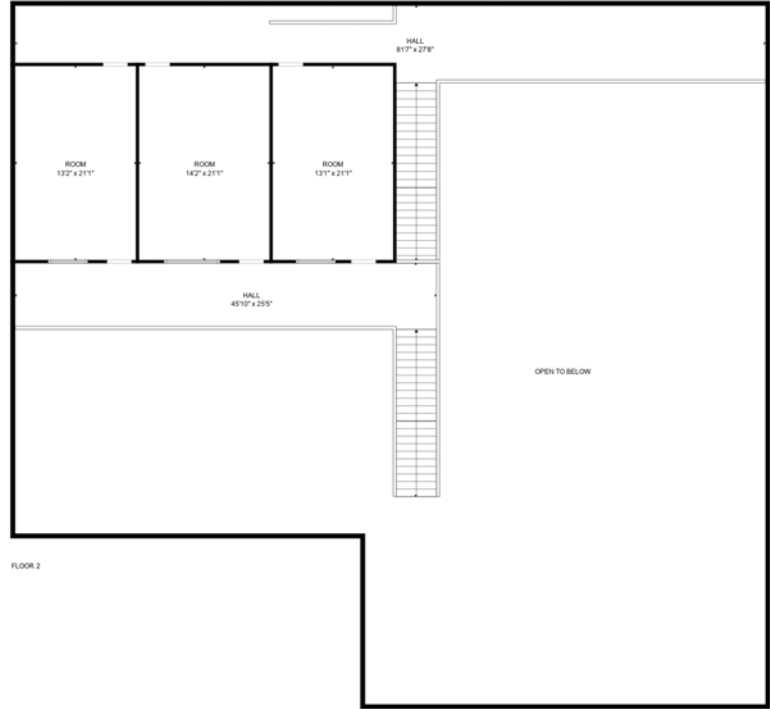


FLOOR PLAN

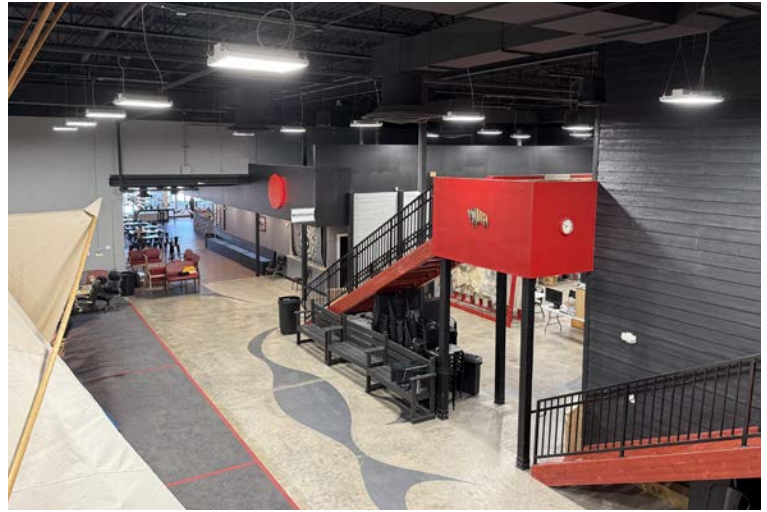
Main Level
