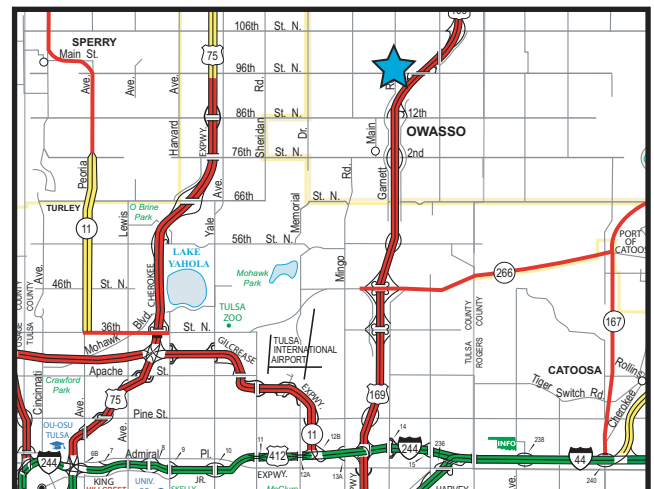

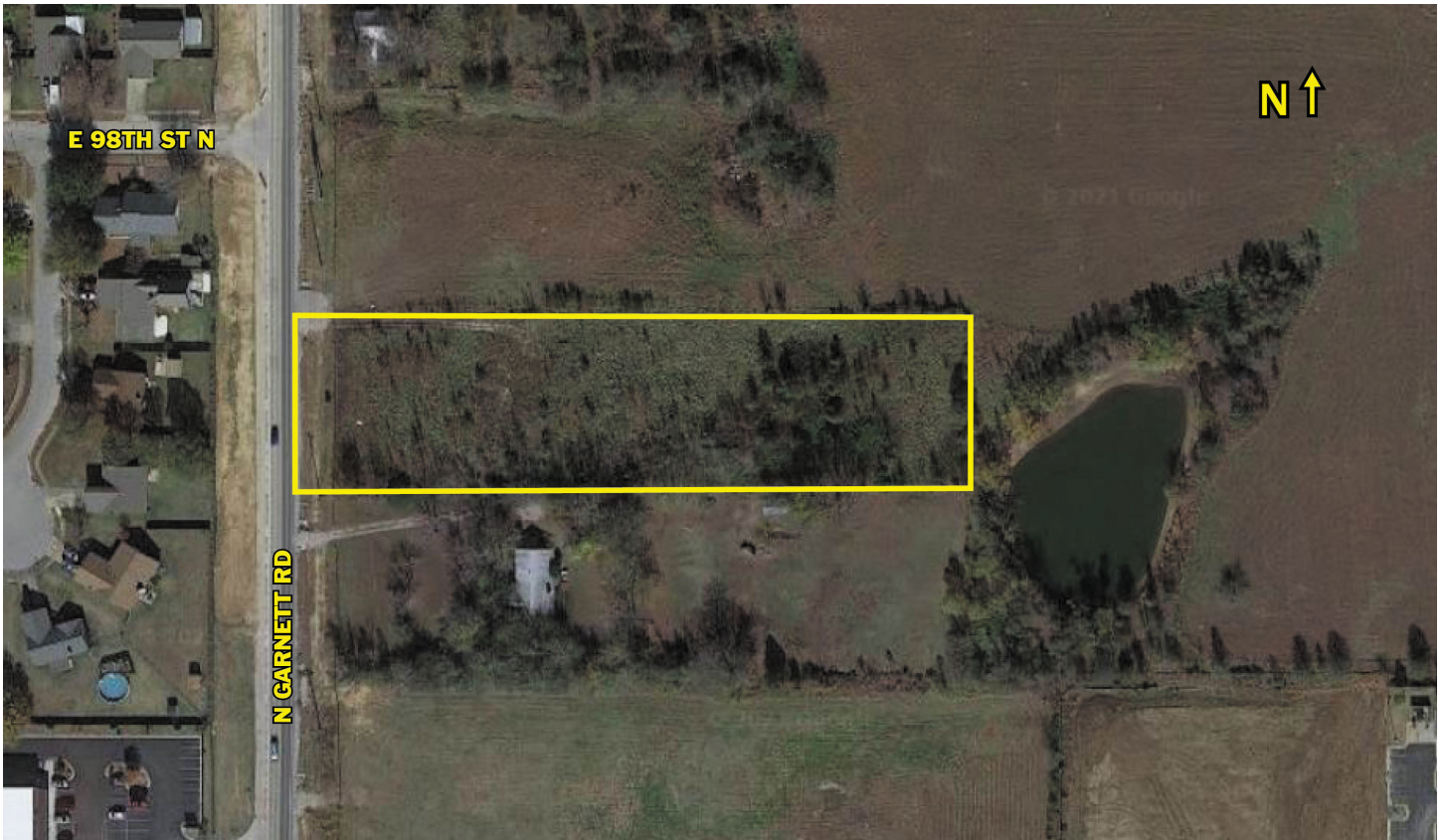

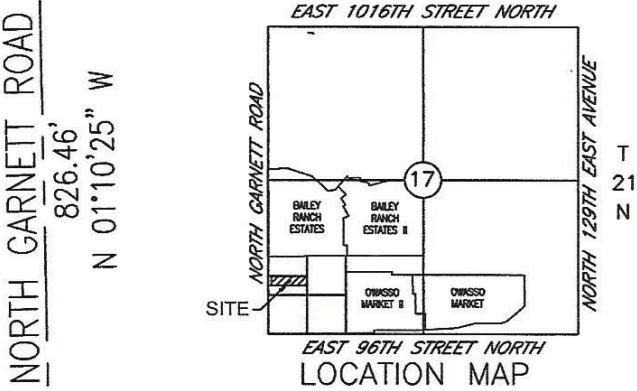
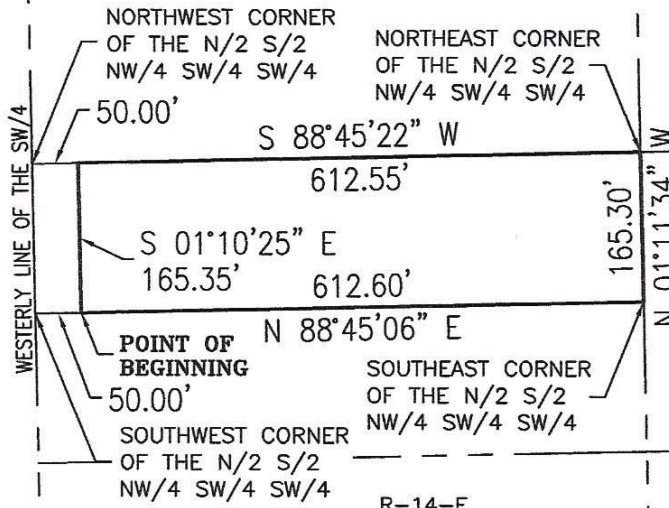
LEGAL DESCRIPTION:

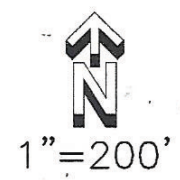
