





Legal Description

A part of Lots 3 and 4, Block 10, Ortega Farms, as recorded in Plat Book 3, page 79 of the current public records of Duval County, Florida and being more particularly described as follows:

Begin at the southern corner of Tract A, Cedar Hills Unit 1, as recorded in Plat Book 19, pages 20 and 20A of said current public records; thence south 22 degree 54 minutes 50 second west along the Westerly right of way line of Blanding Boulevard (an 80 foot right of way as now established), 92.13 feet to the northeast corner of Lot 17, Cedar Hills Unit 1; thence north 71 degree 48 minutes 10 second west along the northeasterly line of Lots 15, 16, & 17, Cedar Hills Unit 1, 219.06 feet to the southeast corner of Lot 13, Cedar Hills unit 1; thence north 15 degrees 58 minutes 20 seconds east along the easterly line of said Lot 13, 91.45 feet to the northeast corner of said Lot 13; thence south 71 degrees 54 minutes 40 seconds east along the southerly line of Tract A, 230.35 feet to the point of beginning.
