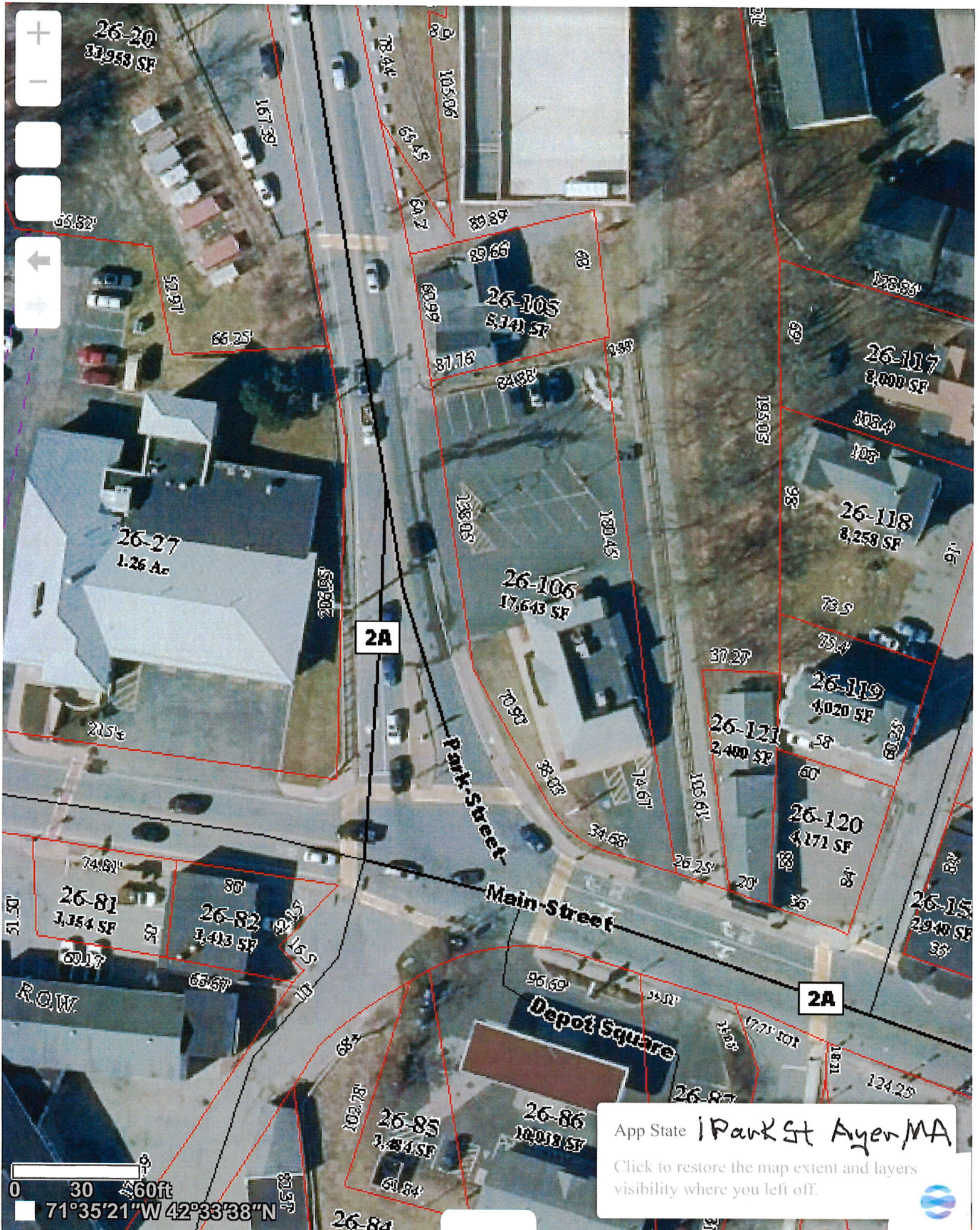

A prior restaurant conversion application had already been filed with the Town and later withdrawn without prejudice, offering insight into the site's viable alternative uses.

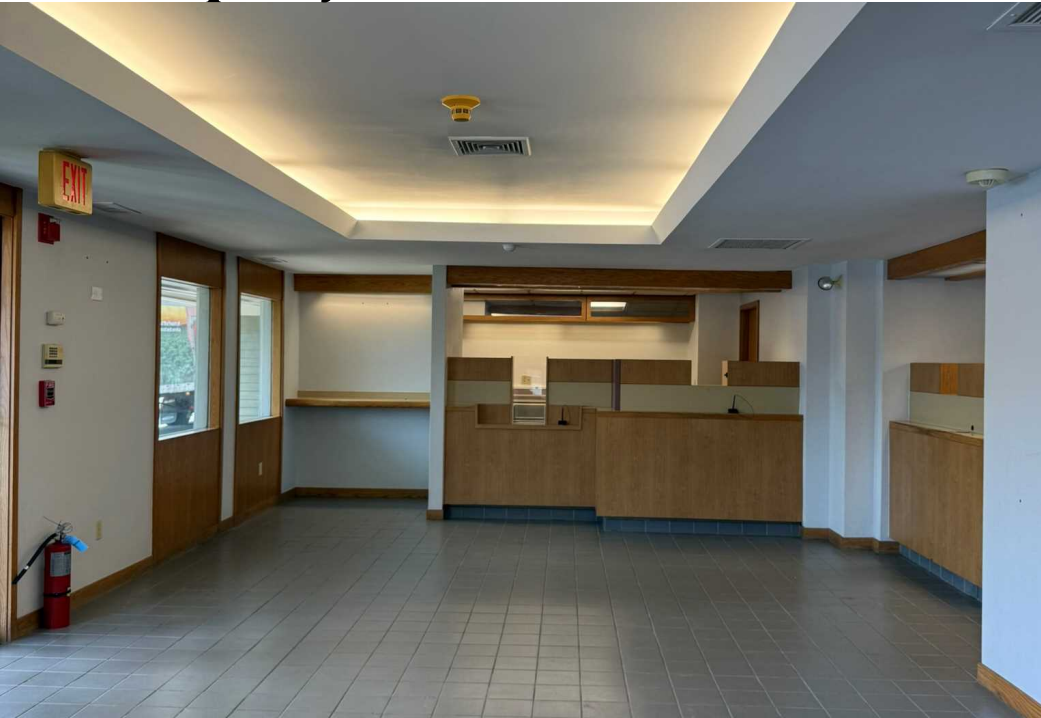

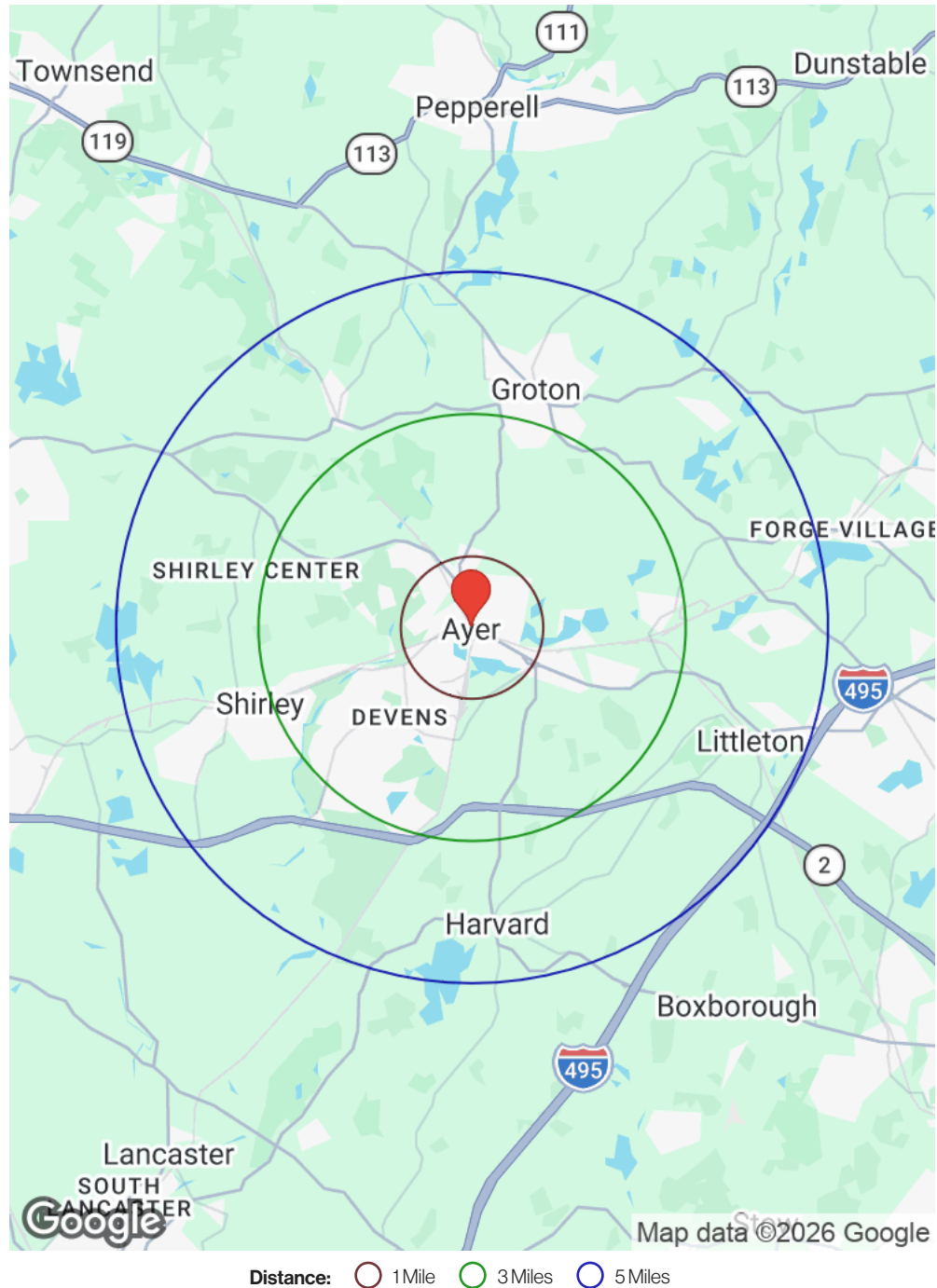
