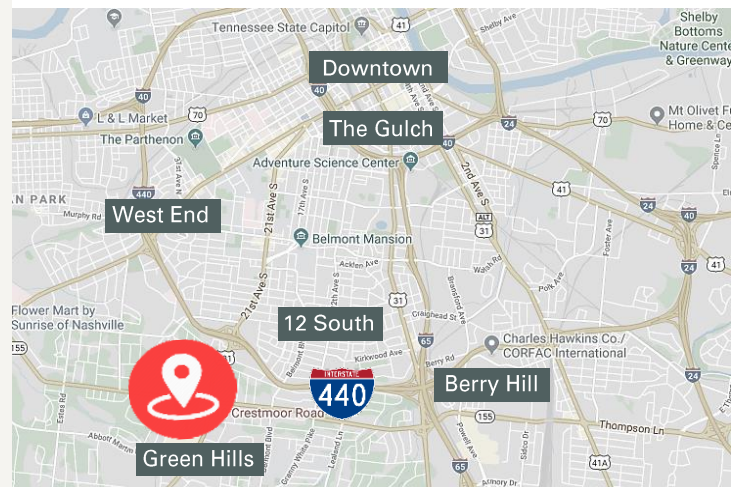
New Connecting Road for Busy Green Hills Intersection

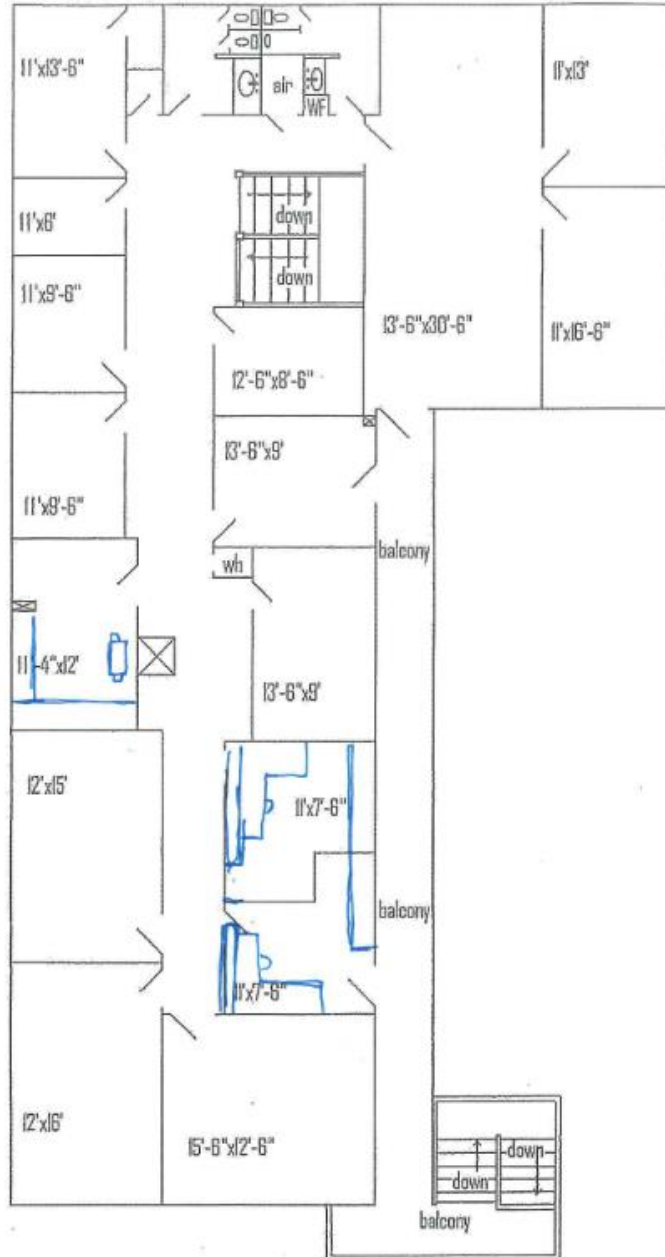

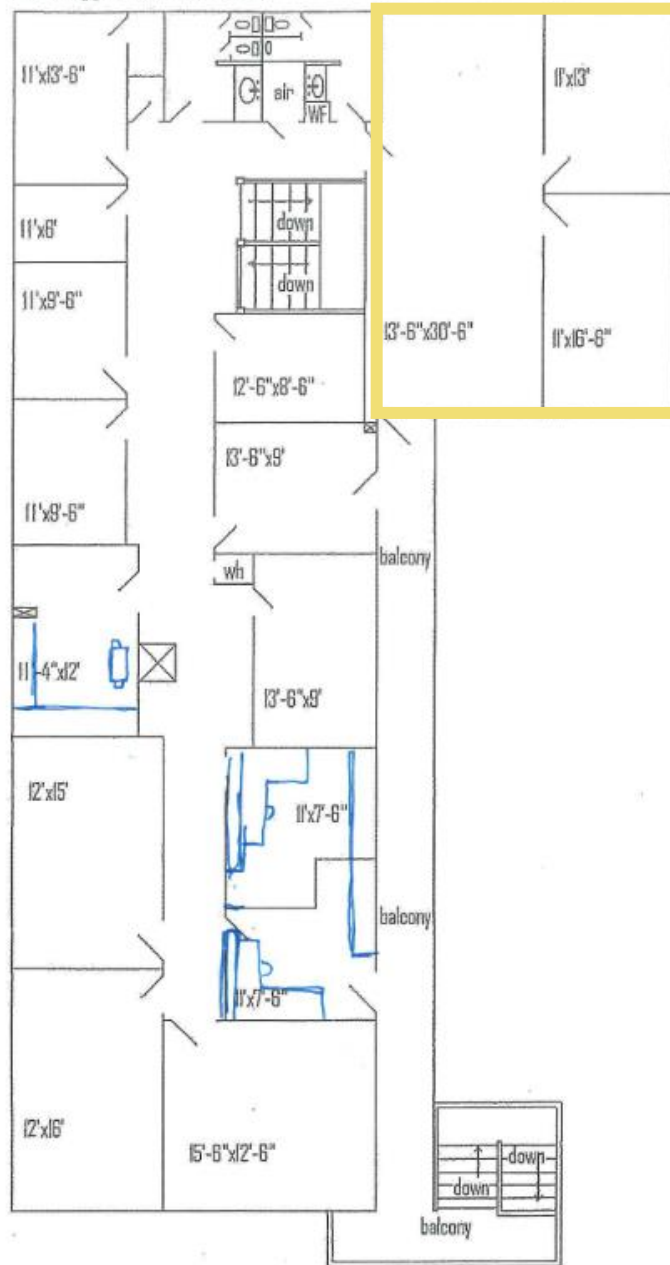
