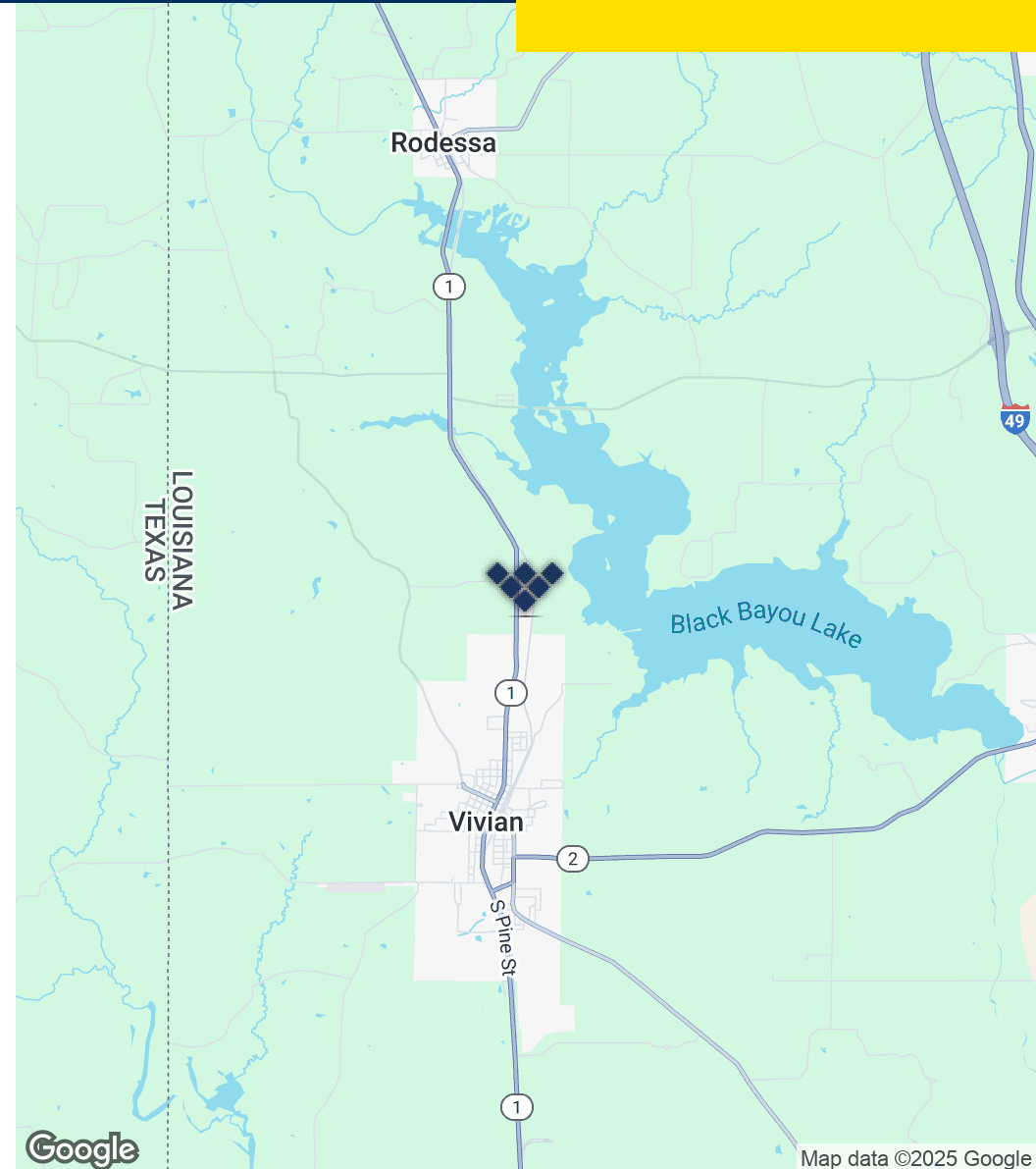
36,850 SF industrial facility situated on 11.5 acres in Vivian, located within the Caddo Parish industrial cluster near LA-1.
