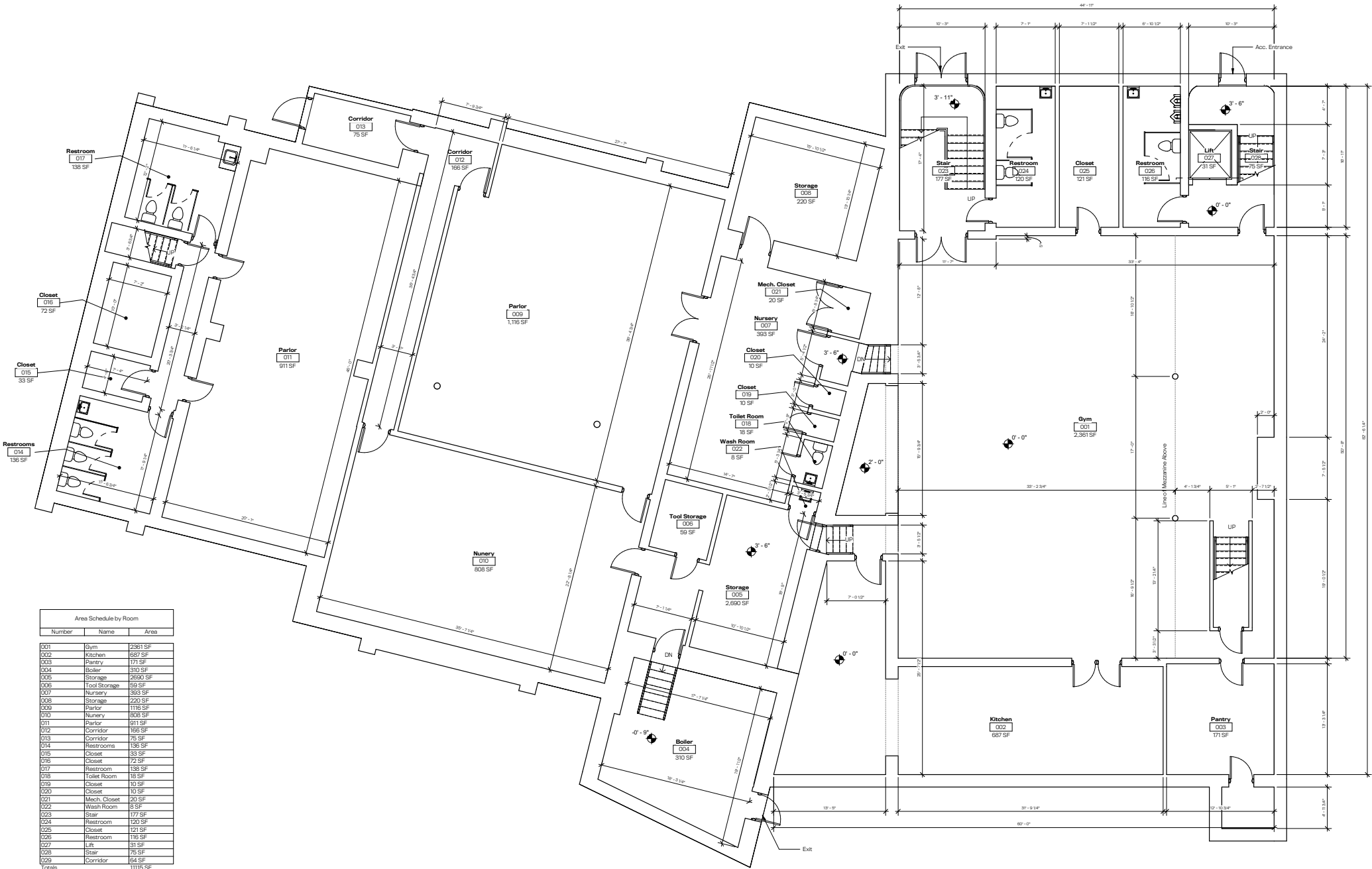

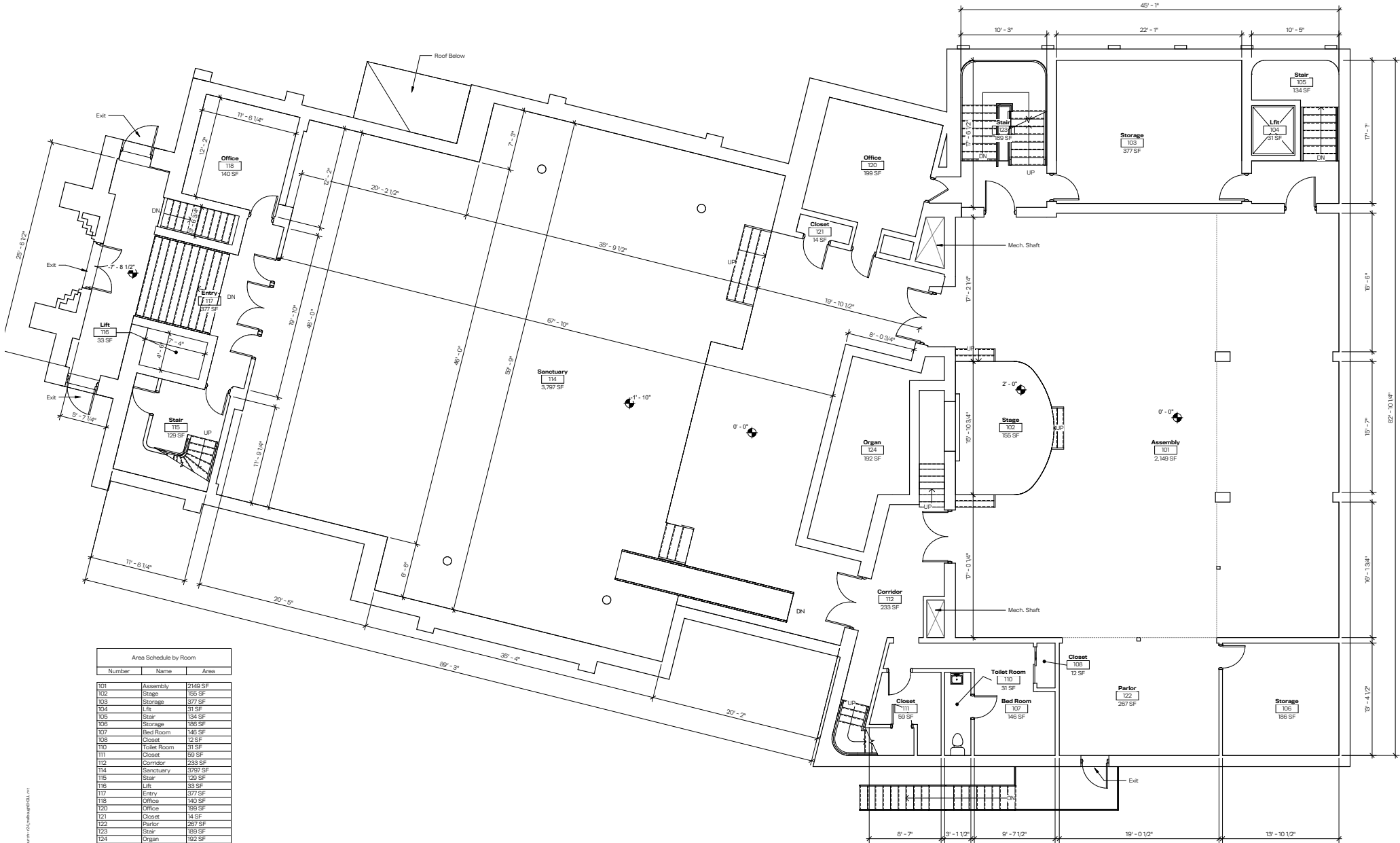

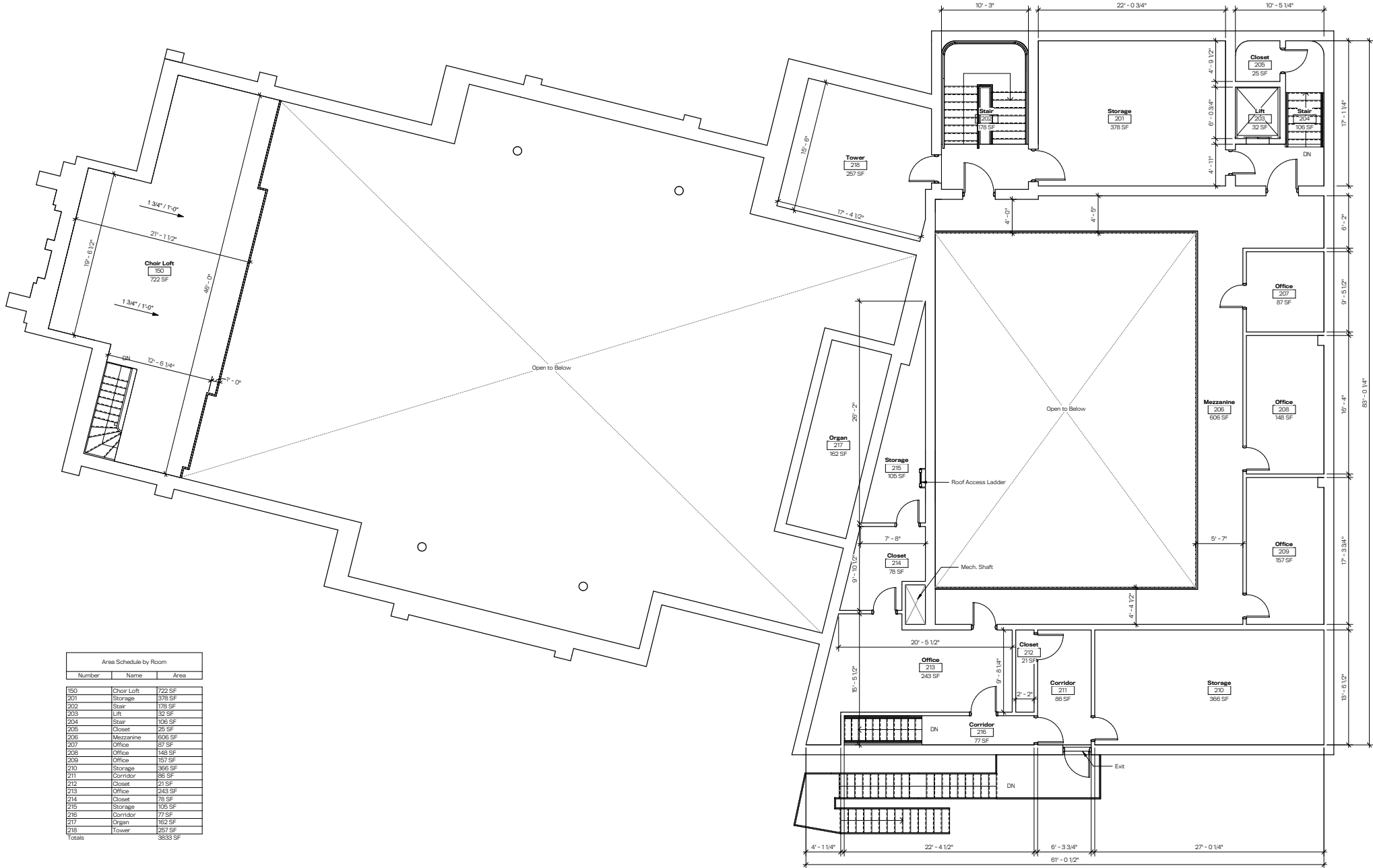

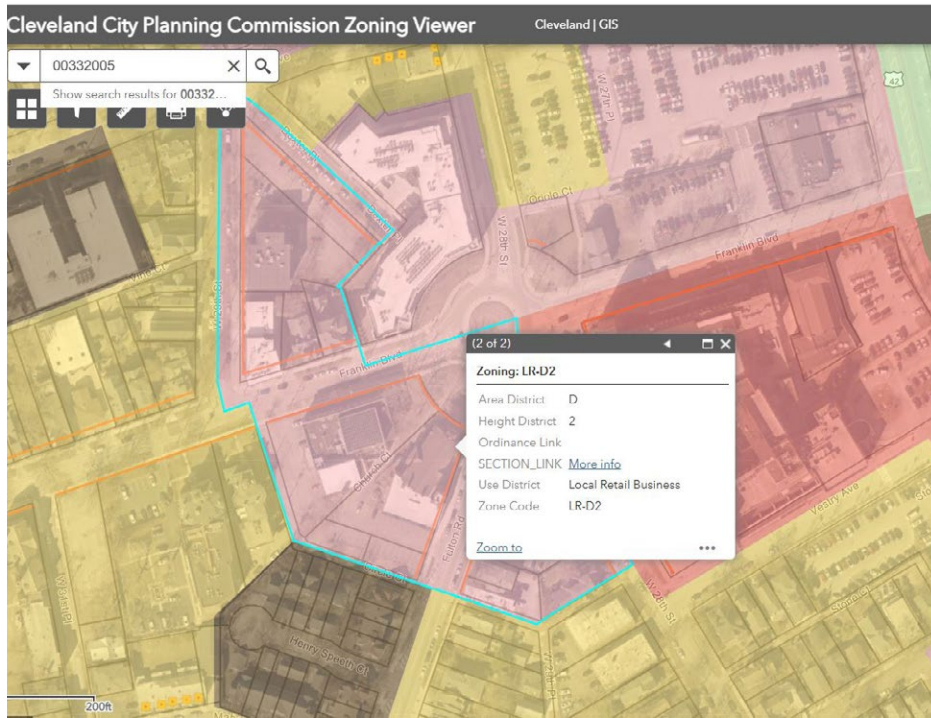

# History

Franklin Circle Christian Church is a landmark in Ohio City, Cleveland, located at the intersection of Franklin Boulevard and Fulton Road. Established by the Disciples of Christ in 1842, it holds a unique place in history: and former President James A. Garfield served as a pastor here in 1857. The current building, an architectural landmark, was designed by the Cleveland firm Cudell and Richardson and constructed between 1874 and 1875. Its rich heritage and architectural significance make it a notable site within Cleveland's historical landscape.
