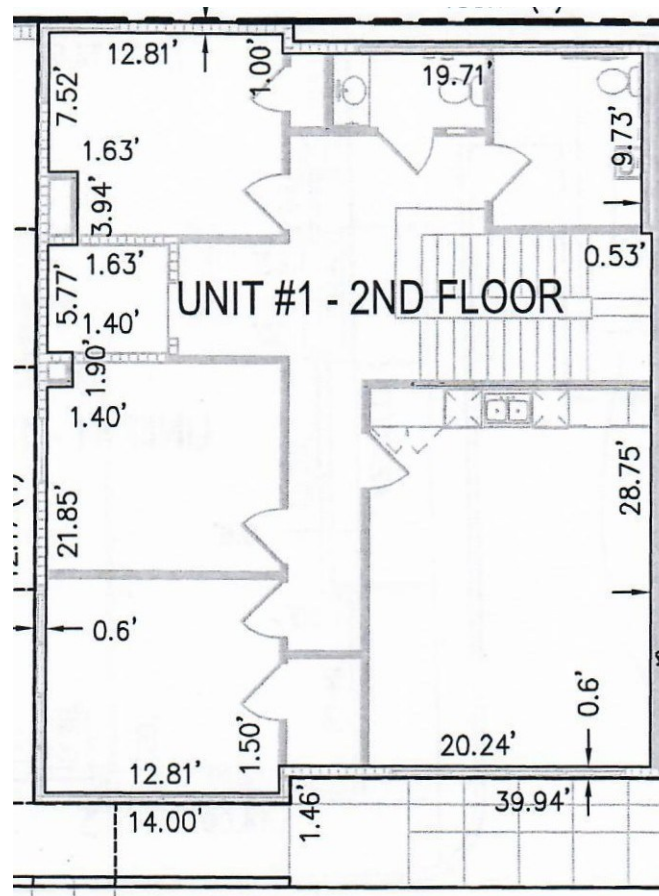

FLOOR PLAN INTERIOR UNIT

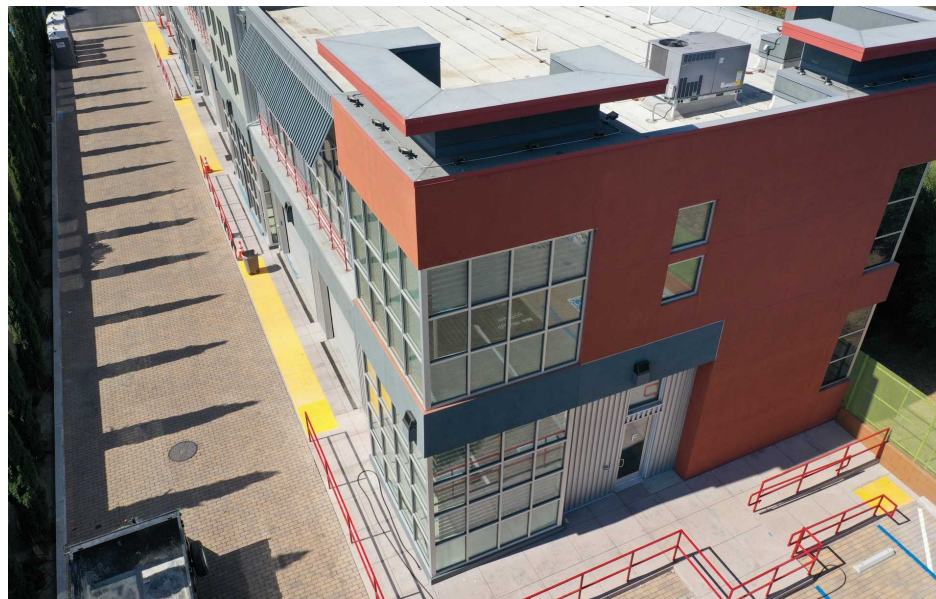

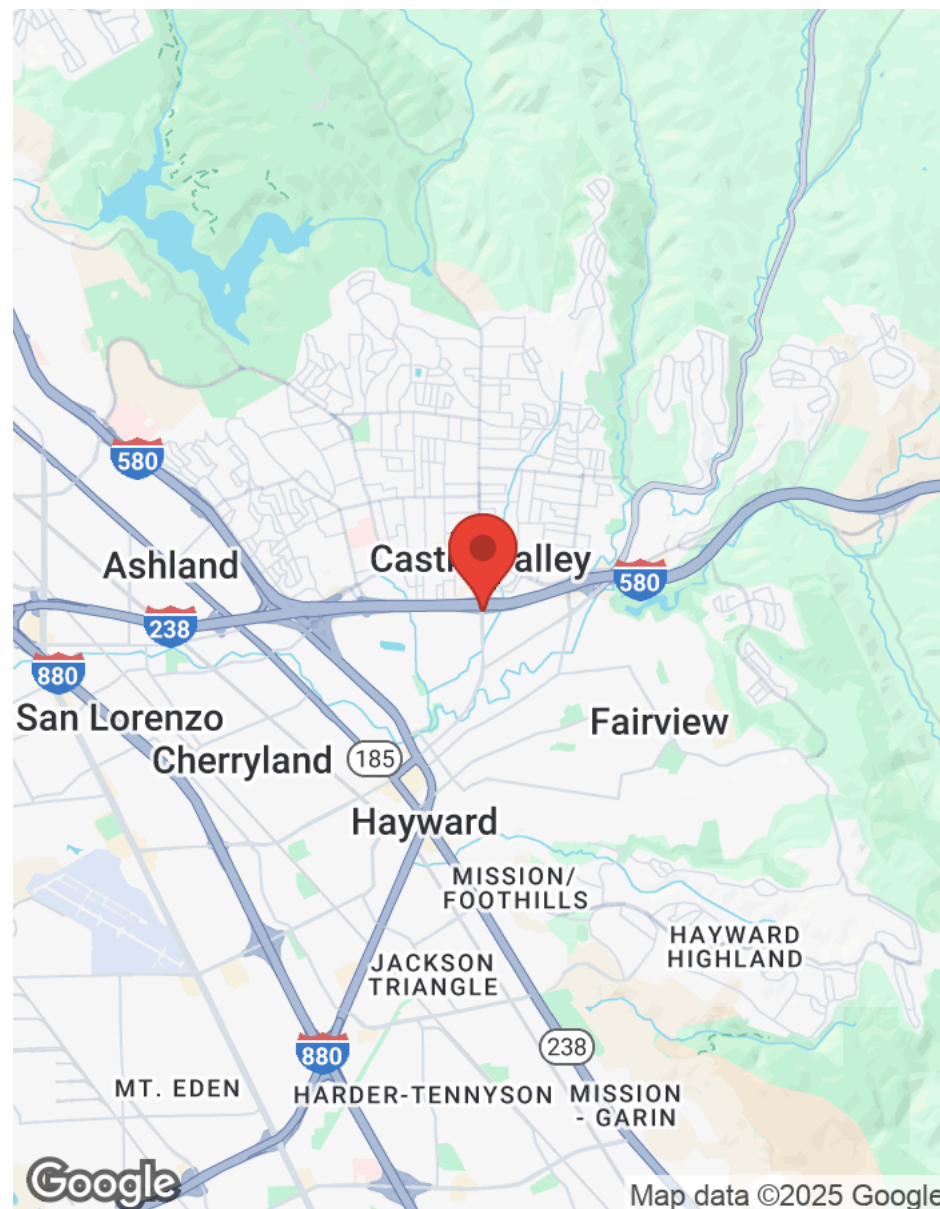

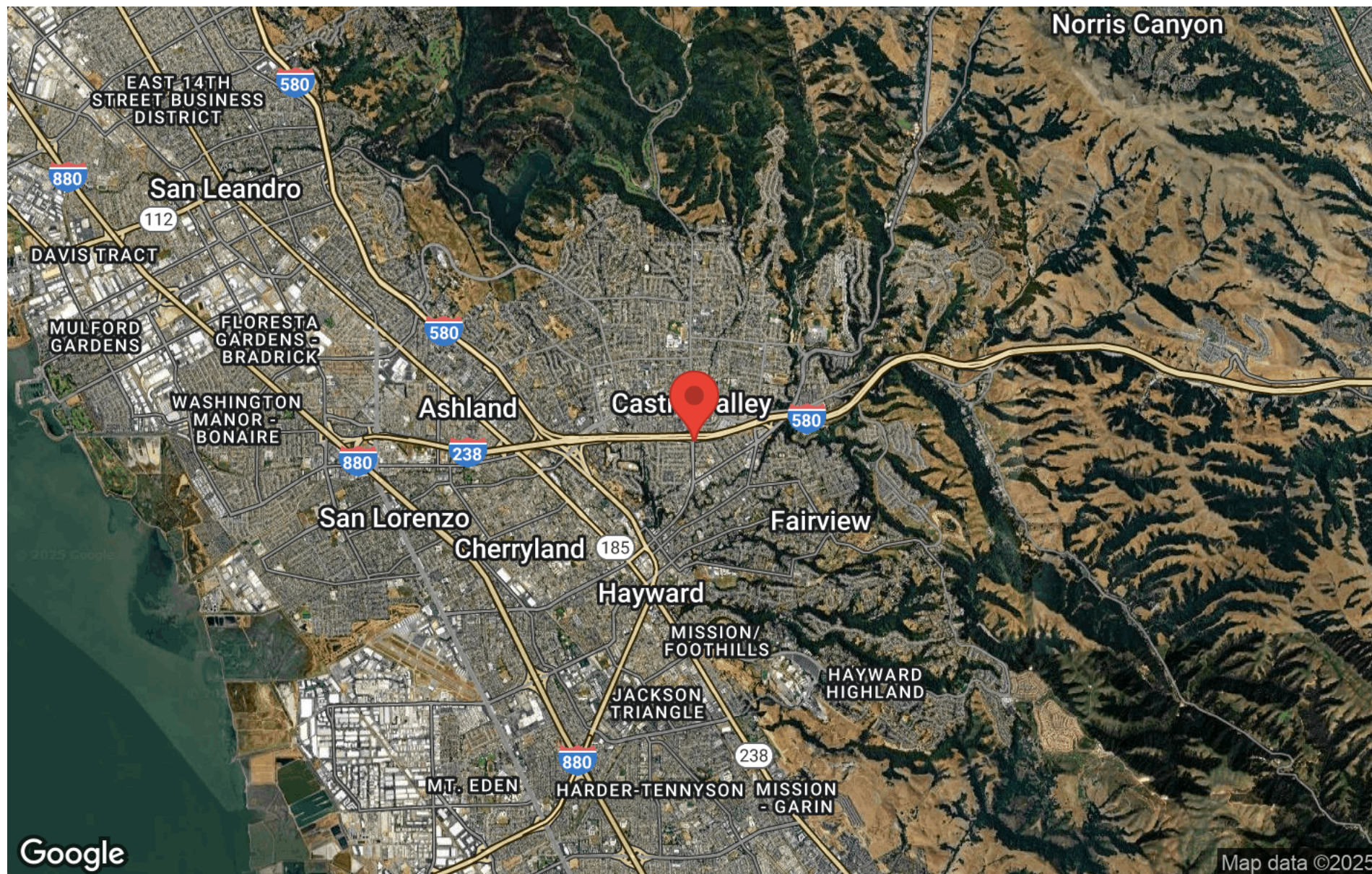
