



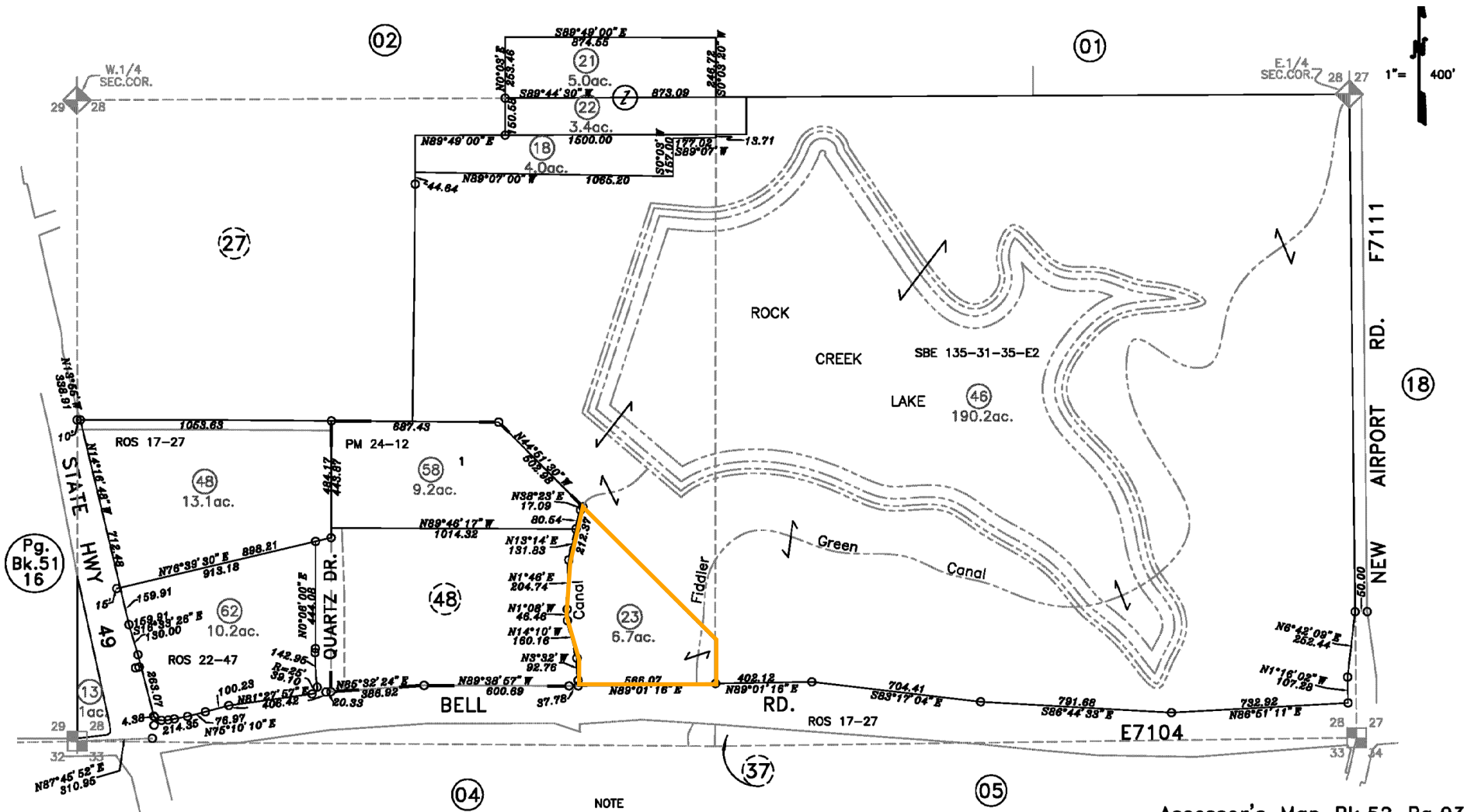
PROPERTY HIGHLIGHTS
