# AREA OVERVIEW

## AMMON, IDAHO

Population: 19,000 (2022 Census est.)

Elevation: 4,713 feet

Ammon, the city “**Where Tomorrow Begins**”, is a suburb city located directly between the Ammon foothills on the east and the city of Idaho Falls on the west, in Bonneville County, Idaho, United States. As of the 2022 US Census, the population of Ammon was 13,816. By the 2020 census, Ammon’s population had grown to 19,000.

Ammon was one of **Idaho’s fastest growing cities** from 2000 to 2010. The city experienced a 123.3% growth rate from 2000 to 2010 based on the 2010 US Census. Ammon is the 15th largest city in Idaho. The city’s **rapid growth** is due to its availability of open space for affordable residential housing and the city’s hometown lifestyle, as well as its near proximity to the urban amenities and job market in Idaho Falls.

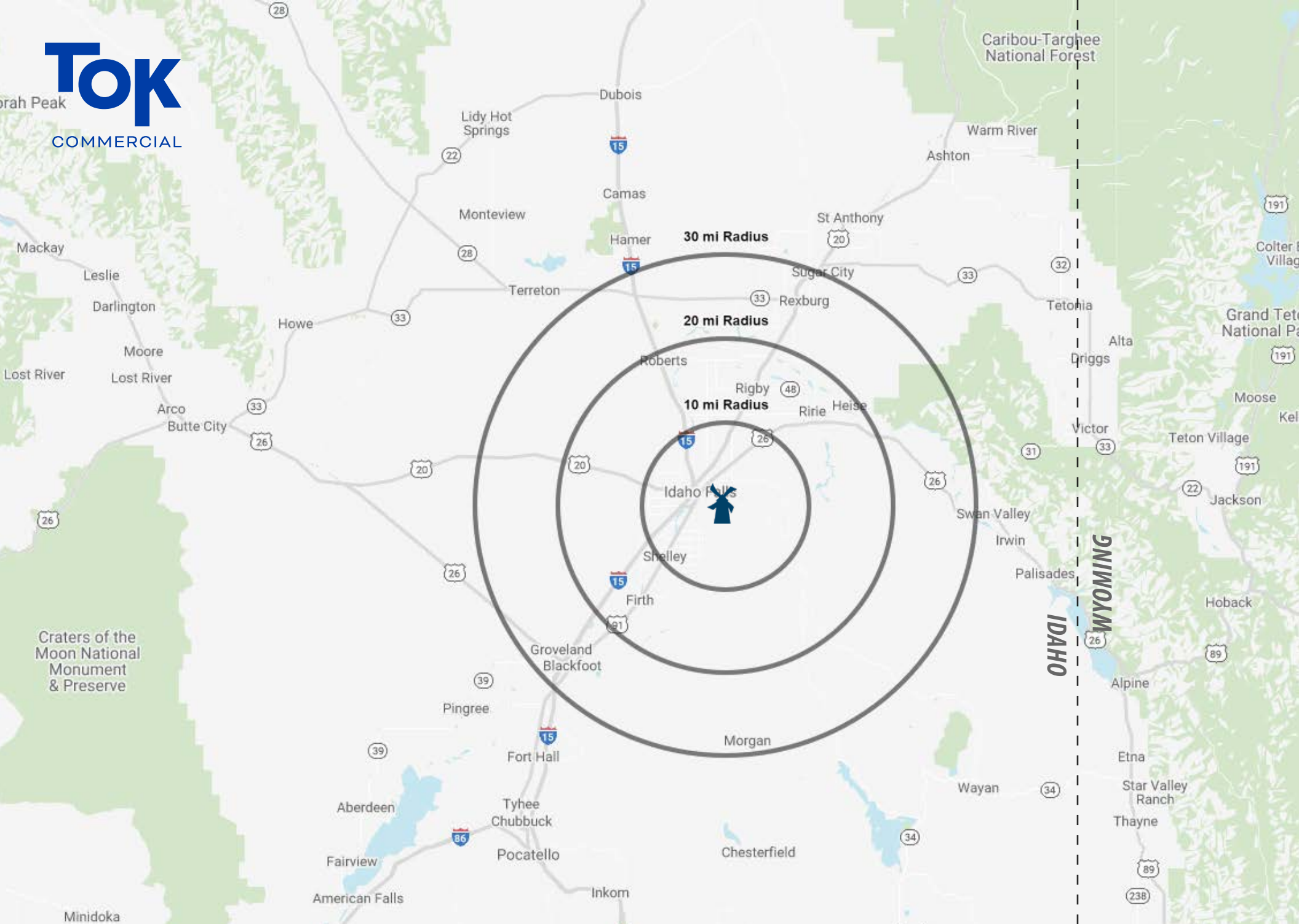
Ammon is located in the Upper Snake River Valley. Its western boundary touches the City of Idaho Falls. Foothills and mountains outline Ammon’s eastern and southern skies. The **Caribou National Forest** with its Blackfoot Mountain range begins ten miles to the south and its rugged Caribou Mountain Range lies 20 miles to the east.

The city has nine parks totaling over 62 acres. The 18-acre McCowin Park is the city’s largest park. It has a swimming pool, splash pad, picnic shelter, playground equipment, tennis courts, horseshoe pits, walking path, and ball fields. The amenities of the other parks include shelters, playground equipment, Tot Park, facilities for athletics, and picnic areas.

Within an **hour’s drive from the city**, opportunities abound for boating, rafting, canoeing, hunting, fishing, camping, snow and water skiing, snowmobiling, and ice fishing.

The company was founded on February 12, 1992 by Dane and Travis Boersma, brothers of Dutch descent, in Grants Pass, Oregon. The two brothers were working on their family's dairy farm when they had the idea to start selling coffee. They originally sold coffee from pushcarts around town and, by 2018, had more than 300 coffee stands in seven Western states with the majority being drive-thrus and a few walk-ins. The company began an expansion into the Southern United States starting in 2020 with locations opening in Oklahoma and Texas.

The coffee chain serves a variety of coffees, caffeinated beverages, and other drinks including hot tea, iced tea, energy drinks, smoothies, hot cocoa, soda, and lemonade including a "not-so-secret menu".

The company's mantra is to "make a difference, one cup at a time". Every year the company holds its annual Drink one for Dane fundraiser for the Muscular Dystrophy Association in honor of the co-founder Dane Boersma, who died of Lou Gehrig's disease in 2009 at the age of 55.

Dutch Bros. held its IPO and began trading on the New York Stock Exchange with the ticker symbol "BROS" on September

15, 2021
