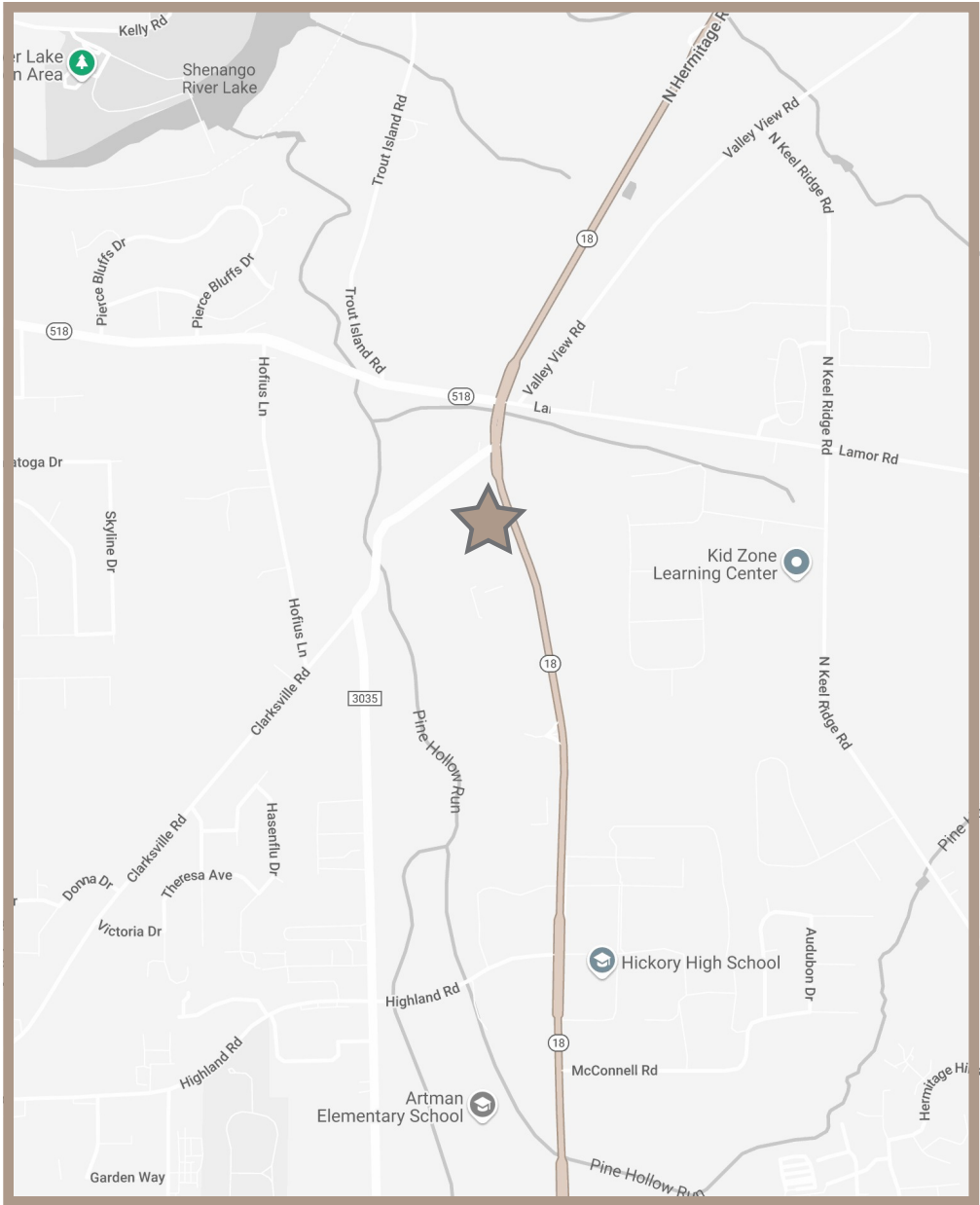
## LOCATION OVERVIEW

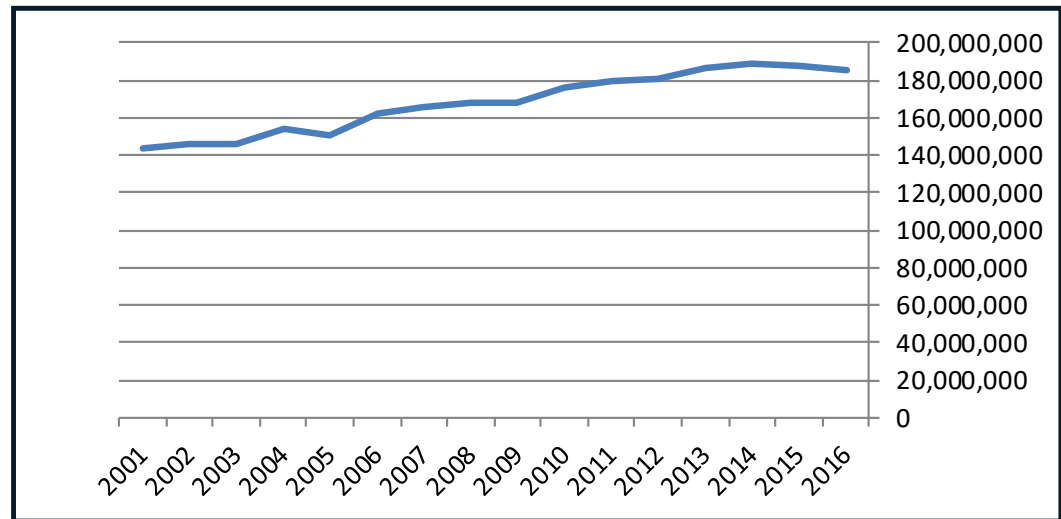
