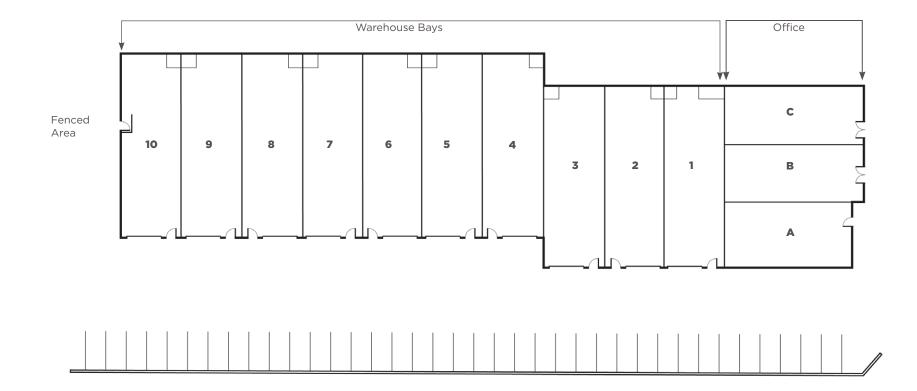

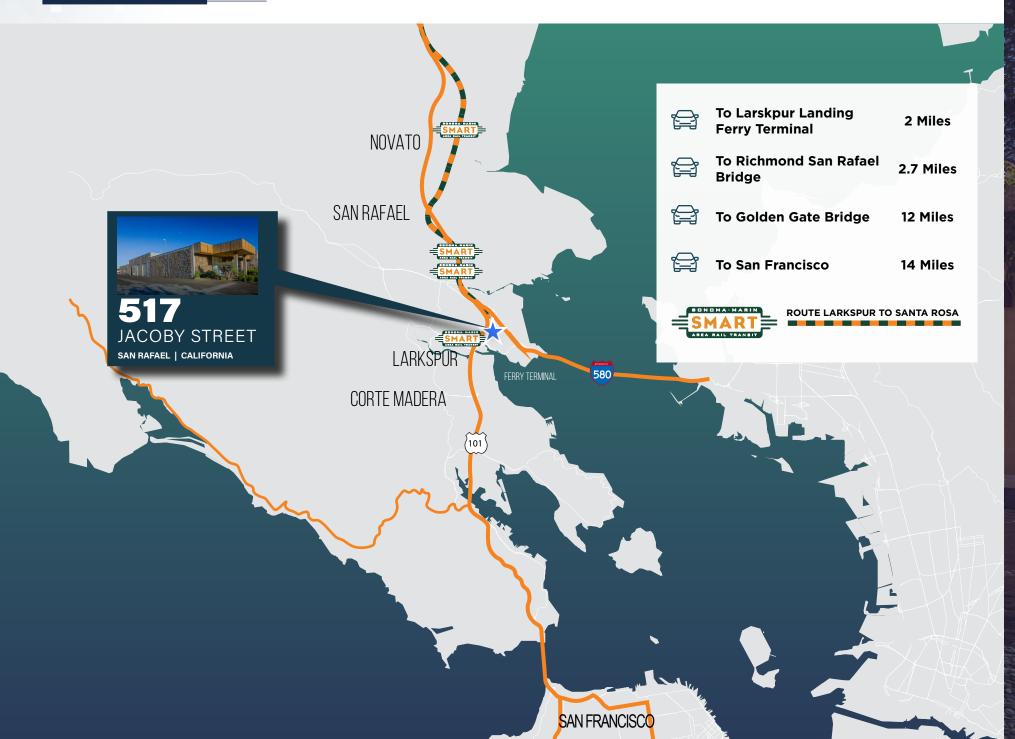




Amenities **Map**
