PROPERTY REMARKS

AMENDMENT TO THE LEASE BETWEEN GRAY MEDIA GROUP, INC., dba KPHO/KTVK AND STUART L. MELTON AND DARLENE K. MELTON

This amendment ("Amendment") is effective as of October 17, 2022, as entered by and between Gray Media Group, Inc., dba KPHO/KTVK ("Tenant"), and Stuart L. Melton and Darlene K. Melton ("Landlord").

The parties entered a Lease dated November 19, 1996 (the "Lease").

The parties hereby amend the Agreement as follows:

- The term of the Lease shall extend to November 19, 2027.
- 2. Effective November 20, 2022, the parties agree the base rent will be \$13,000 per year, plus a rental tax of \$377, for a total of \$13,377 per year.
- 3. Capitalized terms used in this Amendment shall have the same meaning given to them in the Lease, unless otherwise defined in this Amendment. All other terms and conditions provided in the Lease, which do not conflict with this Amendment, shall remain in full force and effect. Copies of the signed Amendment may be enforced as originals. Signatures transmitted by fax, e-mail or other comparable electronic means will be deemed, and will have the same legal force and effect as, an original.


