EXECUTIVE SUMMARY

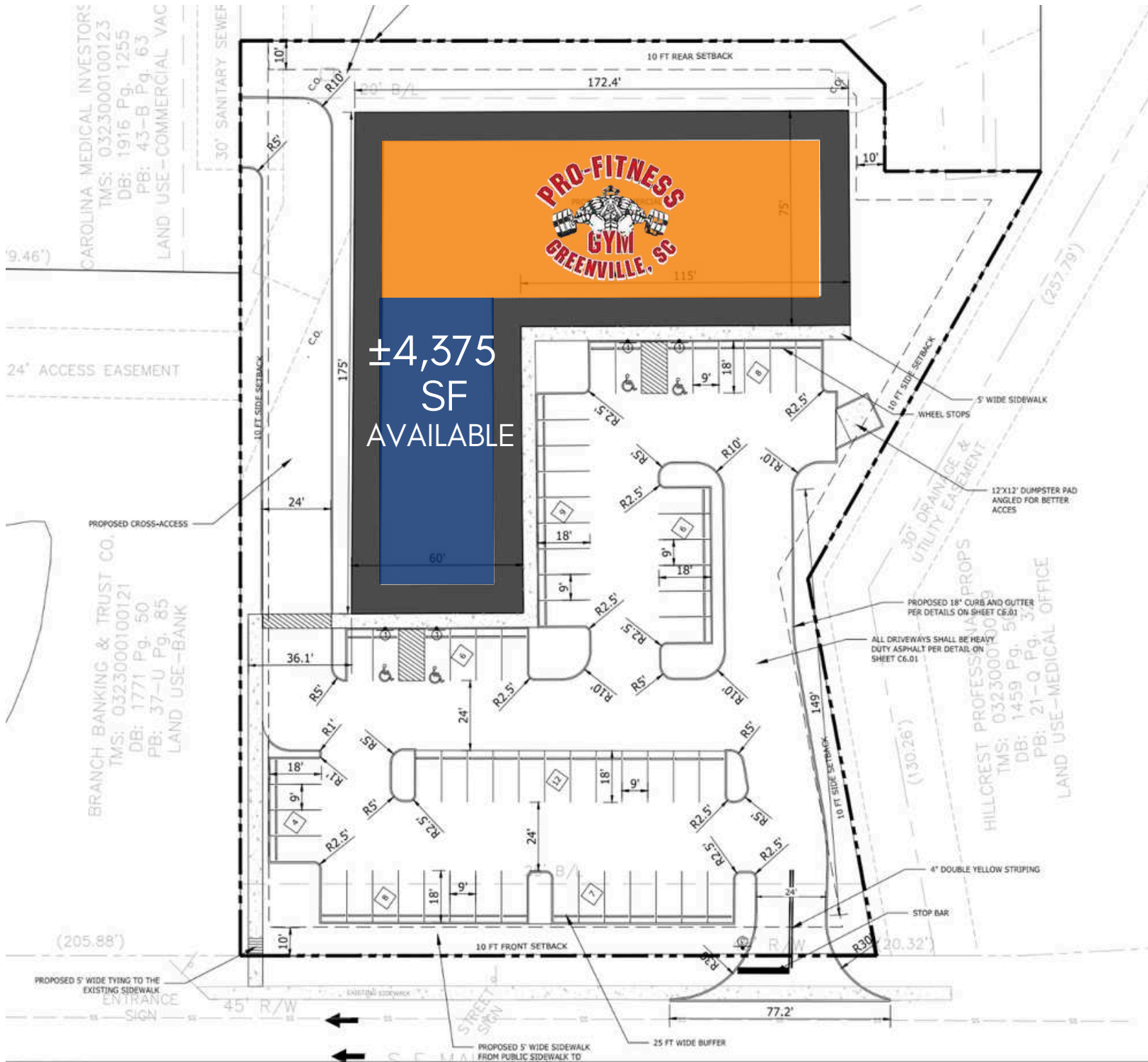

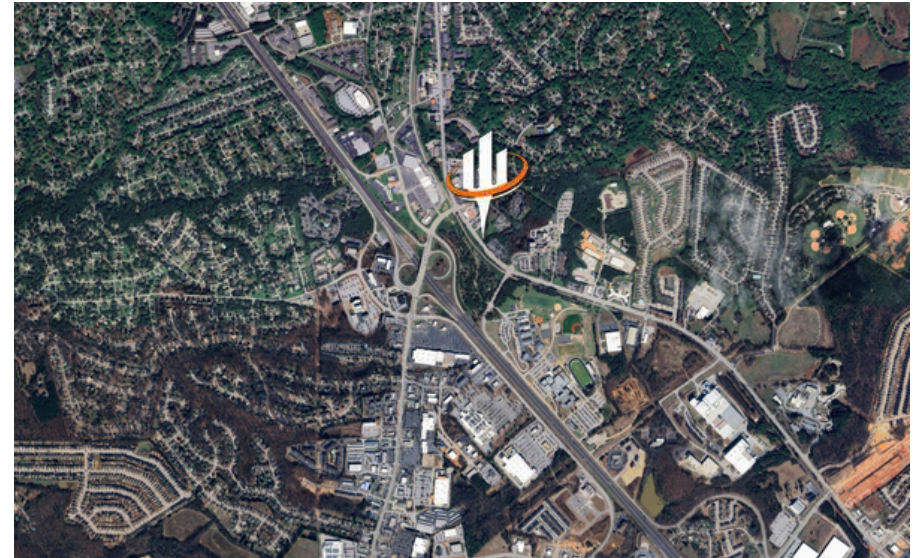
