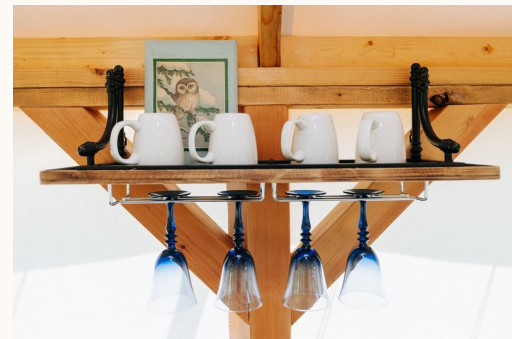
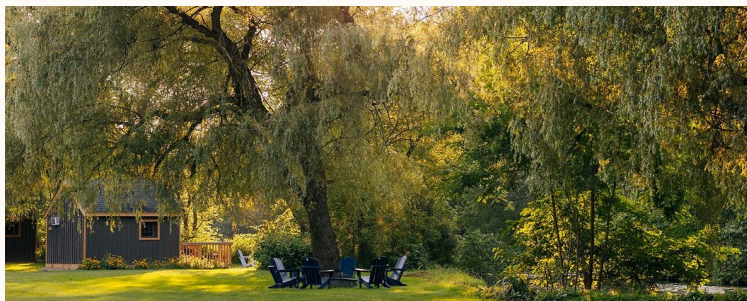
Resort Deluxe Tent Cabins

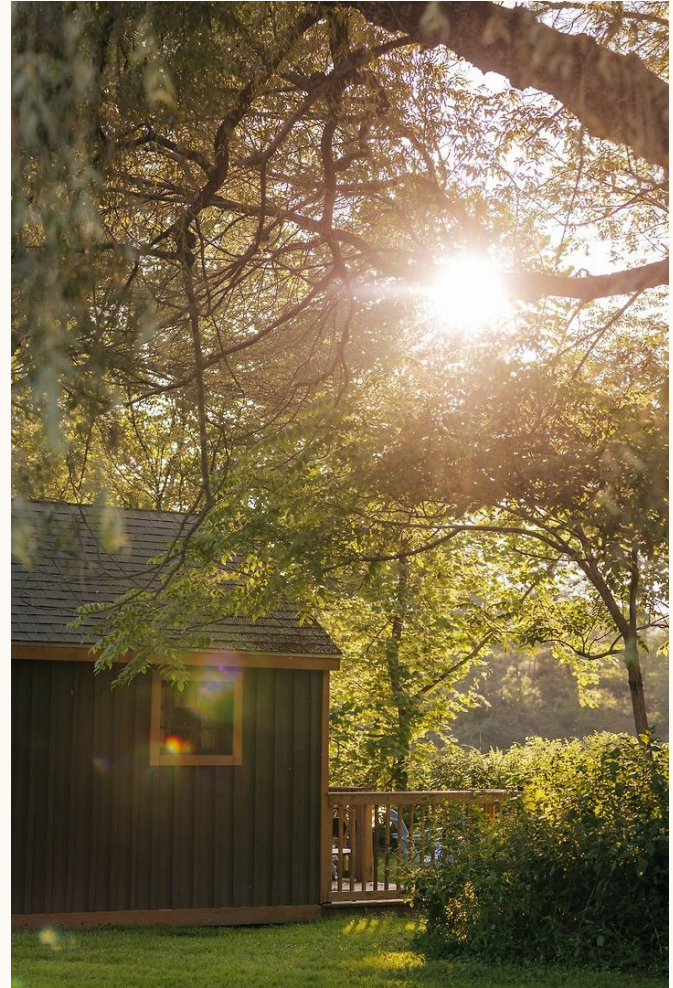

Riverfront Glamping Cabins

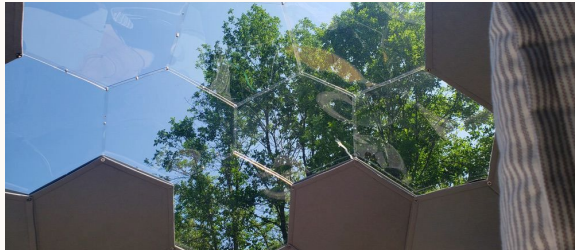
The rustic river front cabins are fully furnished and have all you need to enjoy riverfront living. These cabins are steps from the river's edge and offer our most private accommodations.

The Outpost: Resort Store

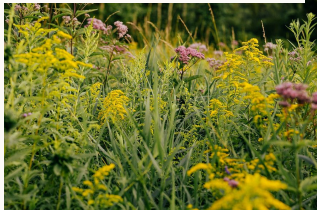

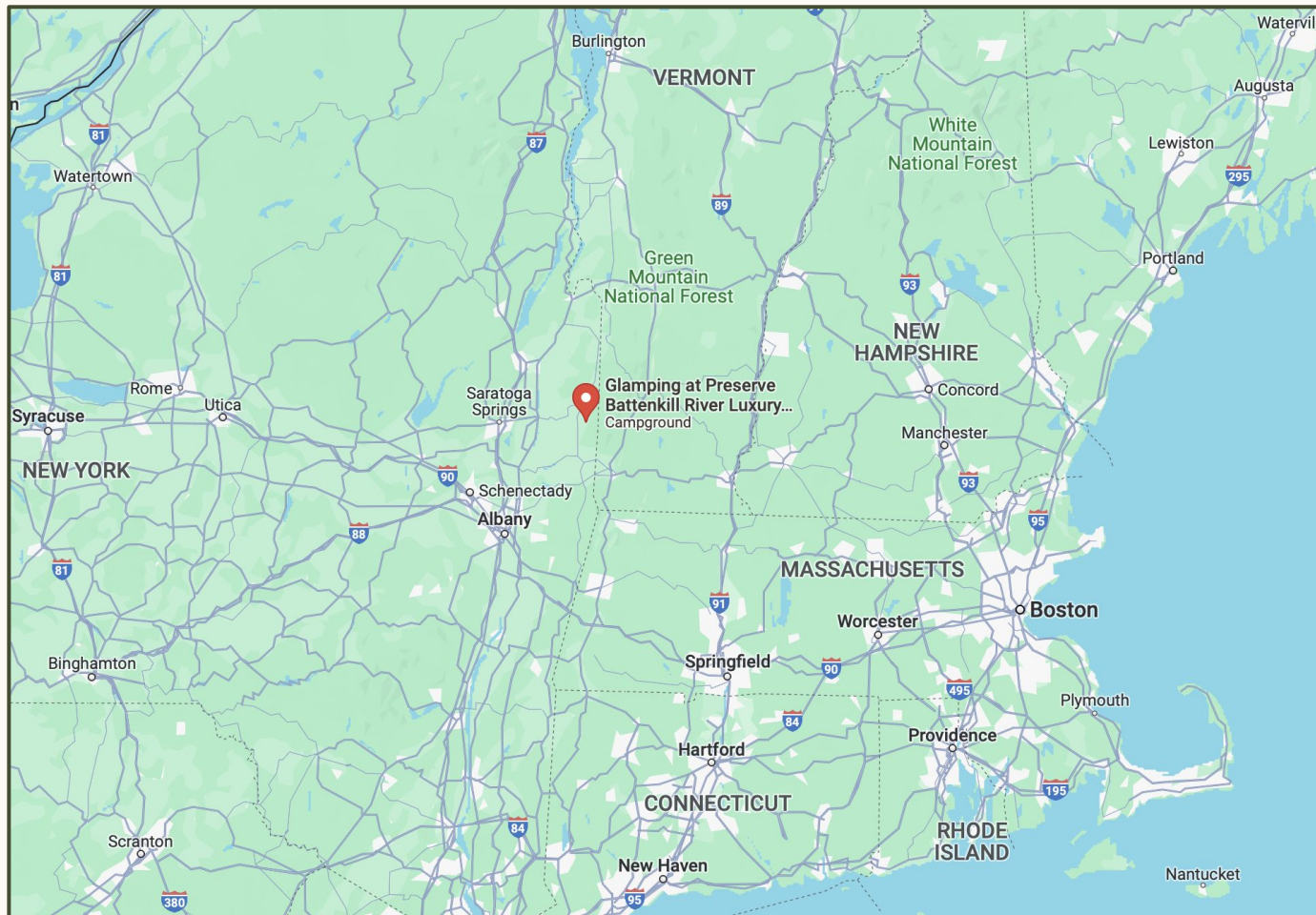


GLAMPING RESORT
